## Transaction Summary

We are providing the rating of Atlas Senior Loan Fund III as a Non-NRSRO rating. The transaction closed on July 09, 2013. It had a reinvestment period, which ended on November 17, 2019. It has a maturity date of November 17, 2027. The Dealer and Trustee are Goldman, Sachs and Wells Fargo Bank, respectively. The issued notes are collateralized by 100.0 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -99.0 second lien loans and senior unsecured loans. Crescent Capital Group serves as the collateral manager.

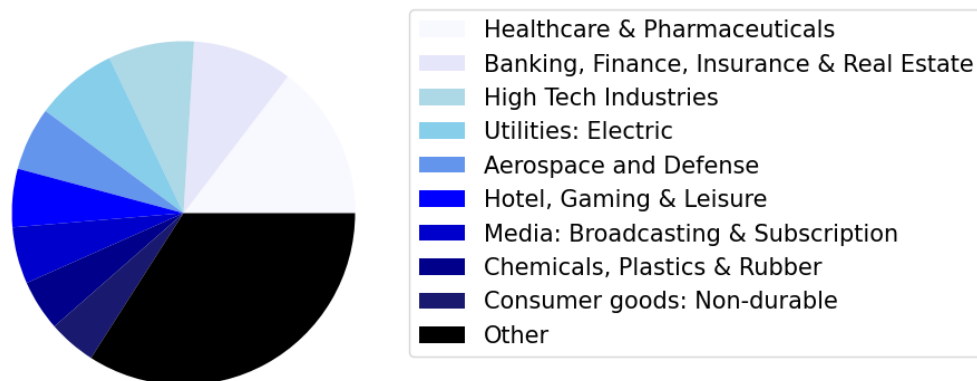
As of April 29, 2023, the total balance of the underlying assets was approximately \$172.1M. The diversity score of the portfolio was 37. Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 3846.6 and 2.4, respectively. Approximately 17.1% of the portfolio's assets were rated CCC+ or less by other agencies. Senior tranche subordination was 64.26%.

### Top 10 Industry Contribution

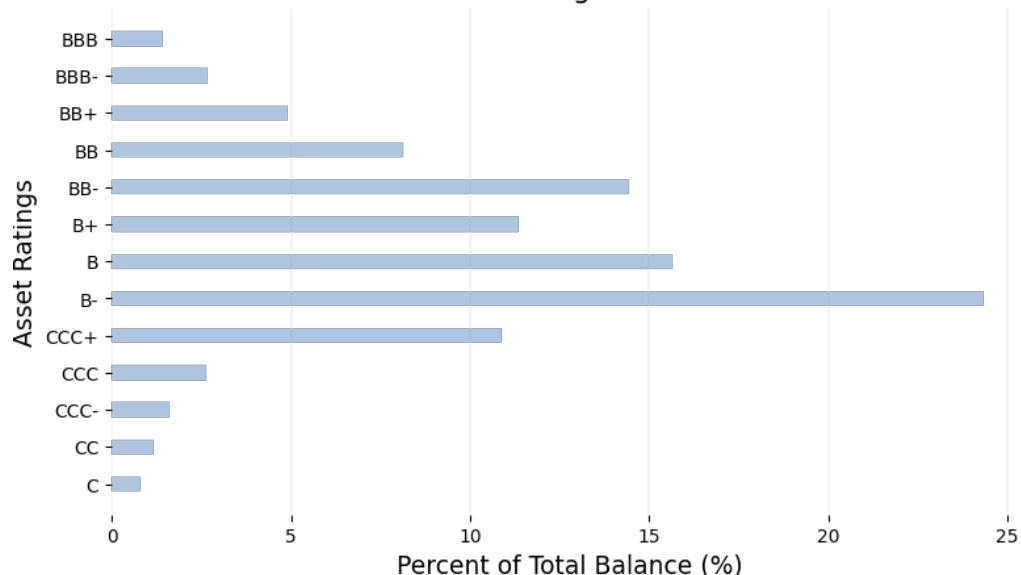

Portfolio Gross Coupon Distribution

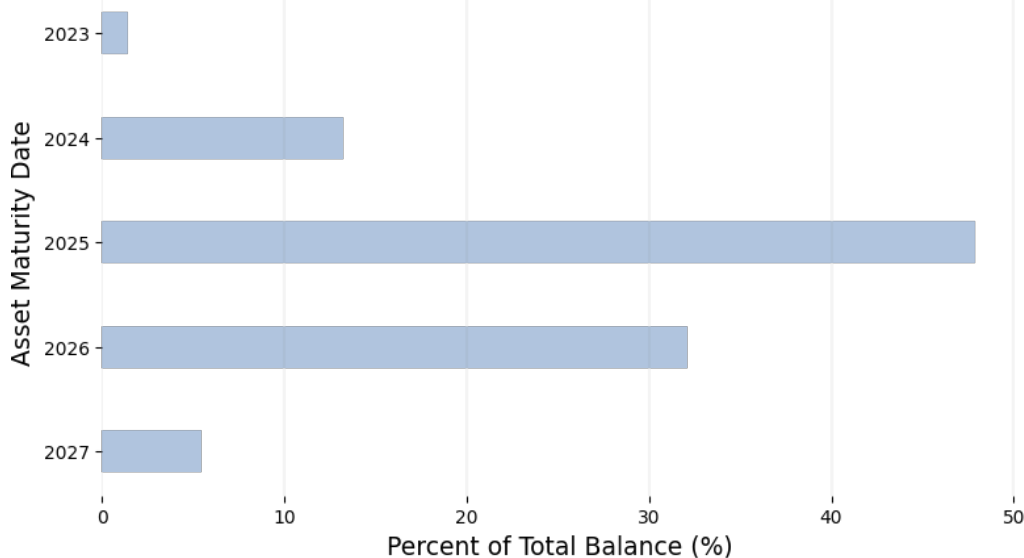


Gross coupon of the underlying assets ranges from 6.5% to 12.7%. The weighted average gross coupon of the portfolio is approximately 8.1.

Asset Maturity Distribution



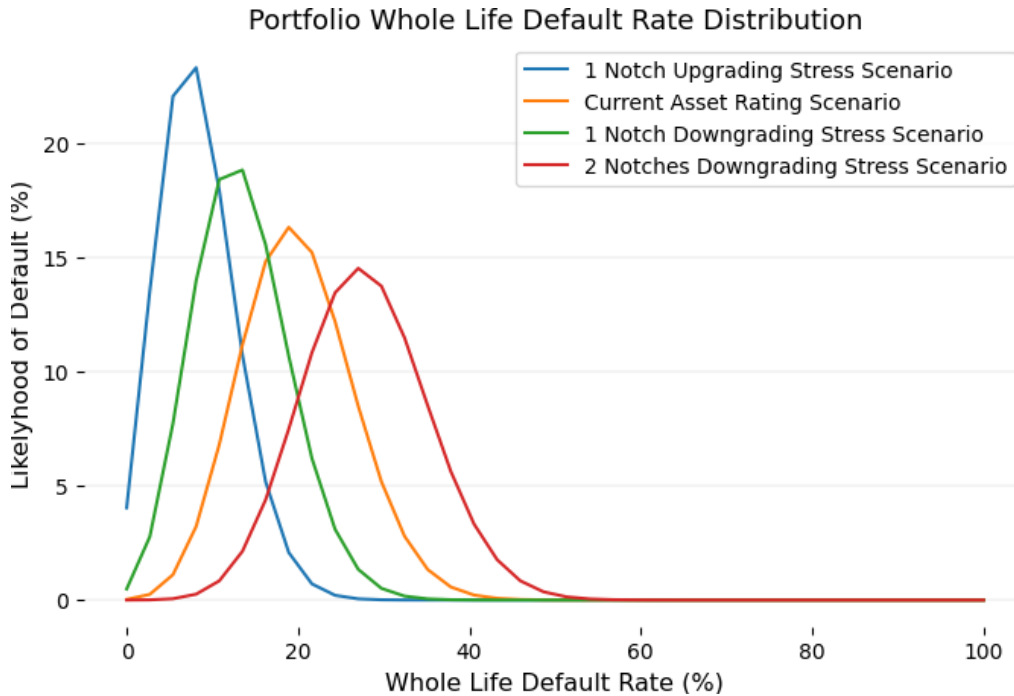

There are 137 non-default assets (with seniority information available) in the underlying collateral pool, 100.0% are senior secured loans, and 0% with lower seniority.

## Sensitivity Analysis



In EJR's view, ratings on loans may be upgraded or downgraded with little notice. In EJR's optimistic case, we assumed an one notch upgrade to the underlying assets. In EJR's stress cases, we assumed one or two notch cut to the underlying assets to reflect possible market pressure. According to EJR's Default Probability Table, the optimistic case, base case, one notch cut and two notches cut cases weighted average whole life default rate of probability are 8.3%, 19.9%, 13.4% and 27.8%, respectively.

## Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:

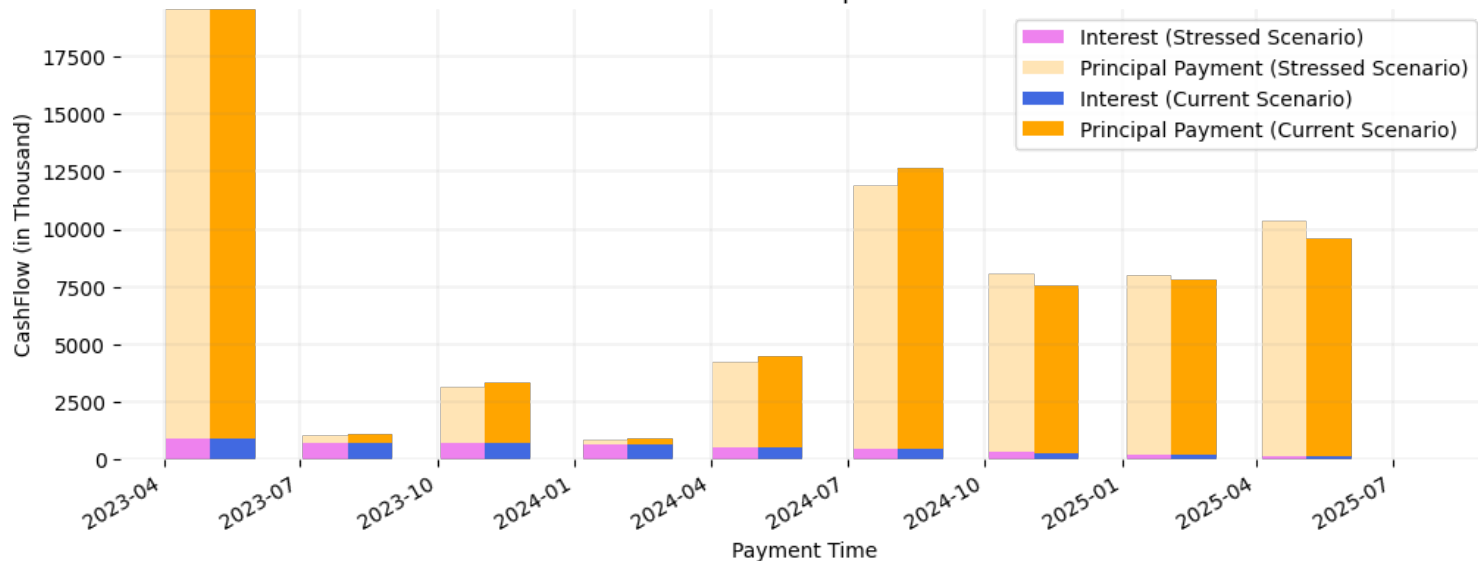

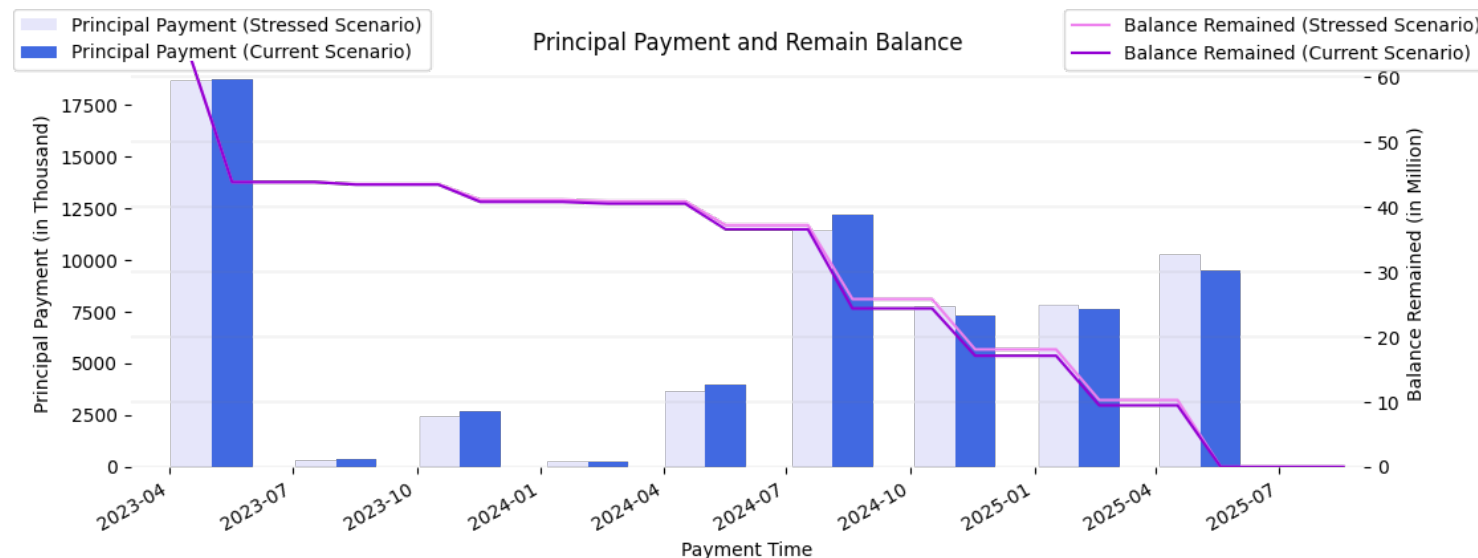

Cashflow Composition



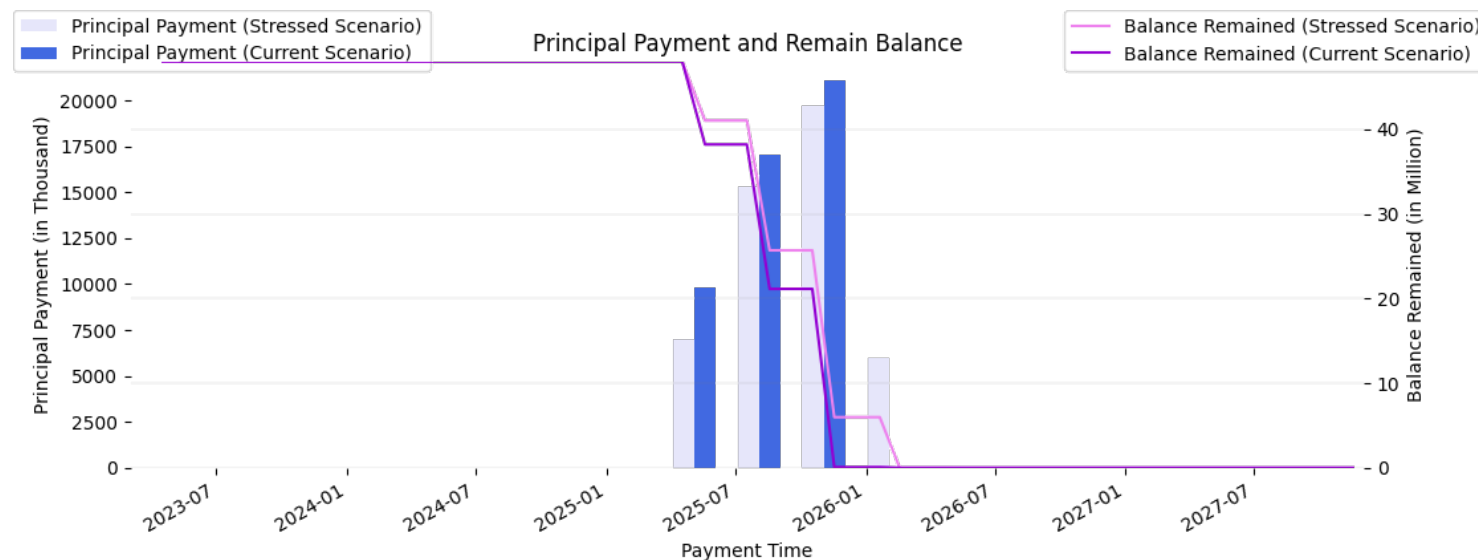
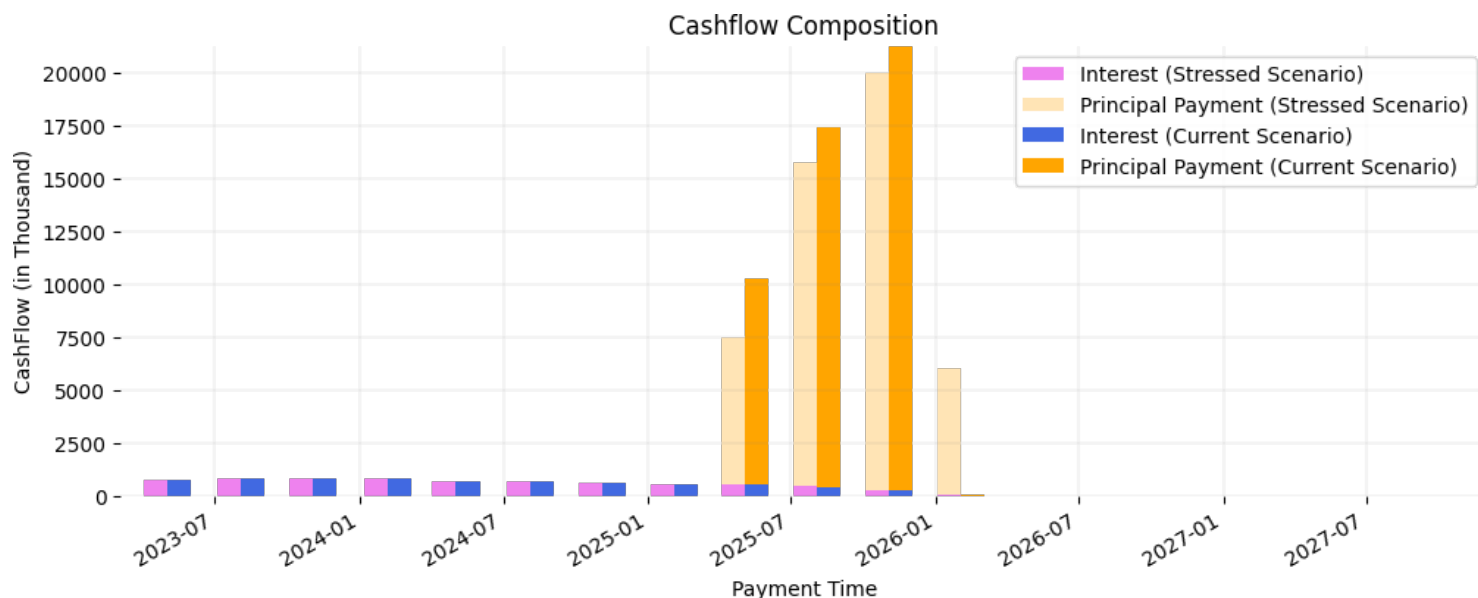

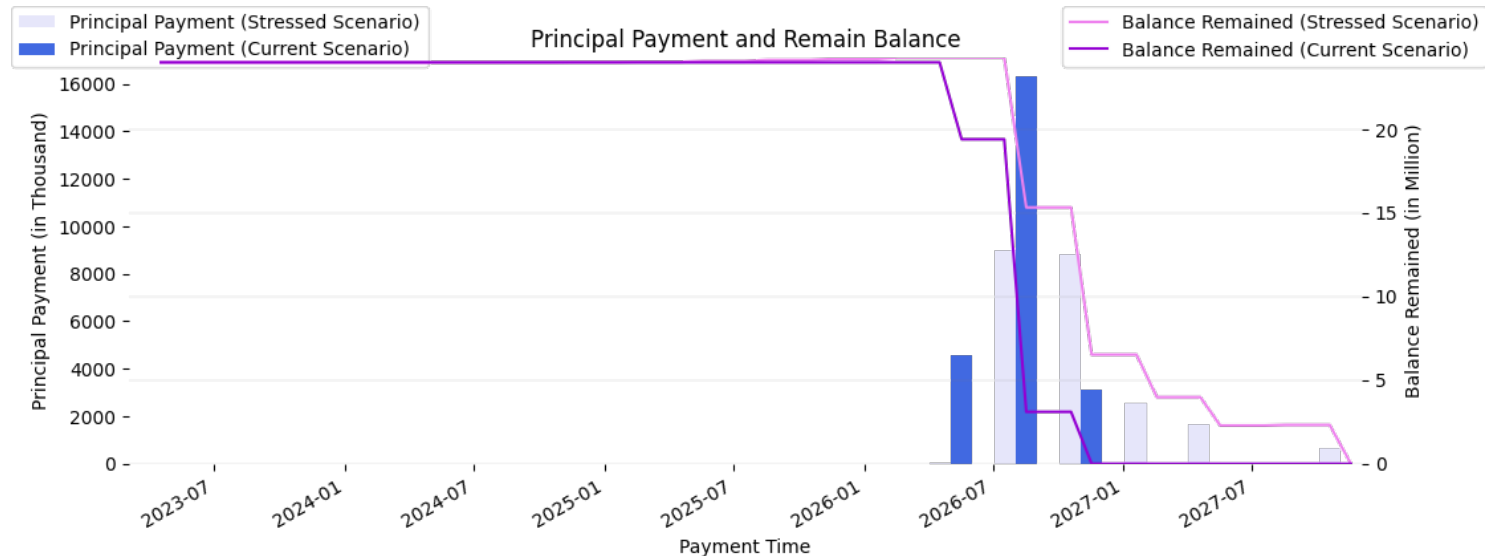

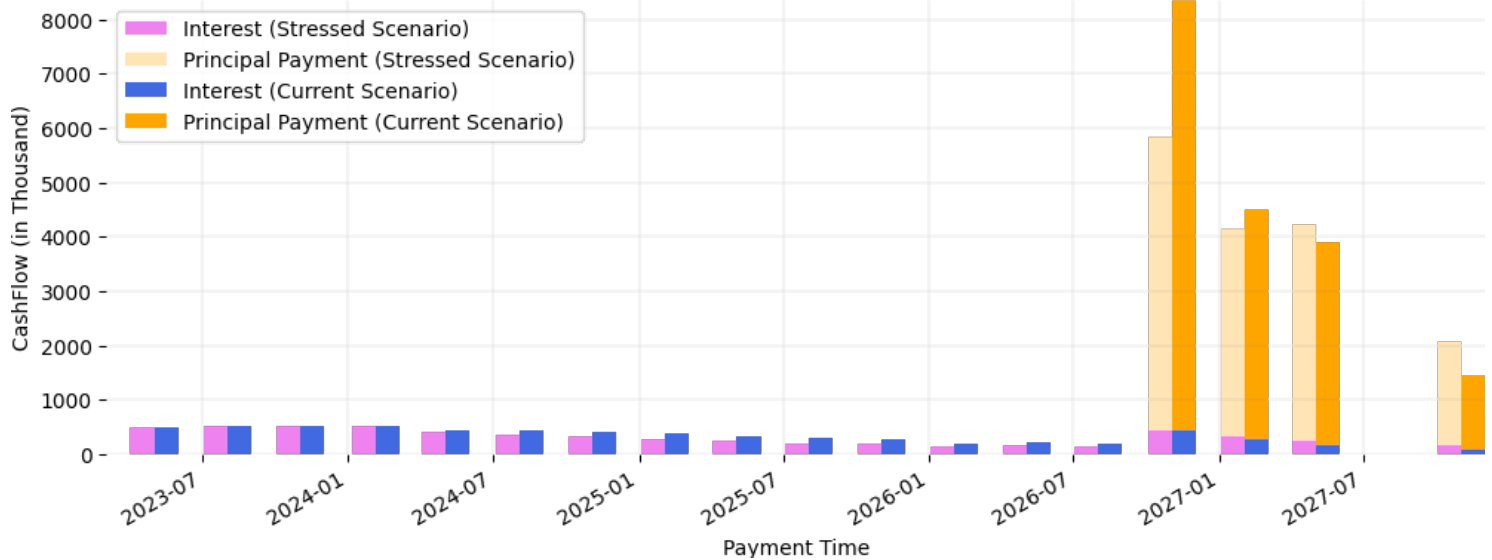

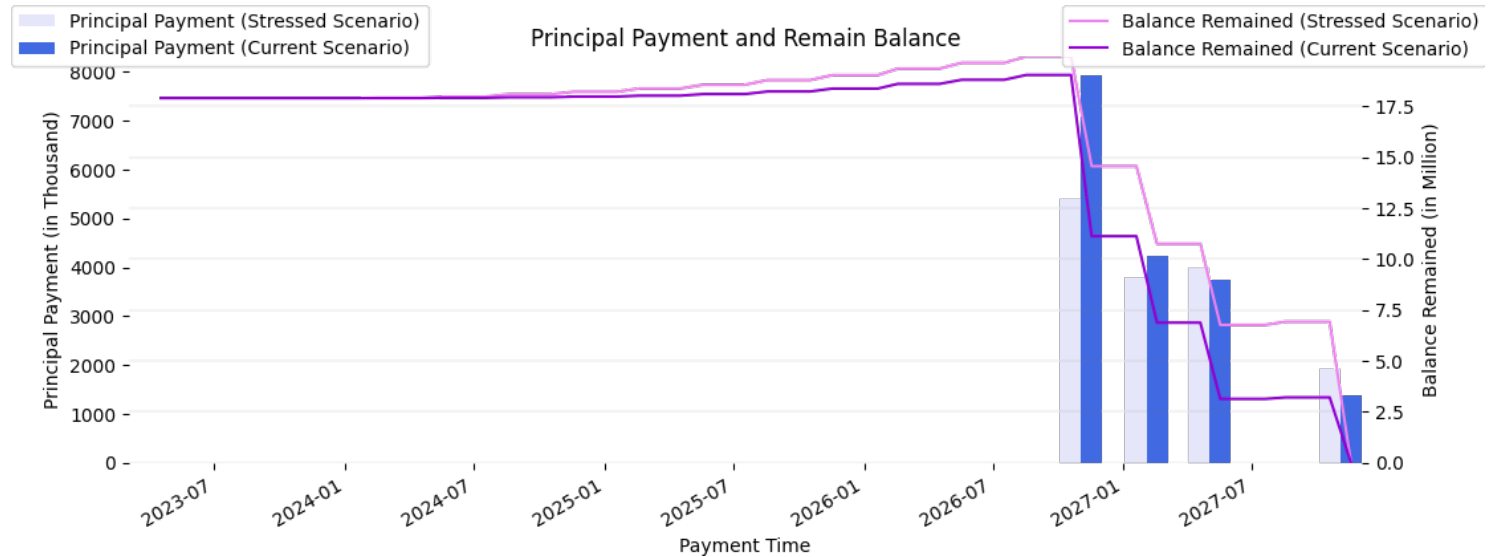

## **EJR's Key Rating Features & Differences Compare With Other NRSROs**

Below is a summary of EJ's approach (see our Methodology for a more complete description):

1. Our rating is derived from estimated losses.
2. The probabilities of default utilized are generally more conservative than industry standards.
3. Generally, our ratings are more heavily model driven and take into account fewer subjective / qualitative assumptions.
4. Generally, EJ updates the cashflow and ratings monthly based on the availability of the trustee reports.
5. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

## **Difference Between Implied Rating and Assigned Rating**

There is no difference between model implied rating and final assigned rating.

There are three notches in each of EJR's rating category (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

We are using the EJR CLO Methodology (Non-NRSRO) version 1a published by December 1, 2022, the General Methodology for Rating Asset Backed and Structured Finance Obligations version 2a published by December 1, 2022.

### **3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:**

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include: 1) Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis. 2) Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate. 3) The economy and regulation policies will remain stable in the foreseeable future. Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Default Rate and Recovery Rate. According to the methodology, EJR converts the collateral assets into numbers of identical independent assets with the same default rate and recovery rate. The number of these converted assets is the Diversity Score.

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer.
