Transaction Summary

We are providing the rating of Battalion CLO XXII as a Non-NRSRO rating. The transaction closed on October 29, 2021. It had a reinvestment period, which ended on January 20, 2027. It has a maturity date of January 20, 2035. The Dealer and Trustee are RBC Capital Markets and U.S. Bank, respectively. The issued notes are collateralized by 95.8 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -94.8 second lien loans and senior unsecured loans. Brigade Capital Management serves as the collateral manager.

As of June 29, 2024, the total balance of the underlying assets was approximately \$407.9M. The diversity score of the portfolio was 64. Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 3778.3 and 4.5, respectively. Approximately 7.4% of the portfolio's assets were rated CCC+ or less by other agencies.




Top 10 Industry Contribution




Portfolio Gross Coupon Distribution



There are 963 non-default assets (with seniority information available) in the underlying collateral pool, 95.8% are senior secured loans, and 4.2% with lower seniority.

Sensitivity Analysis



In EJR's view, ratings on loans may be upgraded or downgraded with little notice. In EJR's optimistic case, we assumed an notch one upgrade to underlying assets. In EJR's stress cases, we assumed one or two notch cut to the underlying assets reflect possible market pressure. According to EJR's Default Probability Table, optimistic case, base case, one notch cut and two notches cut cases weighted average whole life default rate of probability are 14.8%, 31.0%, 47.6% and 38.3%, respectively.



Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:







The charts reflects the remaining balance and cashflow forcasting under a) current default and recovery scenario and b) AAA (sf) stress level default and recovery scenario, assuming 50% loss will happen evenly in the first 2 years. The current principal balance of the tranche is \$75.0M. Under current default and recovery scenario, the payment window for this tranche ranges from Jul 22, 2024 to Jan 20, 2033. By the end of the payment period (Jan 20, 2033), the principal balance should be paid in full. Total interest payments of the tranche will approximately \$0.0M.
