### **Transaction Summary**

We are providing the rating of CarVal CLO VI-C as a Non-NRSRO rating. The transaction closed on June 02, 2022. It had a reinvestment period, which ended on April 21, 2026. It has a maturity date of April 21, 2034. The Dealer and Trustee are Morgan Stanley and Computershare Trust Company, respectively. The issued notes are collateralized by 99.2 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -98.2 second lien loans and senior unsecured loans. CarVal CLO Management serves as the collateral manager.

As of July 27, 2024, the total balance of the underlying assets was approximately \$493.9M. The diversity score of the portfolio was 63. Egan-Jones's weighted average rating score and weighted average life (years) of the collateral were 3801.0 and 4.4, respectively. Approximately 6.4% of the portfolio's assets were rated CCC+ or less by other agencies. Senior tranche subordination was 34.27%.




Top 10 Industry Contribution







There are 333 non-default assets (with seniority information available) in the underlying collateral pool, 99.2% are senior secured loans, and 0.8% with lower seniority.

### **Sensitivity Analysis**



In EJR's view, ratings on loans may be upgraded or downgraded with little notice. In EJR's optimistic case, we assumed an notch one upgrade to underlying assets. In EJR's stress cases, we assumed one or two notch cut to the underlying assets reflect possible market pressure. According to EJR's Default Probability Table, optimistic case, base case, one notch cut and two notches cut cases weighted average whole life default rate of probability are 14.4%, 30.5%, 46.9% and 37.2%, respectively.



#### **Estimated Loss Information**

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. EJR believes a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). A 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). - 1. Our rating is derived from estimated losses.
- 2. The probabilities of default utilized are generally more conservative than industry standards.
- 3. Generally, our ratings are more heavily model driven and take into account fewer subjective / qualitative assumptions.
- 4. Generally, EJR updates the cashflow and ratings monthly based on the availability of the trustee reports.
- 5. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

We are using the EJR CLO Methodology (Non-NRSRO) version 1a published by December 1, 2022, the General Methodology for Rating Asset Backed and Structured Finance Obligations version 2a published by December 1, 2022.

## 3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include: 1) Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis. 2) Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate. 3) The economy and regulation policies will remain stable in the foreseeable future. Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Default Rate and Recovery Rate. According to the methodology, EJR converts the collateral assets into numbers of identical independent assets with the same default rate and recovery rate. The number of these converted assets is the Diversity Score.

### 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings 1) Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment. 2) Do not address investment merit, whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance. 3) Do not address whether the expected return of a particular investment is adequate for the inherent risk. 4) Do not address whether the market value of the security will remain stable over time. 5) Are not exact measures of the probability of default but are instead expressions of the relative credit risk of issuers and debt instruments. 6) Are not recommendations to buy, sell or hold any security.

EJR's rating is dependent on numerous factors including the reliability, accuracy, and quality of the data used in determining the credit rating. The data is sourced from issuers' publicly disclosed reports, or from third-party data vendors. For solicited rating reports, EJR may also use the information provided by the client. In some cases, the information is limited because of issues such as the lack of reported data. Such shortcomings are not always readily apparent. EJR aims to identify such shortcomings and make adjustments using its best judgement.

EJR's ratings of CLO tranches are based on the estimated losses (EL) generated by applying default scenarios based on likelihood of occurrence. However, EJR's credit ratings are not based on absolute measures of probability of default and expected loss. EJR's credit ratings are opinions about the relative creditworthiness of an entity or an instrument.
