## Transaction Summary

We are providing the rating of GLM 2019-4A as a Non-NRSRO rating. The transaction closed on March 06, 2019. It had a reinvestment period, which ended on April 24, 2024. It has a maturity date of April 24, 2031. The deal was refinanced on May 14, 2021. The investments were callable as of April 24, 2021. The Dealer and Trustee were Morgan Stanley / BofA Merrill Lynch / Wells Fargo Securities and Bank of New York Mellon Trust Company, respectively. The issued notes are collateralized by 100% senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of 0% second lien loans and senior unsecured loans. GoldenTree Loan Management serves as the collateral manager.

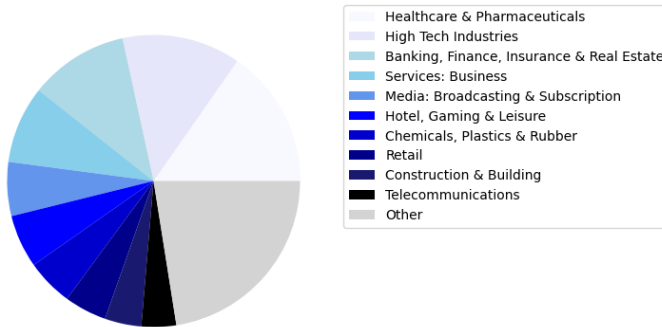
As of August 01, 2021, the total balance of the underlying assets was approximately \$815.34M. The diversity score of the portfolio was 52. EJR's weighted average rating score and weighted average life (years) of the collateral were 3858 and 5.08, respectively. 7.53% of the portfolio's assets were rated CCC+ or less by other NRSROs.

Top 10 Industry Contribution

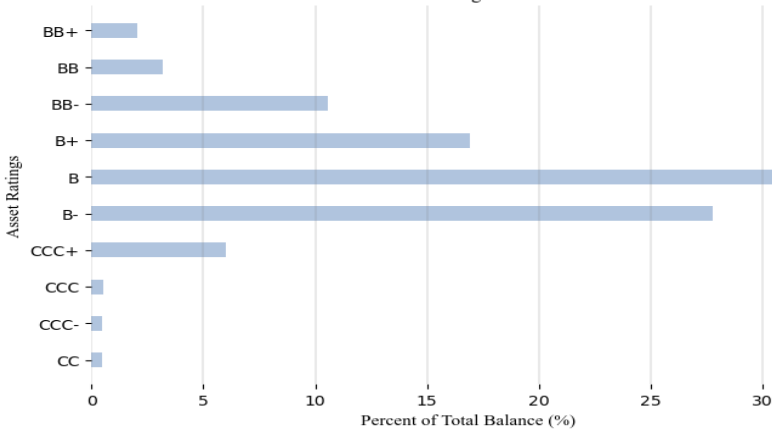

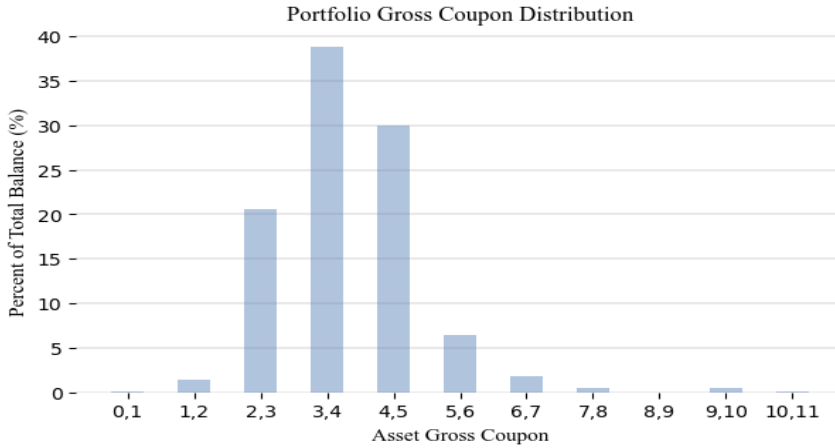
Portfolio Rating Distribution

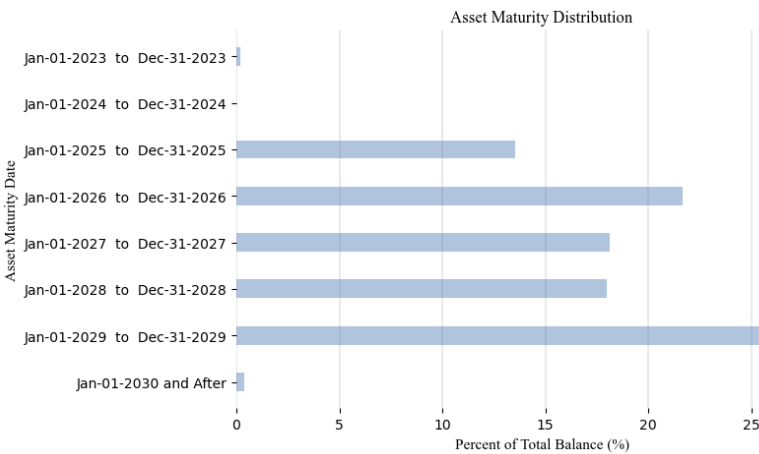

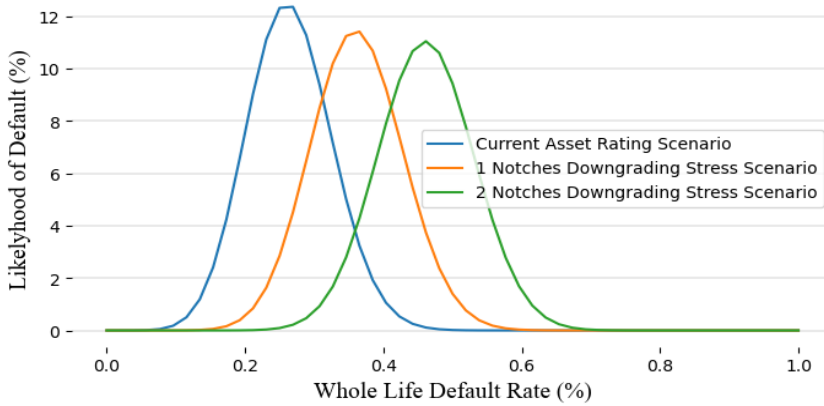

In EJR's view, the credit quality for syndicated loans has been under pressure recently. Unfortunately, ratings on some loans may be cut multiple notches with little notice. In EJR's stress case, we took an one notch cut to the underlying assets to reflect the credit quality of each tranche created by market pressure. In EJR's extra stress case, we assumed a two notch cut to the underlying assets. According to EJR's Default Probability Table, the stress case and extra stress case weighted average whole life default rate of probability can increase to 36.19% and 46.15%, respectively, from its current level of 26.48%.

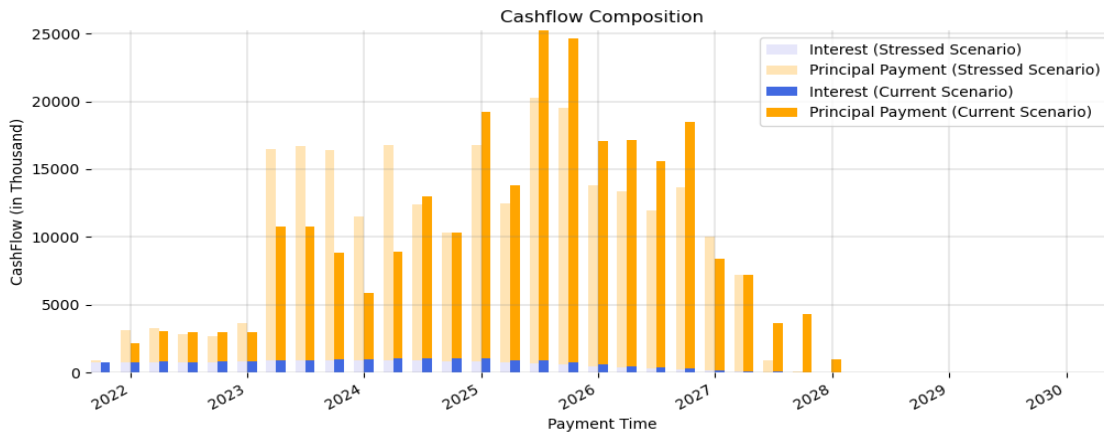
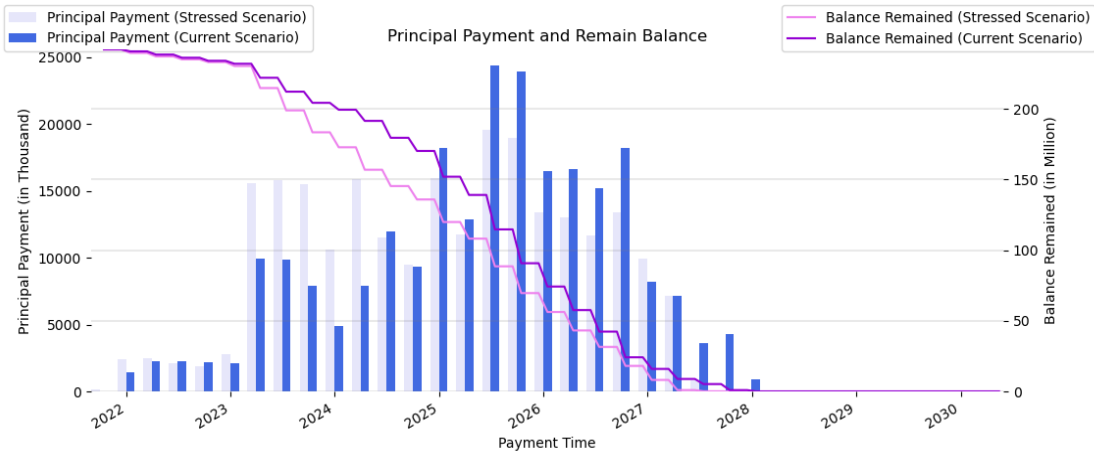
## Estimated Loss Information

Estimated loss is one of the key considerations in EJR's structured finance ratings. In times of stress when economic conditions are deteriorating, default rates and loss severity are more likely to increase relative to a portfolio's initial or base case default and loss severity levels. That is a tranche with higher rating should be able to withstand greater stress and sustain lower losses than a tranche with a lower rating. For example, a tranche with AAA rating should be able to survive the great depression scenario (the highest default and loss severity levels experienced if they were to occur in the future). An 'AA' rated tranche would be more susceptible to an adverse economic impact than the 'AAA' rated tranche, but nonetheless should be able to withstand such effects better than a tranche with a lower rating. EJR creates different stress levels based on different target tranche ratings (from AAA to B+). The detailed estimated loss (%) information of each tranche under each stress level is detailed in the below table:

3. Generally, our ratings are more heavily model driven and take into account fewer subjective / qualitative assumptions.
4. Generally, EJ updates the cashflow and ratings monthly based on the availability of the trustee reports.
5. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Default Rate and Recovery Rate.
