Transaction Summary

We are providing the rating of Vibrant CLO VI as a Non-NRSRO rating. The transaction closed on June 22, 2017. It had a reinvestment period, which ended on September 20, 2021. It has a maturity date of June 20, 2029. The Dealer and Trustee are BNP Paribas and Citibank, respectively. The issued notes are collateralized by 100.0 senior secured loans, cash, and eligible investments with the balance of the portfolio consisting of -99.0 second lien loans and senior unsecured loans. Vibrant Credit Partners serves as the collateral manager. This transaction was fully paid off.

We are using the EJR CLO Methodology (Non-NRSRO) version 1a published by December 1, 2022, the General Methodology for Rating Asset Backed and Structured Finance Obligations version 2a published by December 1, 2022.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include: 1) Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis. 2) Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate. 3) The economy and regulation policies will remain stable in the foreseeable future. Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Default Rate and Recovery Rate. According to the methodology, EJR converts the collateral assets into numbers of identical independent assets with the same default rate and recovery rate. The number of these converted assets is the Diversity Score.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer.
