Transaction Summary

The transaction closed on Sep 24 2015 and matures in Apr 2029. The pool's current aggregate principal balance is \$711.9 million compared to \$753.2 million at close.

The largest loan of the pool (9.0%) is secured by Charles River Plaza North located in Boston, MA metropolitan area. Occupancy at the subject was 100%. The largest tenant was General Hospital corporation (100.00%). The second largest loan of the pool (9.8%) is secured by 261 Fifth Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included NEXT JUMP INC (7.72%) and DKC (6.59%). The third largest loan of the pool (8.9%) is secured by Westin Hotel at the Domain located in metropolitan area. Occupancy at the subject was 72%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.37% and 64 months as of 12/15/2020, respectively. There are a total of 41 loans and 57 properties in the portfolio. The appraisal LTV was approximately 60.7% compared to the Original loan to value (LTV), which was approximately 59.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.93x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

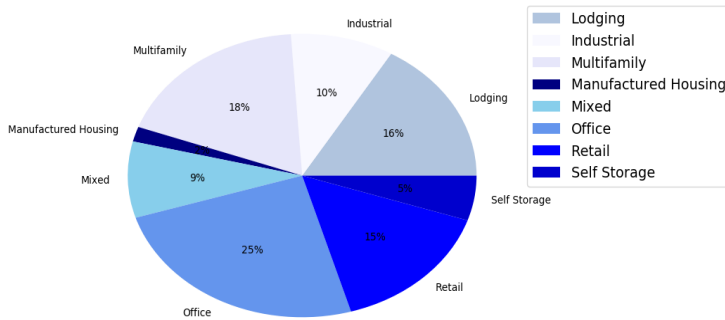

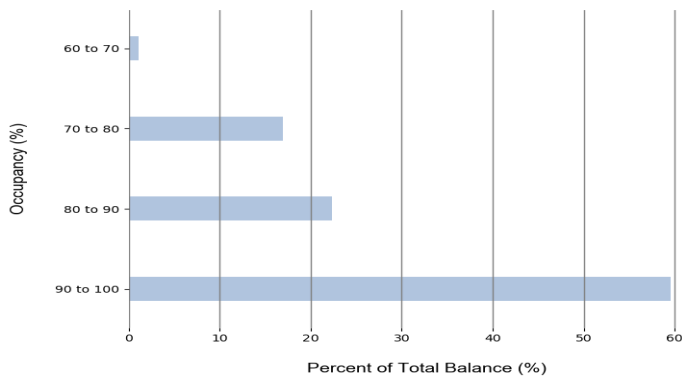

Occupancy Distribution (%)

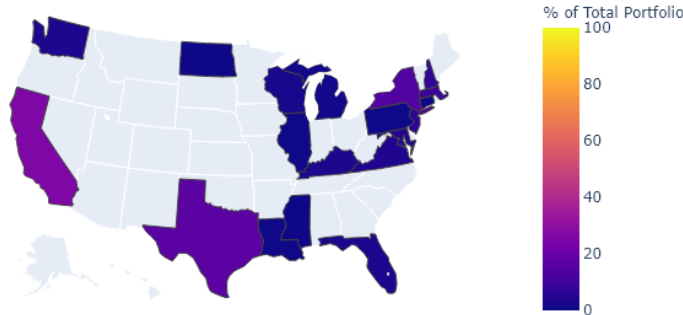

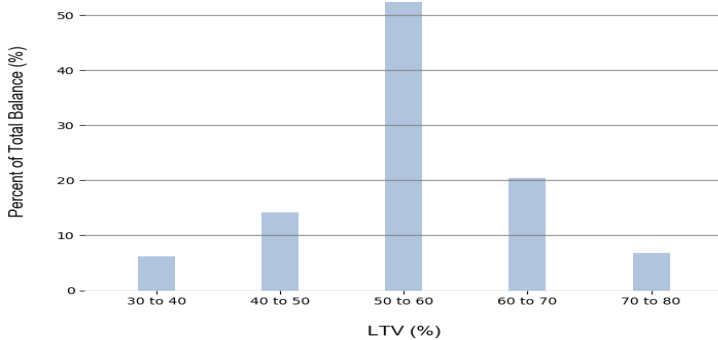
Local Distribution

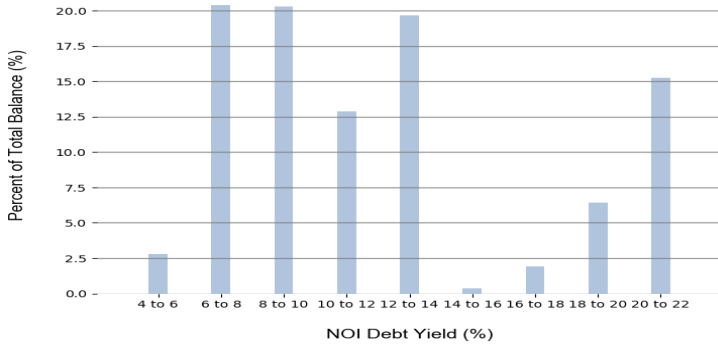

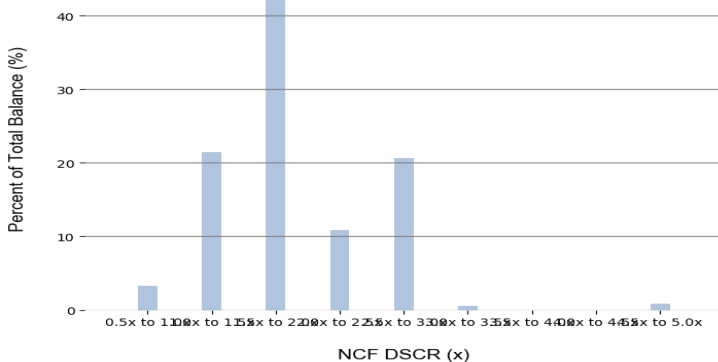
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 21% with a weighted average NOI debt yield of 12.1%. NOI debt yield ranged from 4% to 21%. There were 1 assets (3% of total balance) with NOI debt yield between 4% and 6%, 5 assets (20% of total balance) with NOI debt yield between 6% and 8%, 8 assets (20% of total balance) with NOI debt yield between 8% and 10%, 6 assets (13% of total balance) with NOI debt yield between 10% and 12%, 11 assets (20% of total balance) with NOI debt yield between 12% and 14%, 1 assets (0% of total balance) with NOI debt yield between 14% and 16%, 2 assets (2% of total balance) with NOI debt yield between 16% and 18%, 3 assets (6% of total balance) with NOI debt yield between 18% and 20% and 4 assets (15% of total balance) with NOI debt yield between 20% and 22%.

Net Cash Flow DSCR (x)

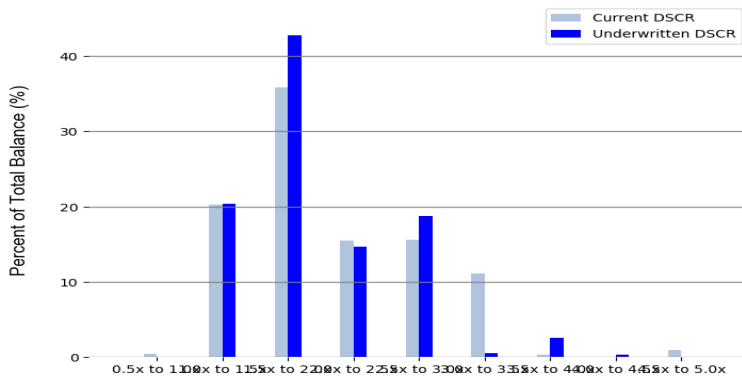

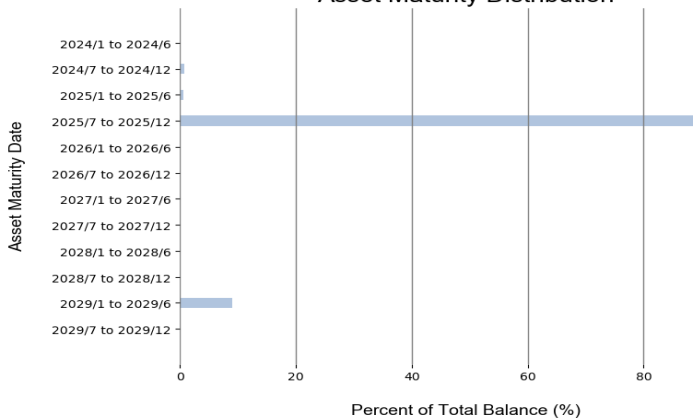
DSCR Distribution (x)

There are 1 assets (0.4% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (20.3% of total balance) with DSCR between 1.0x and 1.5x, 10 assets (35.8% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (15.5% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (15.6% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (11.1% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.4% of total balance) with DSCR between 3.5x and 4.0x and 2 assets (0.9% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
