Transaction Summary

The transaction closed on Feb 16 2017 and matures in Feb 2027. The pool's current aggregate principal balance is \$889.5 million compared to \$915.6 million at close.

The largest loan of the pool (8.2%) is secured by The Summit Birmingham located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Belk's (24.00%) and RSM US LLP (5.24%). The second largest loan of the pool (7.8%) is secured by KOMO Plaza located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 86%. The major tenants included Sinclair Broadcasting (41.55%) and TierPoint Seattle Ho (14.49%). The third largest loan of the pool (5.6%) is secured by 85 Tenth Avenue -Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 89%. The major tenants included Google (28.40%) and GSA (28.10%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.51% and 64 months as of 04/15/2022, respectively. There are a total of 61 loans and 91 properties in the portfolio. The appraisal LTV was approximately 55.7% compared to the Original loan to value (LTV), which was approximately 57.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.06x. As of 04/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

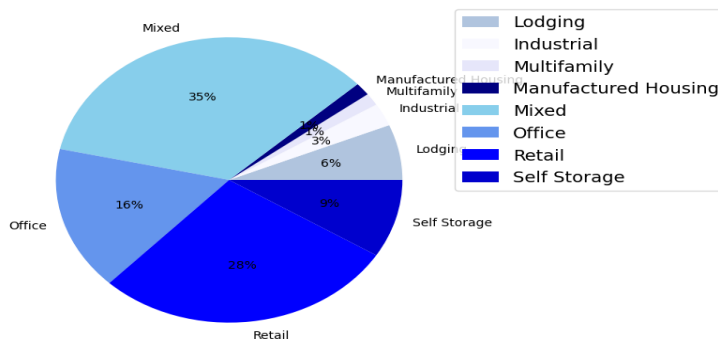

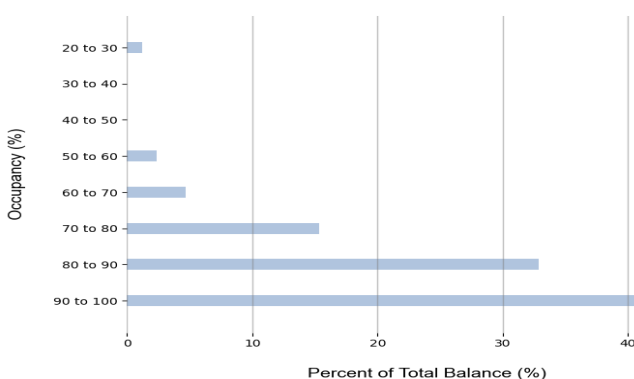

Occupancy Distribution (%)

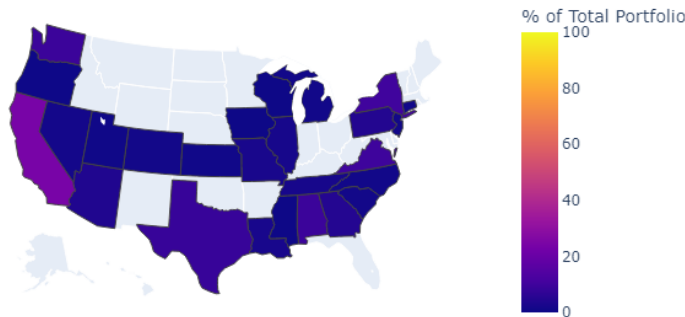

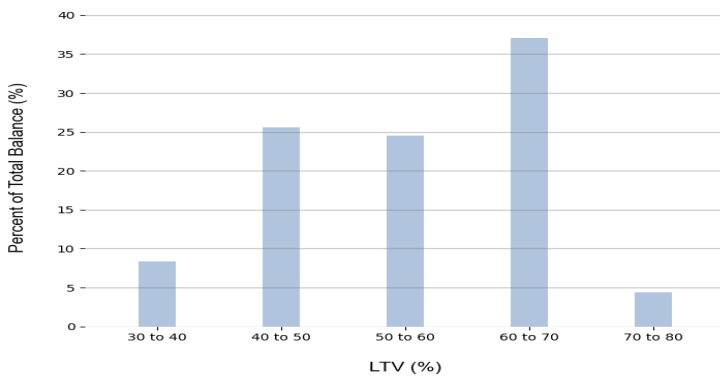
Local Distribution

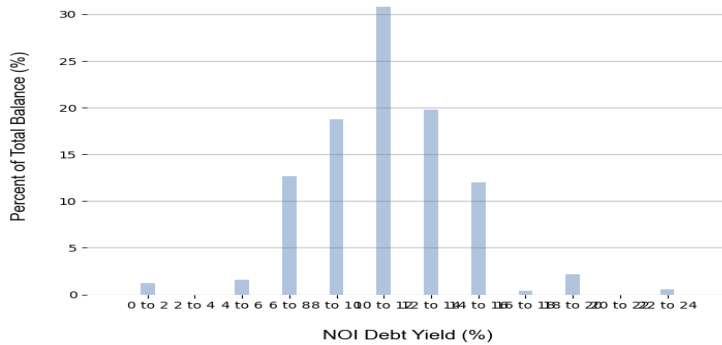

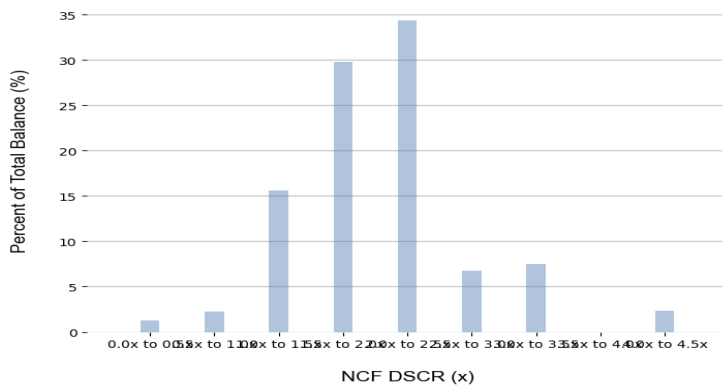
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

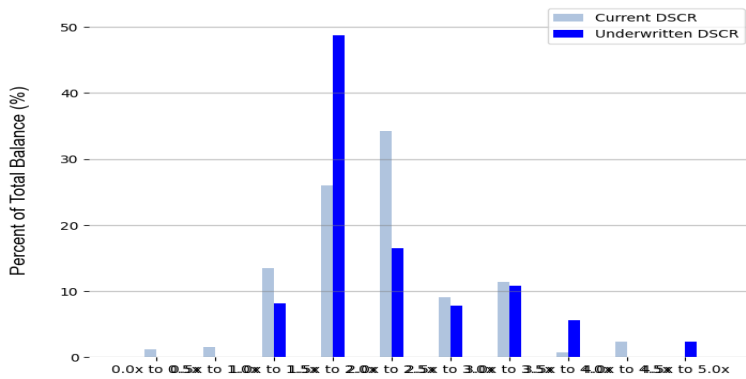

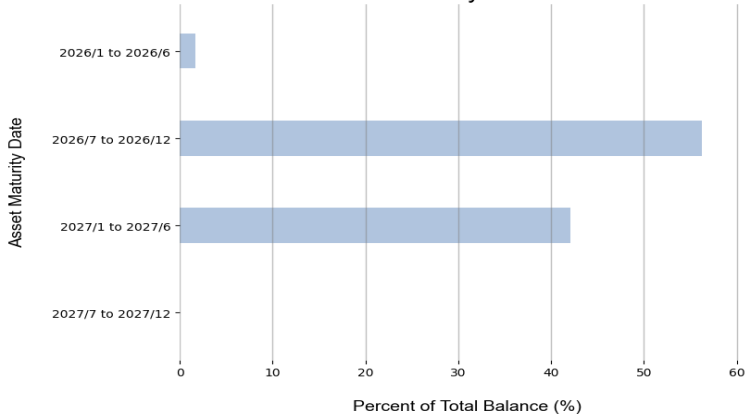
DSCR Distribution (x)

There are 1 assets (1.2% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (1.6% of total balance) with DSCR between 0.5x and 1.0x, 15 assets (13.5% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (26.0% of total balance) with DSCR between 1.5x and 2.0x, 16 assets (34.3% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (9.1% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (11.4% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.7% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (2.3% of total balance) with DSCR between 4.0x and 4.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


