Transaction Summary

The transaction closed on Feb 27 2017 and matures in Nov 2031. The pool's current aggregate principal balance is \$826.2 million compared to \$842.6 million at close.

The largest loan of the pool (7.4%) is secured by Alhambra Towers located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 92%. The major tenants included AerSale Inc (15.73%) and Becker & Poliakoff P.A. (12.93%). The second largest loan of the pool (6.8%) is secured by 1166 Avenue of the Americas located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included DE Shaw & Co (43.80%) and Arcesium (20.00%). The third largest loan of the pool (6.8%) is secured by 1000 Denny Way located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 93%. The major tenants included Seattle Times Company (59.41%) and Level 3 Communications (18.65%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.01% and 47 months as of 12/15/2020, respectively. There are a total of 57 loans and 74 properties in the portfolio. The appraisal LTV was approximately 60.0% compared to the Original loan to value (LTV), which was approximately 59.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.86x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

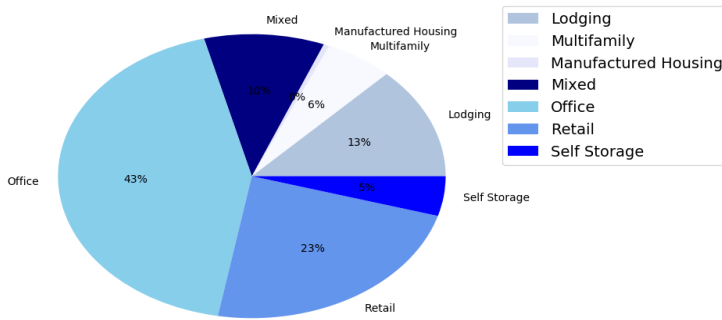

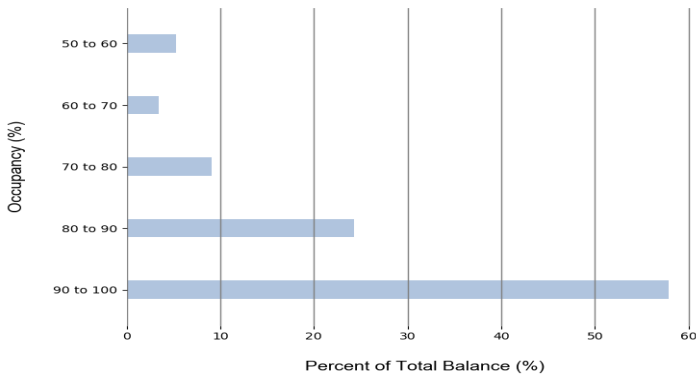

Occupancy Distribution (%)

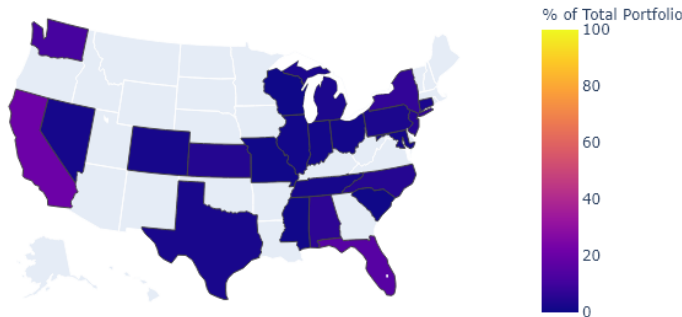

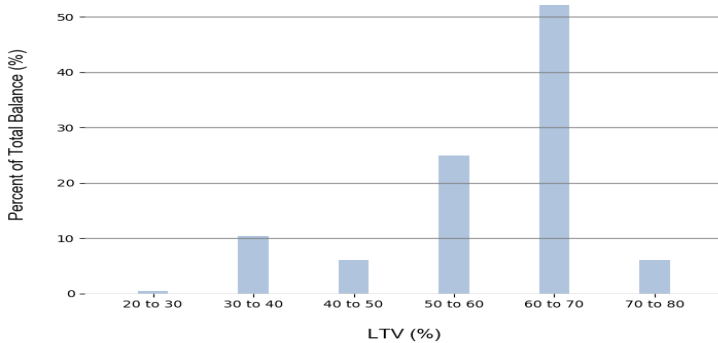
Local Distribution

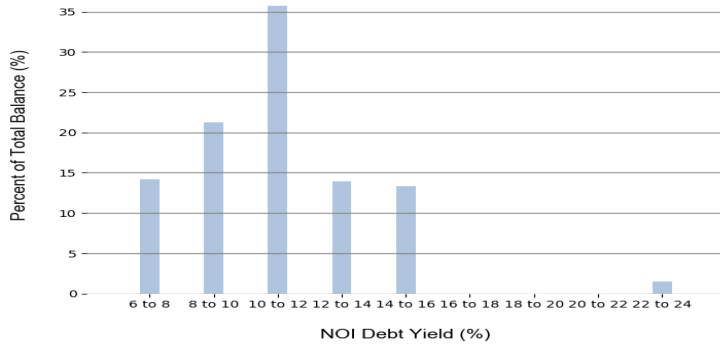

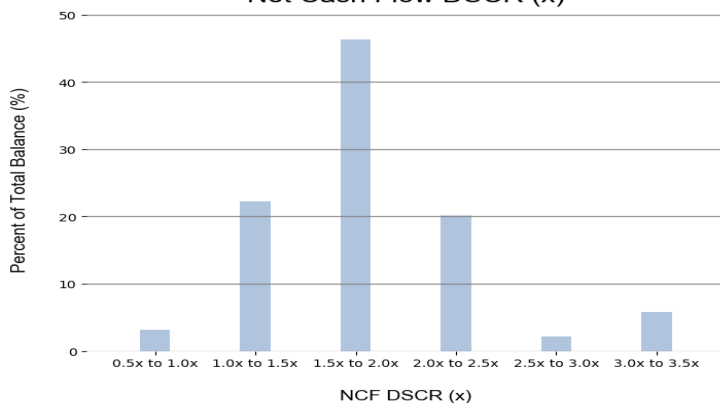
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

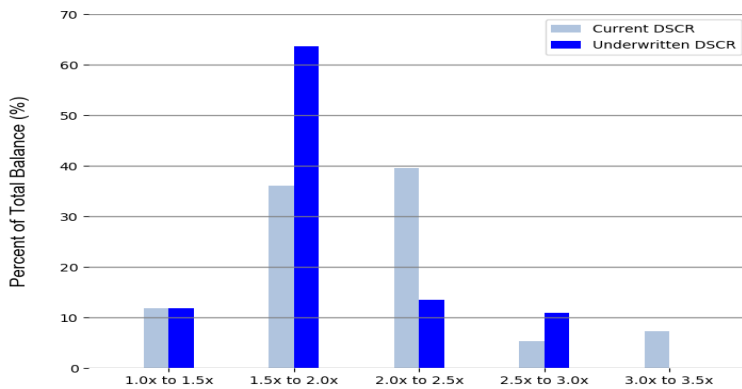


NCF DSCR ranged from 0.0x to 3.0x. There were 4 assets (3.2% of total balance) with NCF DSCR between 0.5x and 1.0x, 15 assets (22.3% of total balance) with NCF DSCR between 1.0x and 1.5x, 23 assets (46.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (20.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.2% of total balance) with NCF DSCR between 2.5x and 3.0x and 2 assets (5.8% of total balance) with NCF DSCR between 3.0x and 3.5x. 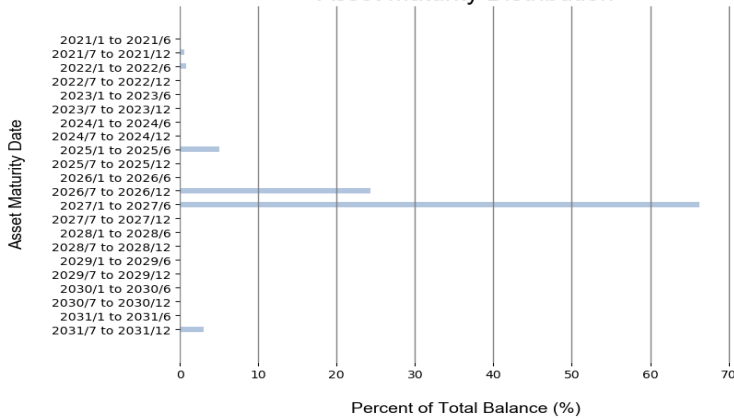
DSCR Distribution (x)



DSCRs ranged from 1.0x to 3.5x. There are 13 assets (11.8% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (36.0% of total balance) with DSCR between 1.5x and 2.0x, 17 assets (39.6% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (5.3% of total balance) with DSCR between 2.5x and 3.0x and 3 assets (7.2% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 2.0x.

There are 1 assets (0.6% of total balance) that have maturity dates between 2021/7 and 2021/12, 1 assets (0.8% of total balance) that have maturity dates between 2022/1 and 2022/6, 1 assets (5.0% of total balance) that have maturity dates between 2025/1 and 2025/6, 19 assets (24.3% of total balance) that have maturity dates between 2026/7 and 2026/12, 34 assets (66.3% of total balance) that have maturity dates between 2027/1 and 2027/6 and 1 assets (3.0% of total balance) that have maturity dates between 2031/7 and 2031/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
