## Transaction Summary

The transaction closed on Feb 27 2018 and matures in Jan 2033. The pool's current aggregate principal balance is \$1480.4 million compared to \$1507.5 million at close.

The largest loan of the pool (5.4%) is secured by Central Park of Lisle located in metropolitan area. Occupancy at the subject was 84%. The major tenants included Armour-Eckrich Meats LLC (7.65%) and Kantar LLC (5.76%). The second largest loan of the pool (4.4%) is secured by Promenade Shops at Aventura located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 94%. The major tenants included Marshall's (16.58%) and Winn Dixie (12.31%). The third largest loan of the pool (4.6%) is secured by Apple Campus 3 located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Apple Inc (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.21% and 51 months as of 03/15/2022, respectively. There are a total of 57 loans and 64 properties in the portfolio. The appraisal LTV was approximately 61.9% compared to the Original loan to value (LTV), which was approximately 56.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.96x. As of 03/15/2022, 2.03% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.

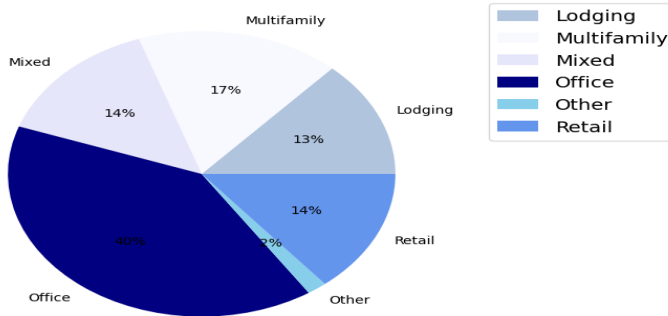

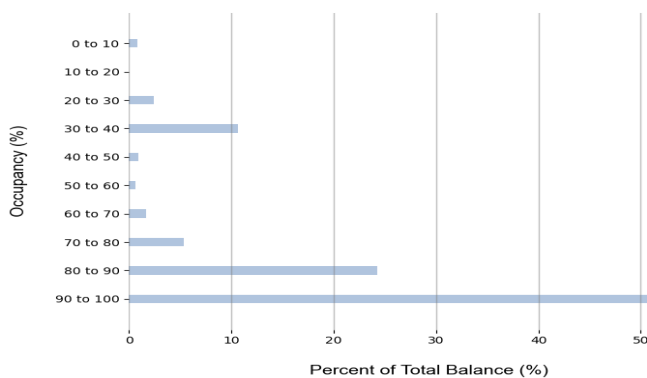

### Occupancy Distribution (%)



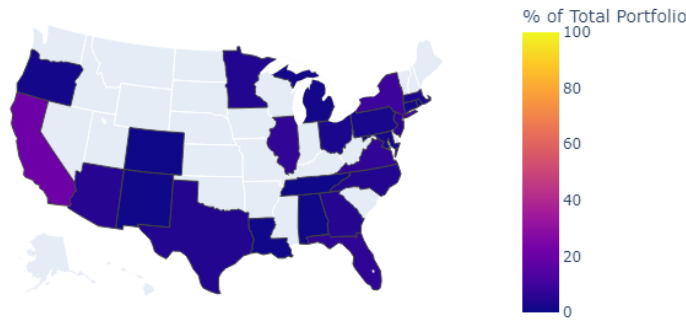

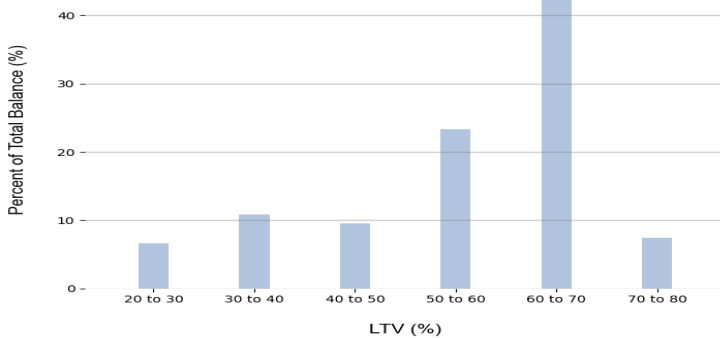
Local Distribution

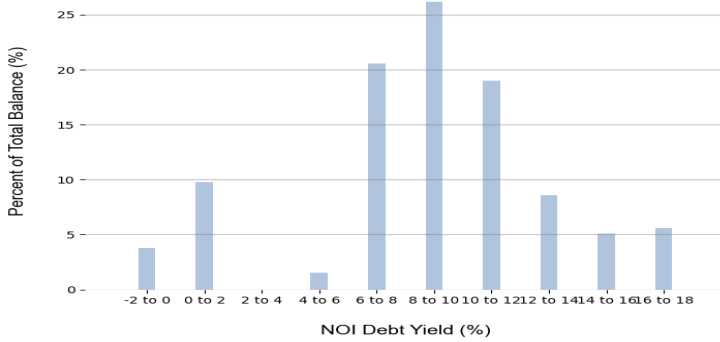

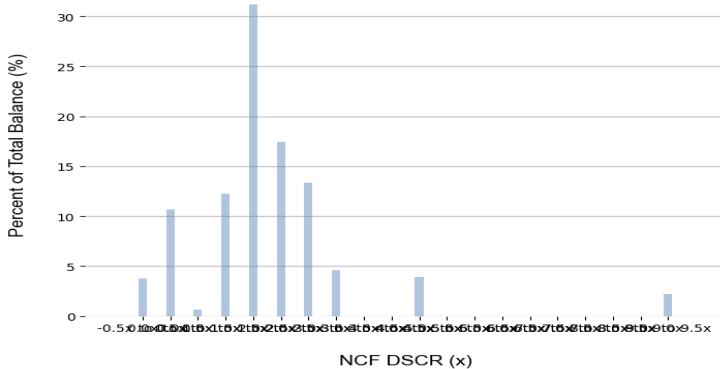
NOI Debt Yield (%)

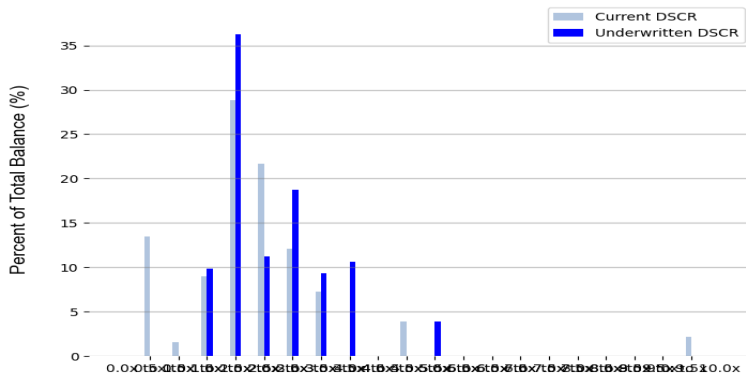

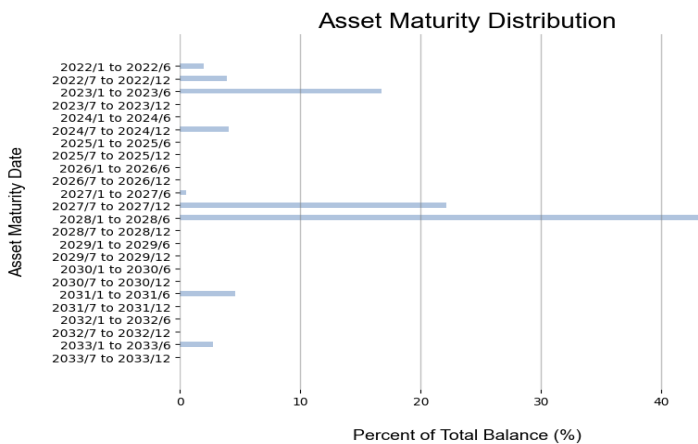

There are 5 assets (13.5% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (1.5% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (9.0% of total balance) with DSCR between 1.0x and 1.5x, 24 assets (28.8% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (21.6% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (12.1% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (7.3% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (3.9% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (2.2% of total balance) with DSCR between 9.5x and 10.0x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### 4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:


