Transaction Summary

The transaction closed on Feb 14 2019 and matures in Oct 2033. The pool's current aggregate principal balance is \$879.6 million compared to \$883.7 million at close.

The largest loan of the pool (10.0%) is secured by 3 Park Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 85%. The major tenants included HOUGHTON MIFFLIN (9.66%) and P.KAUFMANN INC. (8.54%). The second largest loan of the pool (5.3%) is secured by Country Club Plaza located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 93%. The major tenants included Octapharma USA (20.99%) and Sony (18.39%). The third largest loan of the pool (5.3%) is secured by Plymouth Corporate Center located in metropolitan area. Occupancy at the subject was 98%. The major tenants included TCF Bank (72.43%) and Comm-Works LLC (10.79%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.02% and 24 months as of 12/15/2020, respectively. There are a total of 50 loans and 88 properties in the portfolio. The appraisal LTV was approximately 62.2% compared to the Original loan to value (LTV), which was approximately 62.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.80x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

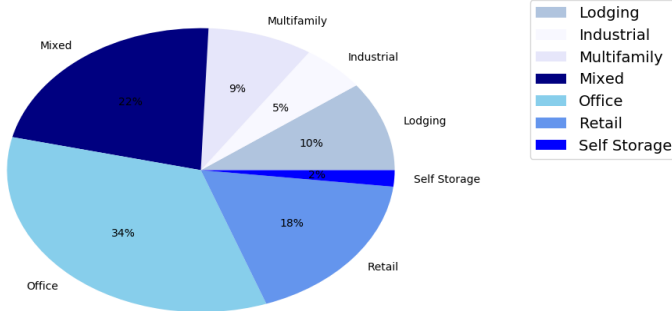

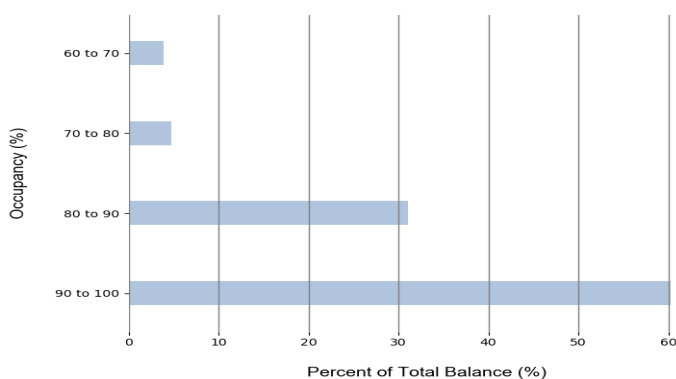

Occupancy Distribution (%)

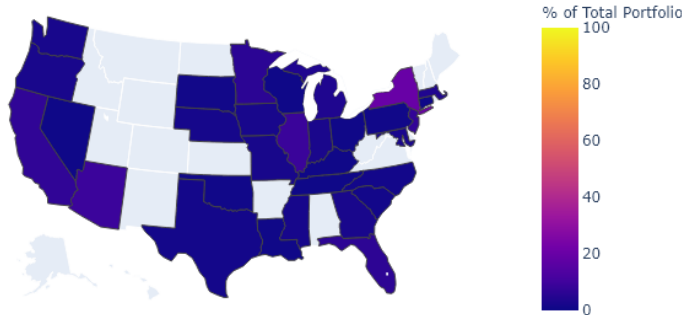

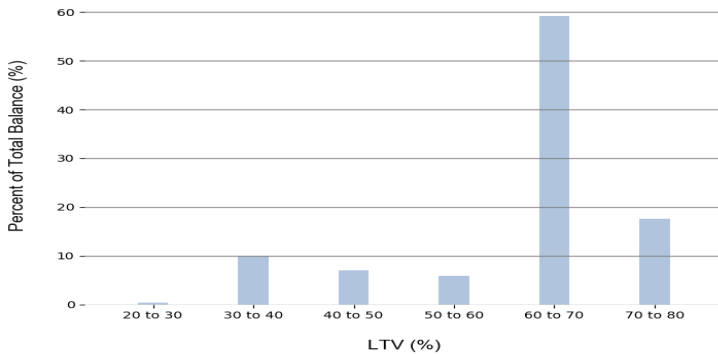
Local Distribution

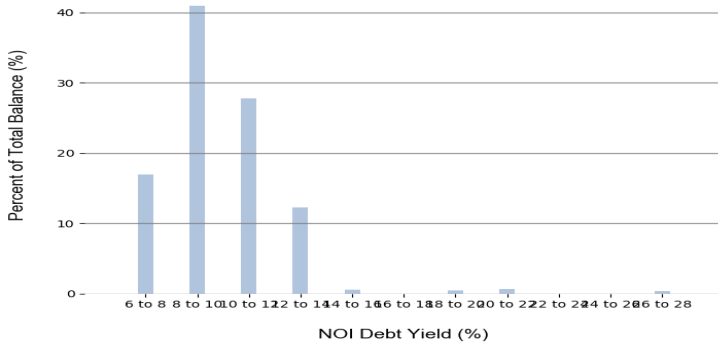

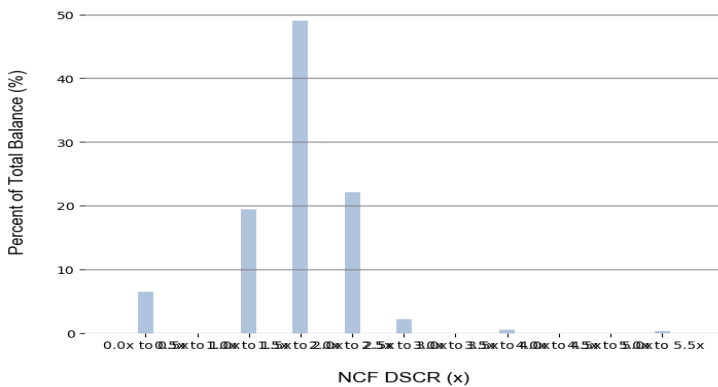
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

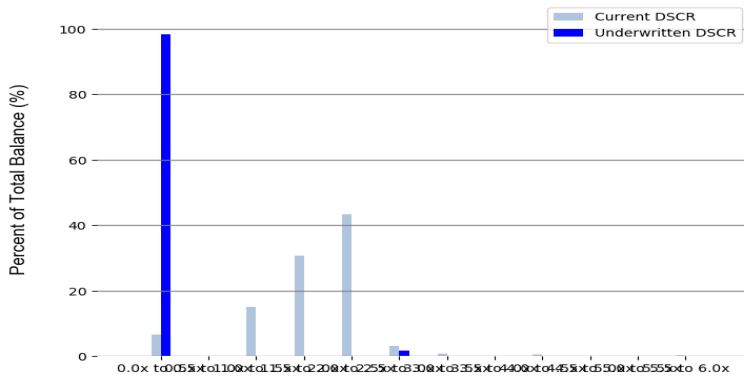


NCF DSCR ranged from 0.0x to 5.0x. There were 4 assets (6.5% of total balance) with NCF DSCR between 0.0x and 0.5x, 13 assets (19.4% of total balance) with NCF DSCR between 1.0x and 1.5x, 21 assets (49.0% of total balance) with NCF DSCR between 1.5x and 2.0x, 8 assets (22.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.5% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (0.3% of total balance) with NCF DSCR between 5.0x and 5.5x. 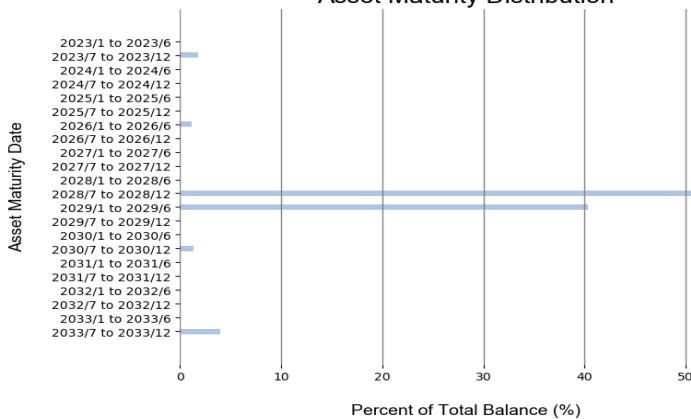
DSCR Distribution (x)



DSCRs ranged from 0.0x to 6.0x. There are 4 assets (6.5% of total balance) with DSCR between 0.0x and 0.5x, 9 assets (14.9% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (30.6% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (43.3% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (3.2% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.7% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (0.3% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 1.9x.

There are 2 assets (1.8% of total balance) that have maturity dates between 2023/7 and 2023/12, 1 assets (1.2% of total balance) that have maturity dates between 2026/1 and 2026/6, 21 assets (51.3% of total balance) that have maturity dates between 2028/7 and 2028/12, 24 assets (40.4% of total balance) that have maturity dates between 2029/1 and 2029/6, 1 assets (1.3% of total balance) that have maturity dates between 2030/7 and 2030/12 and 1 assets (4.0% of total balance) that have maturity dates between 2033/7 and 2033/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
