Transaction Summary

The transaction closed on Dec 20 2017 and matures in Nov 2032. The pool's current aggregate principal balance is \$1040.3 million compared to \$1053.8 million at close.

The largest loan of the pool (10.1%) is secured by Duane Morris Plaza located in Philadelphia, PA metropolitan area. Occupancy at the subject was 97%. The major tenants included DUANE MORRIS LLP (41.62%) and Convene South (7.41%). The second largest loan of the pool (9.3%) is secured by Griffin Portfolio located in Dallas-Plano-Irving, TX-22.68% Seattle-Bellevue-Everett, WA-3.76% metropolitan area. Occupancy at the subject was 97%. The major tenants included Restoration Hardware (40.48%) and State Farm Insurance Company (13.57%). The third largest loan of the pool (8.2%) is secured by Laguna Cliffs Marriott located in Anaheim-Santa Ana-Irvine, CA metropolitan area. Occupancy at the subject was 67%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.24% and 35 months as of 10/15/2020, respectively. There are a total of 45 loans and 89 properties in the portfolio. The appraisal LTV was approximately 59.0% compared to the Original loan to value (LTV), which was approximately 59.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.33x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

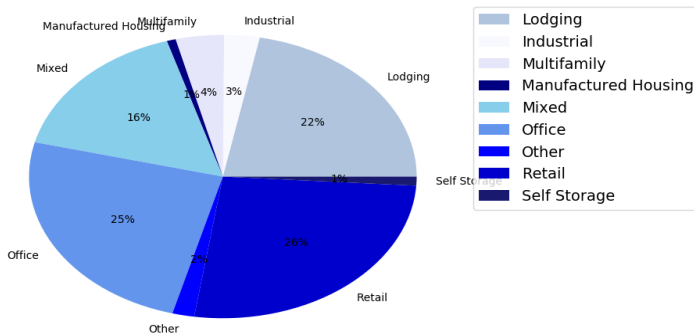

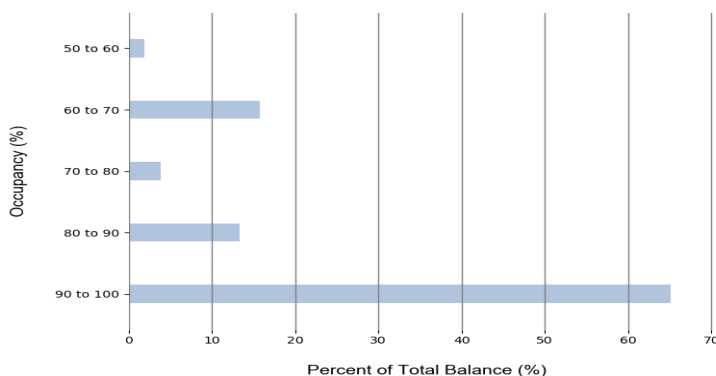

Occupancy Distribution (%)

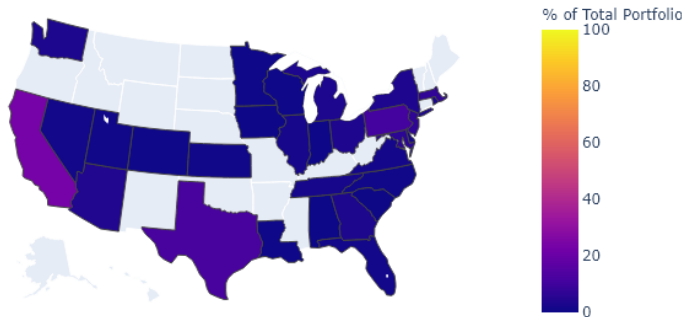

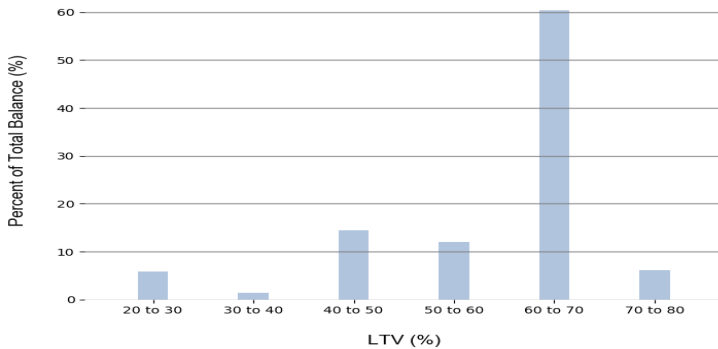
Local Distribution

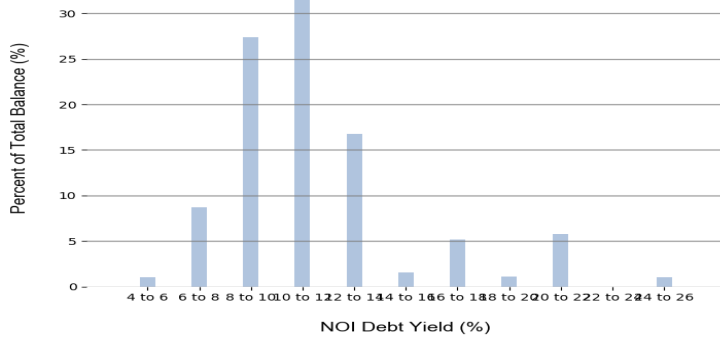

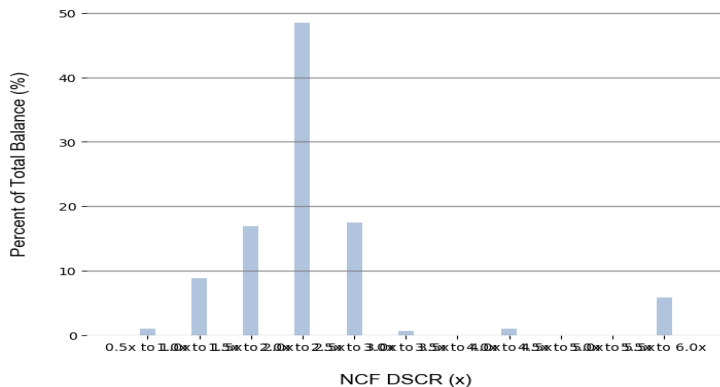
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

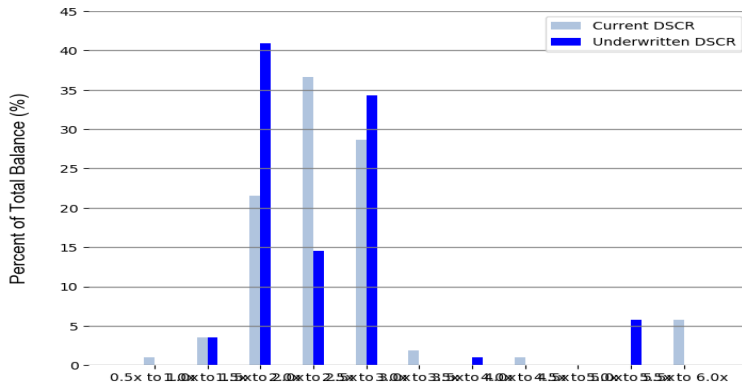

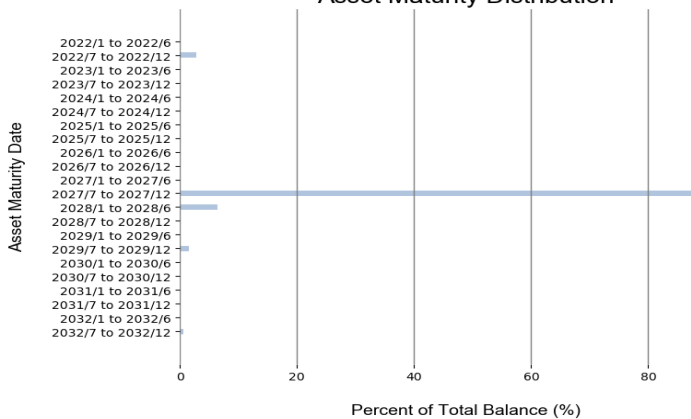
DSCR Distribution (x)



DSCRs ranged from 0.5x to 6.0x. There are 1 assets (1.0% of total balance) with DSCR between 0.5x and 1.0x, 4 assets (3.5% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (21.5% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (36.6% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (28.7% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.9% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.0% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (5.8% of total balance) with DSCR between 5.5x and 6.0x. There are 3 assets (2.8% of total balance) that have maturity dates between 2022/7 and 2022/12, 39 assets (88.7% of total balance) that have maturity dates between 2027/7 and 2027/12, 1 assets (6.4% of total balance) that have maturity dates between 2028/1 and 2028/6, 1 assets (1.5% of total balance) that have maturity dates between 2029/7 and 2029/12 and 1 assets (0.6% of total balance) that have maturity dates between 2032/7 and 2032/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
