Transaction Summary

The transaction closed on May 31 2019 and matures in Oct 2030. The pool's current aggregate principal balance is \$1032.3 million compared to \$1037.0 million at close.

The largest loan of the pool (9.7%) is secured by 350 Bush Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included Twitch Interactive Inc (48.00%) and Atlassian Inc (37.47%). The second largest loan of the pool (9.7%) is secured by The Alhambra located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 81%. The major tenants included Eastern Los Angeles (12.28%) and University Of Southe (7.91%). The third largest loan of the pool (9.2%) is secured by Ford Factory located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 100%. The largest tenant was WMG Acquisition Corp (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.38% and 20 months as of 12/15/2020, respectively. There are a total of 56 loans and 248 properties in the portfolio. The appraisal LTV was approximately 52.1% compared to the Original loan to value (LTV), which was approximately 52.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.28x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.

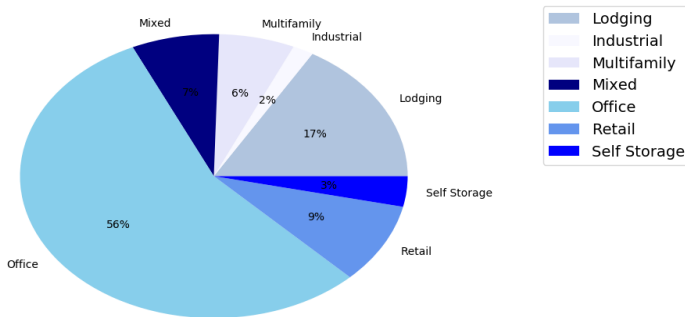

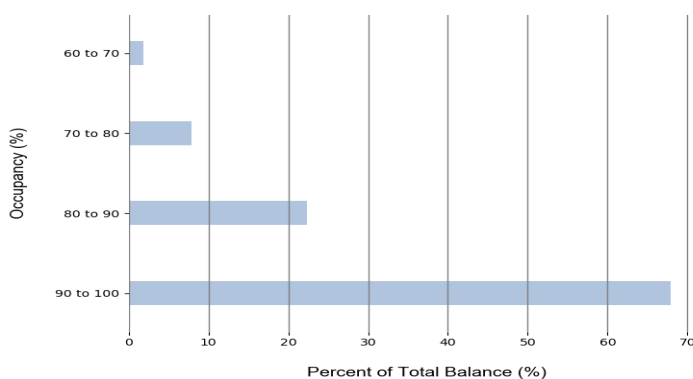

Occupancy Distribution (%)

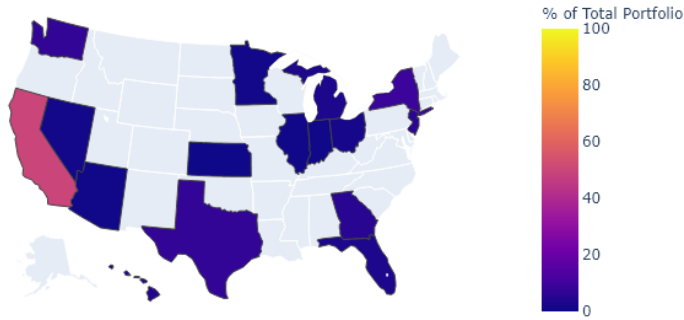

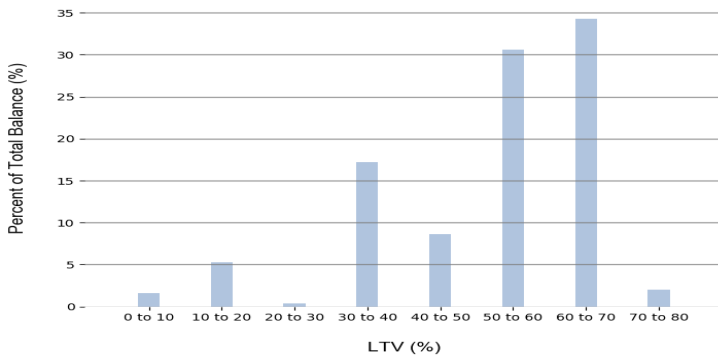
Local Distribution

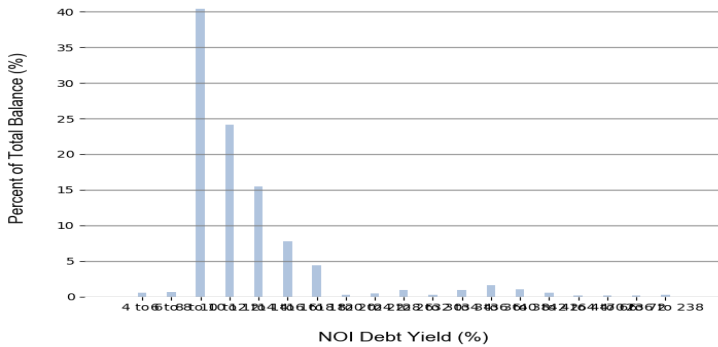

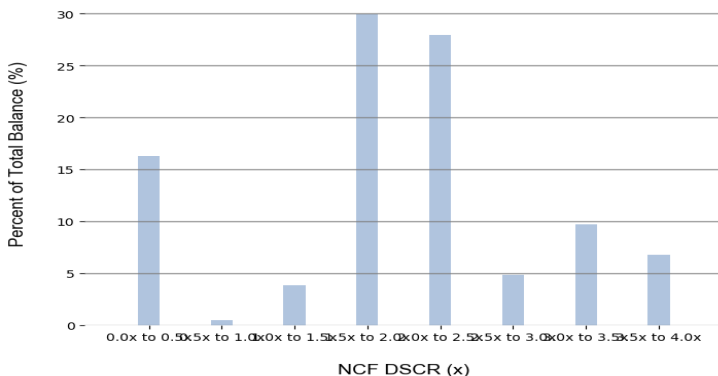
NOI Debt Yield (%)

NCF DSCR

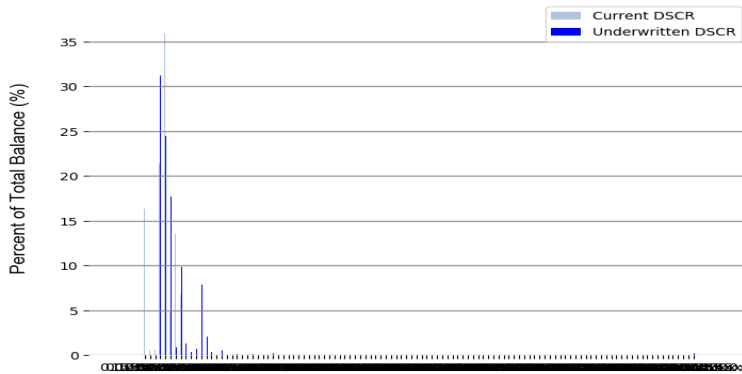
Net Cash Flow DSCR (x)

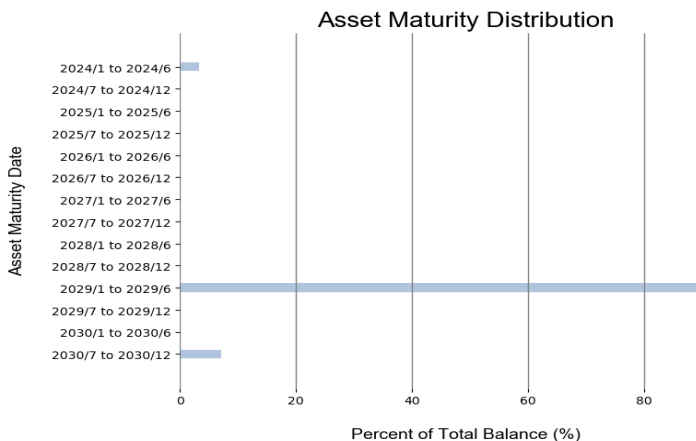

DSCRs ranged from 0.0x to 4.0x. There are 21 assets (16.3% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 1 assets (0.6% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (21.4% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (35.9% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (4.8% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (13.6% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (6.8% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.4x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
