Transaction Summary

The transaction closed on Aug 08 2019 and matures in Jun 2034. The pool's current aggregate principal balance is \$1297.7 million compared to \$1303.1 million at close.

The largest loan of the pool (7.7%) is secured by Grand Canal Shoppes - Trust located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Venetian Casino Resort (5.55%) and The Venetian Resort (Showroom / Theater) (5.12%). The second largest loan of the pool (6.8%) is secured by Waterford Lakes Town Center located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Regal Cinemas (12.47%) and Best Buy (6.67%). The third largest loan of the pool (6.5%) is secured by 350 Bush Street located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 98%. The major tenants included Twitch Interactive Inc (48.00%) and Atlassian Inc (37.47%).








Local Distribution



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2) The credit rating was based solely upon the merits of the obligor, security, or money market instrument being rated, and
