Transaction Summary

The transaction closed on Nov 15 2019 and matures in Nov 2034. The pool's current aggregate principal balance is \$1199.1 million compared to \$1202.5 million at close.

The largest loan of the pool (9.6%) is secured by Park Tower at Transbay located in San Francisco-Redwood City-South San Francisco, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Facebook, Inc. (66.54%) and Facebook, Inc. (32.32%). The second largest loan of the pool (9.2%) is secured by 230 Park Avenue South located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Discovery Communicat (94.80%) and JPMorgan Chase (3.26%). The third largest loan of the pool (7.4%) is secured by Midtown Center - Trust located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 100%. The major tenants included Fannie Mae (82.23%) and WeWork (12.67%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.48% and 12 months as of 10/15/2020, respectively. There are a total of 58 loans and 131 properties in the portfolio. The appraisal LTV was approximately 52.8% compared to the Original loan to value (LTV), which was approximately 52.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.93x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 97%.

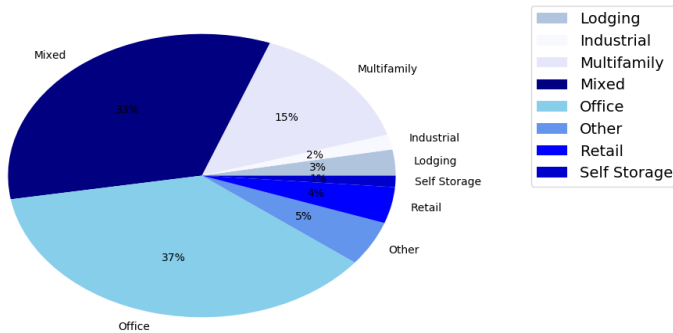

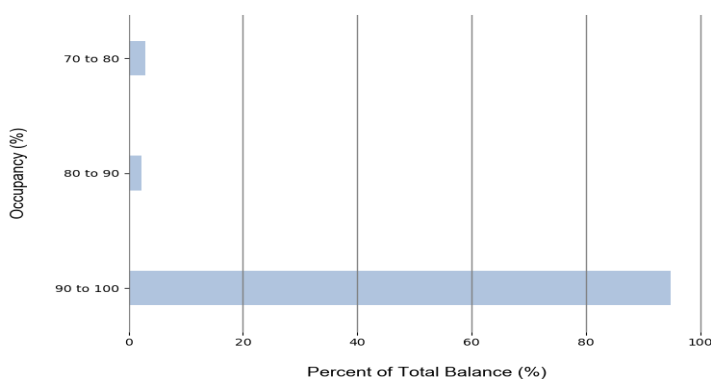

Occupancy Distribution (%)

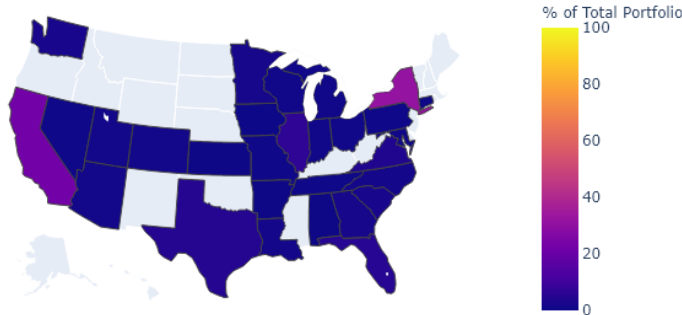

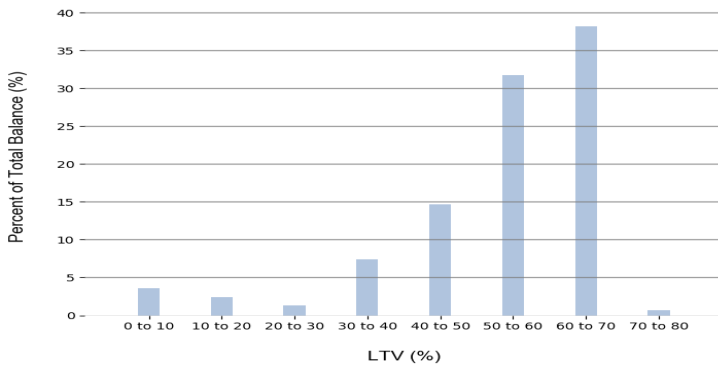
Local Distribution

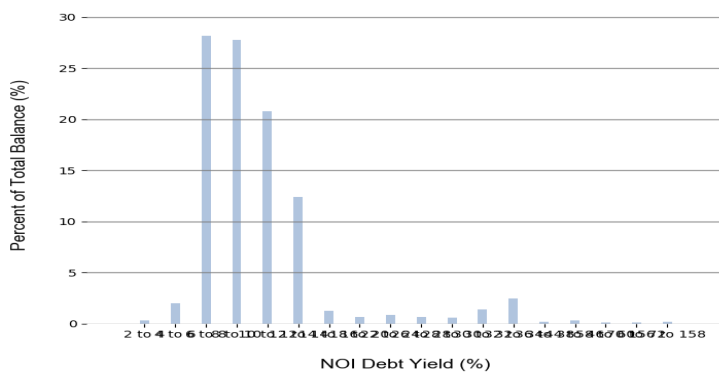

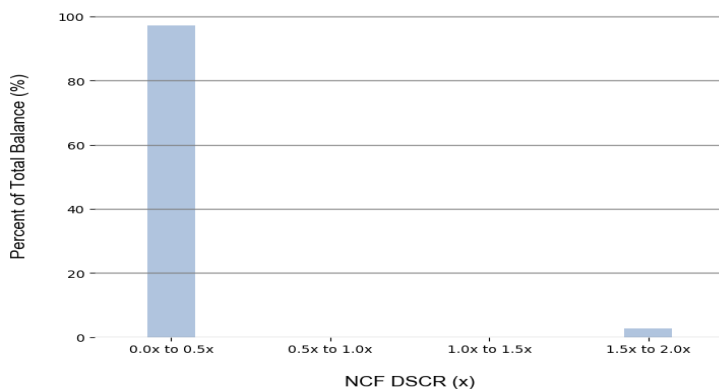
NOI Debt Yield (%)

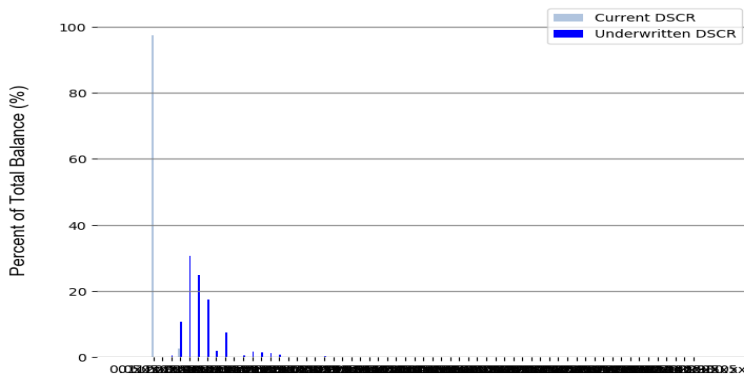
Net Cash Flow DSCR (x)

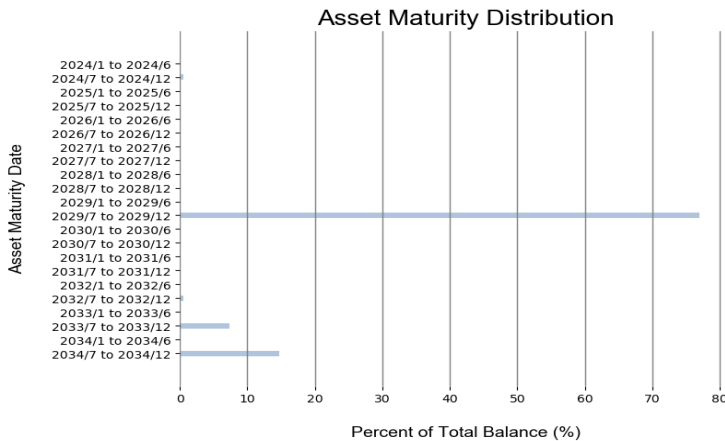

DSCRs ranged from 0.0x to 2.0x. There are 57 assets (97.3% of total balance) with DSCR between 0.0x and 0.5x and 1 assets (2.7% of total balance) with DSCR between 1.5x and 2.0x. The most recent weighted average DSCR is 2.0x.

There are 1 assets (0.5% of total balance) that have maturity dates between 2024/7 and 2024/12, 53 assets (76.9% of total balance) that have maturity dates between 2029/7 and 2029/12, 1 assets (0.5% of total balance) that have maturity dates between 2032/7 and 2032/12, 1 assets (7.4% of total balance) that have maturity dates between 2033/7 and 2033/12 and 2 assets (14.7% of total balance) that have maturity dates between 2034/7 and 2034/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
