## Transaction Summary

The transaction closed on Dec 19 2019 and matures in Aug 2034. The pool's current aggregate principal balance is \$1219.0 million compared to \$1226.0 million at close.

The largest loan of the pool (8.2%) is secured by 55 Hudson Yards - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Point72 (23.20%) and Milbank, Tweed, Hadley & McCloy (20.10%). The second largest loan of the pool (8.2%) is secured by Jackson Park - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 98%. The third largest loan of the pool (8.2%) is secured by 1412 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 79%. The major tenants included ONE STEP UP LTD (12.53%) and Jones Apparel (9.31%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 3.54% and 28 months as of 03/15/2022, respectively. There are a total of 71 loans and 104 properties in the portfolio. The appraisal LTV was approximately 52.8% compared to the Original loan to value (LTV), which was approximately 52.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.02x. As of 03/15/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.

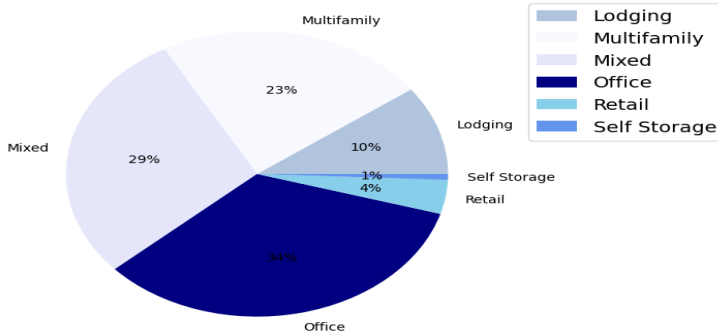

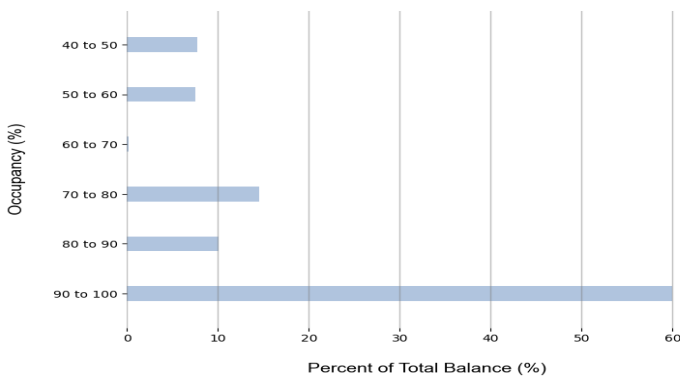

### Occupancy Distribution (%)

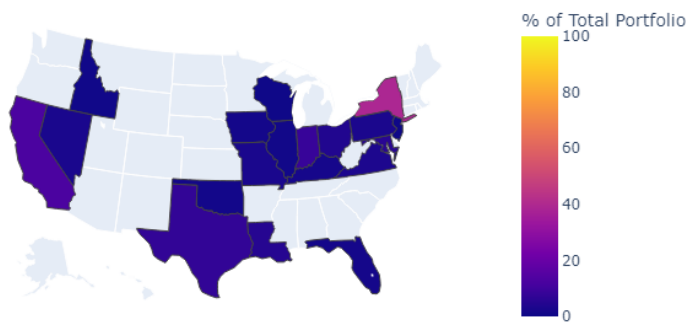

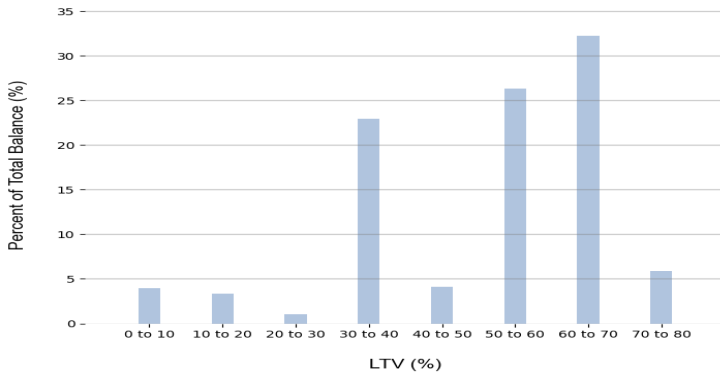
Local Distribution

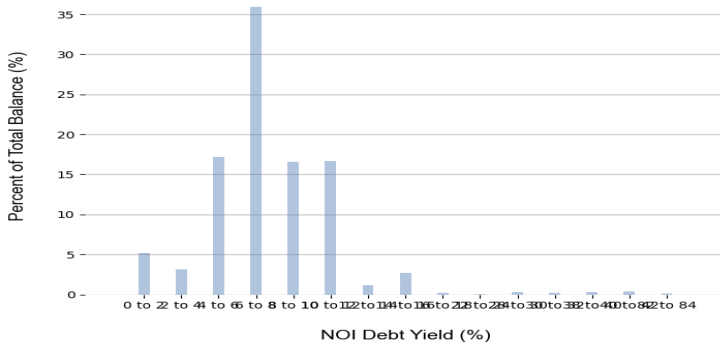

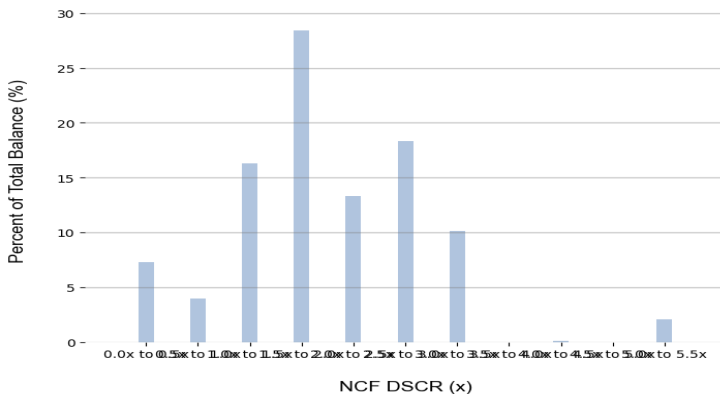
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 0% to 83% with a weighted average NOI debt yield of 7.7%. NOI debt yield ranged from 0% to 83%. 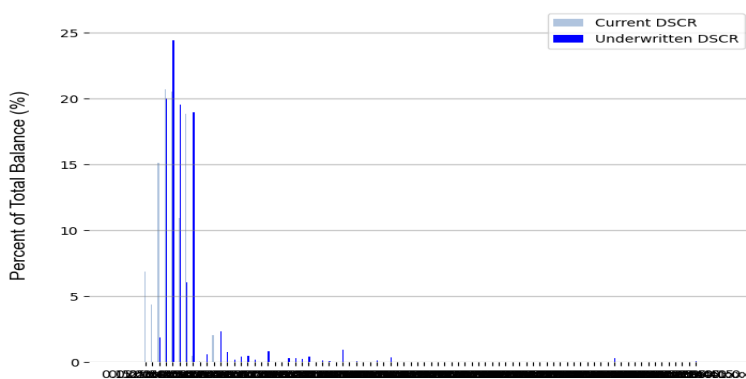
Net Cash Flow DSCR (x)

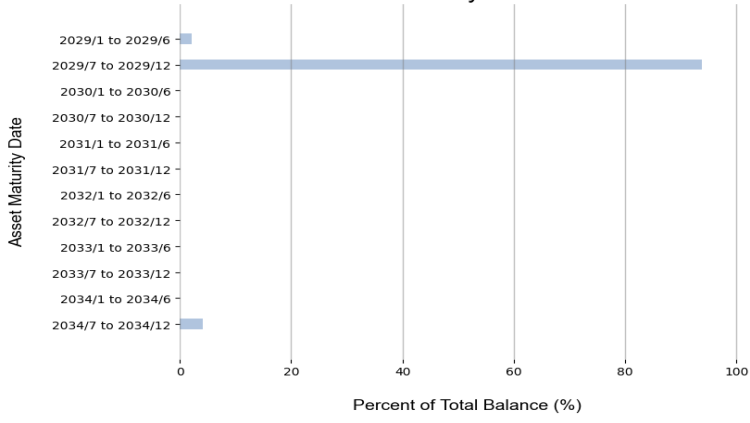
**DSCR Distribution (x)**

DSCRs ranged from 0.0x to 5.5x. There are 8 assets (6.9% of total balance) with DSCR between 0.0x and 0.5x, 9 assets (4.4% of total balance) with DSCR between 0.5x and 1.0x, 15 assets (15.1% of total balance) with DSCR between 1.0x and 1.5x, 14 assets (20.7% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (20.5% of total balance) with DSCR between 2.0x and 2.5x, 10 assets (10.9% of total balance) with DSCR between 2.5x and 3.0x, 5 assets (18.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.5% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (0.1% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (2.1% of total balance) with DSCR between 5.0x and 5.5x. The most recent weighted average DSCR is 2.1x.

There are 2 assets (26.0% of total balance) that have maturity dates between 2029/1 and 2029/6, 68 assets (1142.9% of total balance) that have maturity dates between 2029/7 and 2029/12 and 1 assets (50.0% of total balance) that have maturity dates between 2034/7 and 2034/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

### **3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:**

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

### **4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:**


