## Transaction Summary

The transaction closed on Aug 15 2017 and matures in Aug 2027. The pool's current aggregate principal balance is \$912.9 million compared to \$932.4 million at close.

The largest loan of the pool (11.0%) is secured by General Motors Building - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Weil, Gotshal & Manges (24.62%) and Aramis (15.07%). The second largest loan of the pool (6.6%) is secured by Olympic Tower - Trust located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included NBA Properties, Inc. (36.54%) and Richemont North America, Inc. (24.06%). The third largest loan of the pool (6.1%) is secured by AHIP Northeast Portfolio IV located in New York-Jersey City-White Plains, NY-NJ-24.62% metropolitan area. Occupancy at the subject was 82%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.20% and 42 months as of 12/15/2020, respectively. There are a total of 48 loans and 134 properties in the portfolio. The appraisal LTV was approximately 53.9% compared to the Original loan to value (LTV), which was approximately 54.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.39x. As of 12/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

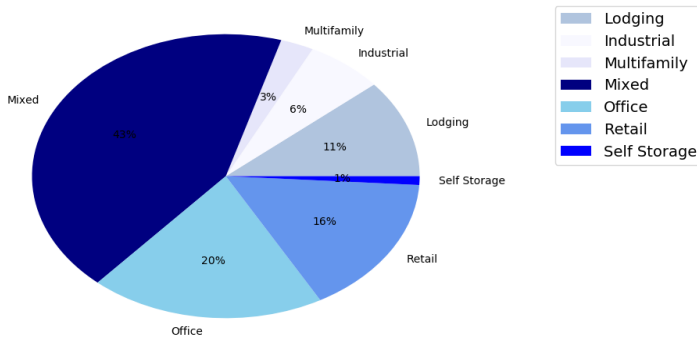

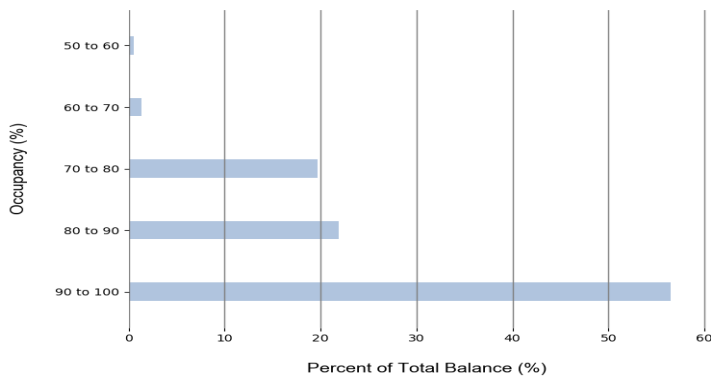

Occupancy Distribution (%)

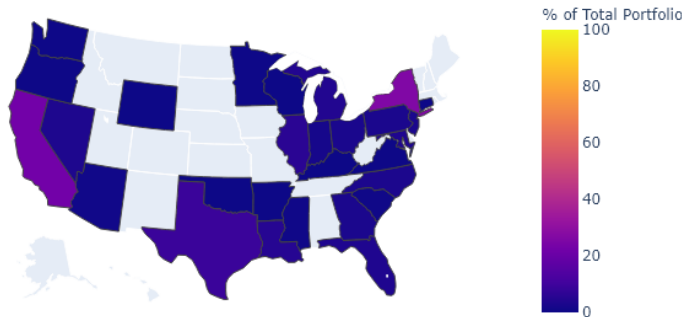

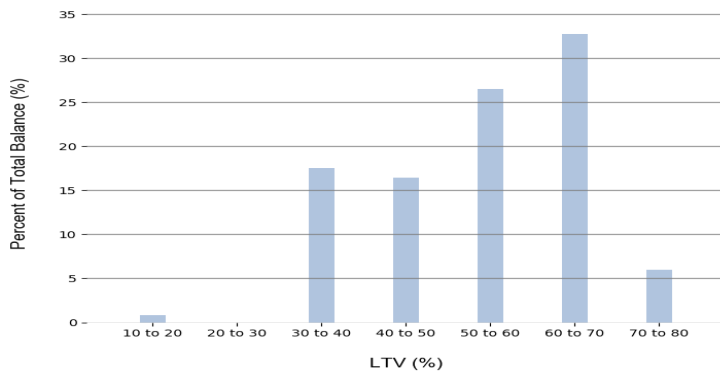
Local Distribution

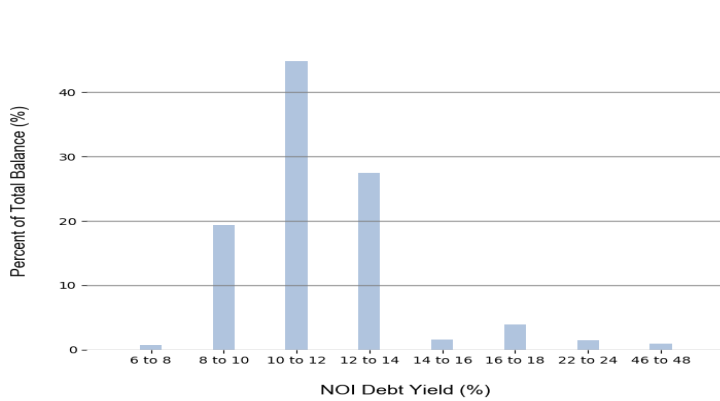

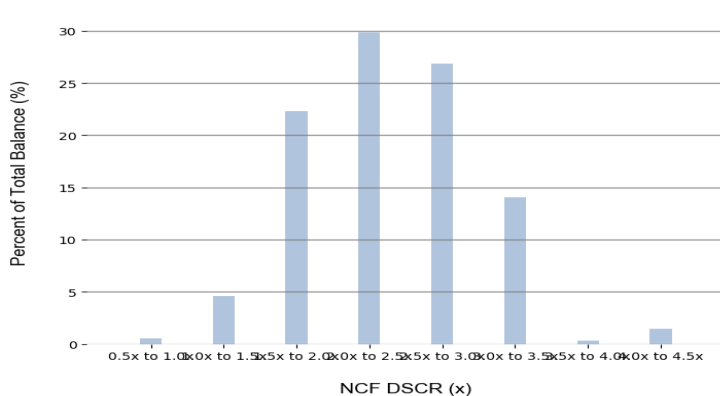
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 47% with a weighted average NOI debt yield of 12.0%. NOI debt yield ranged from 6% to 47%. There were 1 assets (1% of total balance) with NOI debt yield between 6% and 8%, 13 assets (19% of total balance) with NOI debt yield between 8% and 10%, 17 assets (45% of total balance) with NOI debt yield between 10% and 12%, 12 assets (27% of total balance) with NOI debt yield between 12% and 14%, 2 assets (2% of total balance) with NOI debt yield between 14% and 16%, 1 assets (4% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24% and 1 assets (1% of total balance) with NOI debt yield between 46% and 48%.

Net Cash Flow DSCR (x)

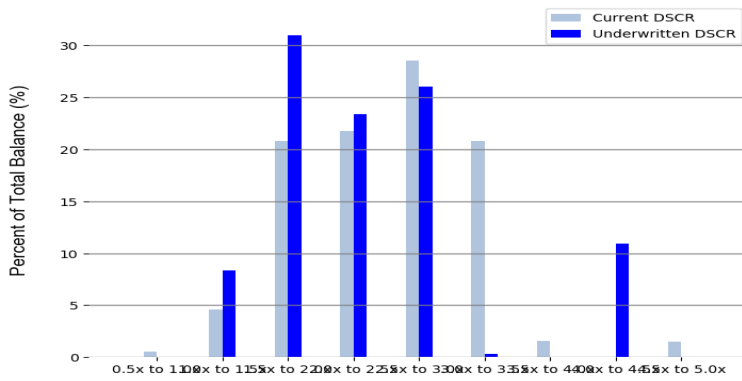


NCF DSCR ranged from 0.0x to 4.0x. 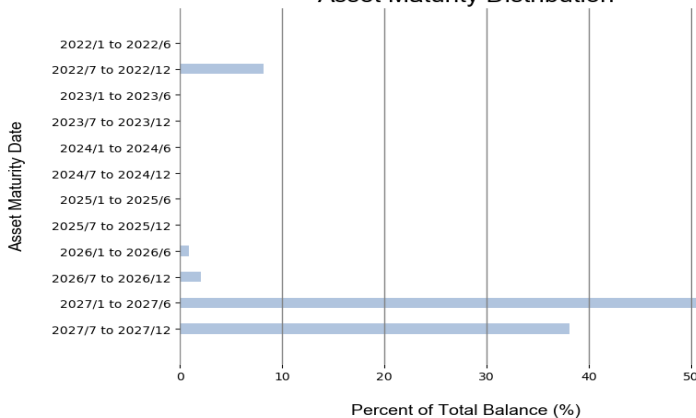
**DSCR Distribution (x)**

There are 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 6 assets (4.6% of total balance) with DSCR between 1.0x and 1.5x, 13 assets (20.8% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (21.7% of total balance) with DSCR between 2.0x and 2.5x, 9 assets (28.5% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (20.8% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (1.5% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.5% of total balance) with DSCR between 4.5x and 5.0x. There are 2 assets (8.2% of total balance) that have maturity dates between 2022/7 and 2022/12, 1 assets (0.9% of total balance) that have maturity dates between 2026/1 and 2026/6, 1 assets (2.0% of total balance) that have maturity dates between 2026/7 and 2026/12, 23 assets (50.8% of total balance) that have maturity dates between 2027/1 and 2027/6 and 21 assets (38.1% of total balance) that have maturity dates between 2027/7 and 2027/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
