Transaction Summary

The transaction closed on Oct 17 2019 and matures in Oct 2029. The pool's current aggregate principal balance is \$829.7 million compared to \$833.3 million at close.

The largest loan of the pool (8.2%) is secured by GNL Office and Industrial Portfolio located in Los Angeles-Long Beach-Glendale, CA-27.38% Detroit-Dearborn-Livonia, MI-5.25% metropolitan area. Occupancy at the subject was 100%. The major tenants included AT&T (18.29%) and Hanes Co (12.55%). The second largest loan of the pool (5.1%) is secured by Uline Arena located in Washington-Arlington-Alexandria, DC-VA-MD-WV metropolitan area. Occupancy at the subject was 76%. The major tenants included Recreational Equipment (20.60%) and RGN National Business Center (17.59%). The third largest loan of the pool (4.7%) is secured by Ocean Edge Resort & Golf Club located in metropolitan area. Occupancy at the subject was 42%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.04% and 13 months as of 10/15/2020, respectively. There are a total of 49 loans and 137 properties in the portfolio. The appraisal LTV was approximately 57.1% compared to the Original loan to value (LTV), which was approximately 56.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.86x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

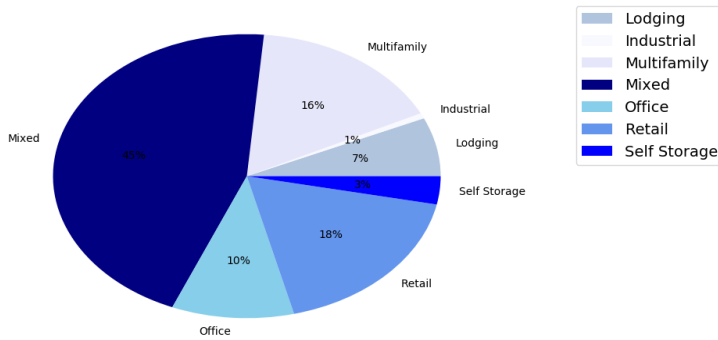

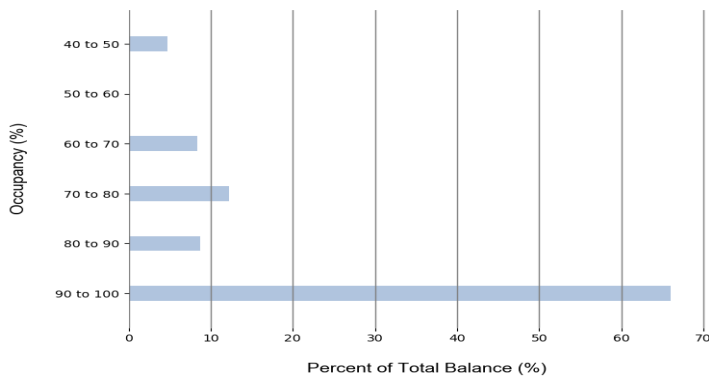

Occupancy Distribution (%)

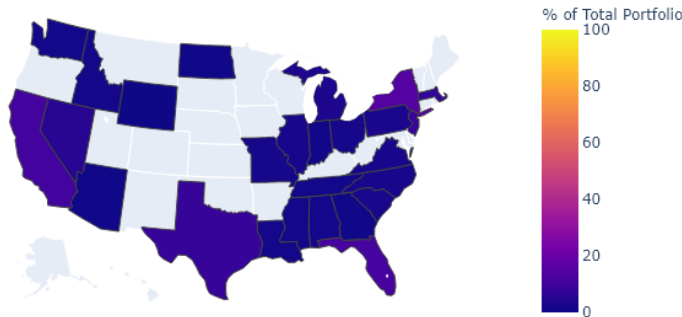

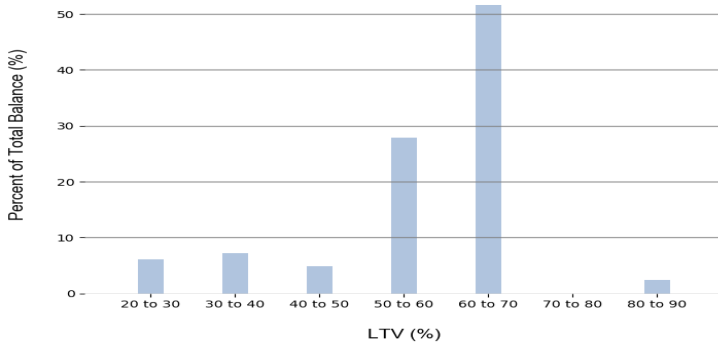
Local Distribution

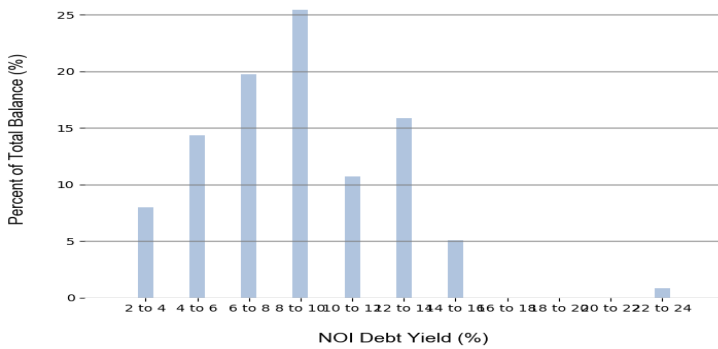

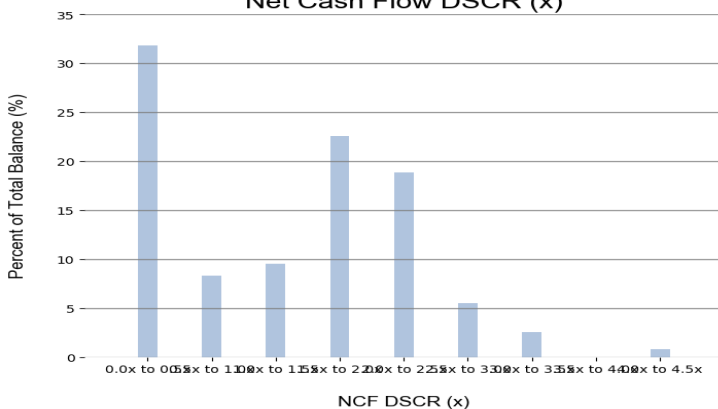
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 2% to 23% with a weighted average NOI debt yield of 9.0%. NOI debt yield ranged from 2% to 23%. There were 3 assets (8% of total balance) with NOI debt yield between 2% and 4%, 7 assets (14% of total balance) with NOI debt yield between 4% and 6%, 8 assets (20% of total balance) with NOI debt yield between 6% and 8%, 13 assets (25% of total balance) with NOI debt yield between 8% and 10%, 8 assets (11% of total balance) with NOI debt yield between 10% and 12%, 6 assets (16% of total balance) with NOI debt yield between 12% and 14%, 3 assets (5% of total balance) with NOI debt yield between 14% and 16%, 1 assets (1% of total balance) with NOI debt yield between 22% and 24%

Net Cash Flow DSCR (x)

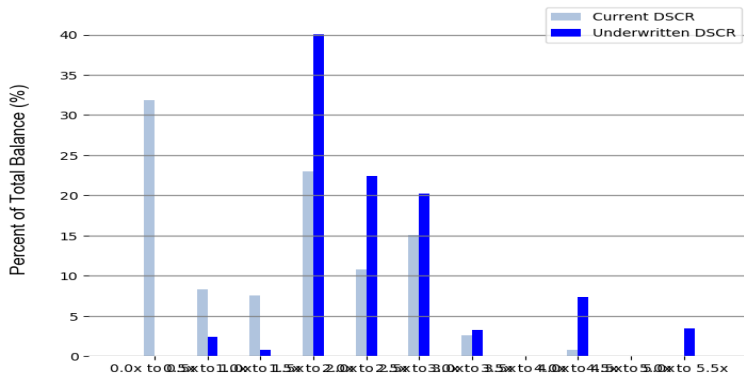


NCF DSCR ranged from 0.0x to 4.0x. There were 20 assets (31.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 4 assets (8.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 4 assets (9.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 8 assets (22.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (18.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (5.5% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (2.6% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.8% of total balance) with NCF DSCR between 4.0x and 4.5x. 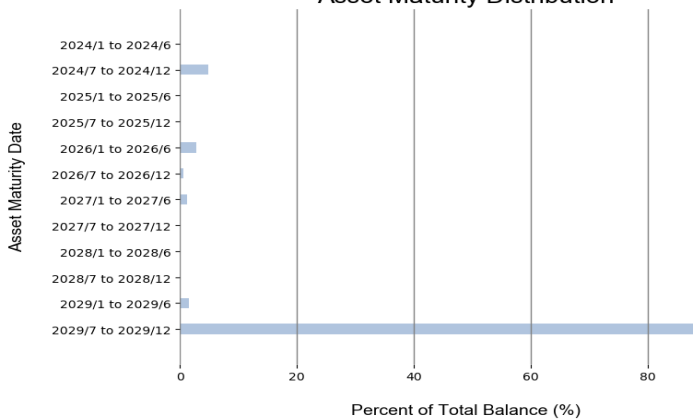
DSCR Distribution (x)

There are 20 assets (31.9% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (8.3% of total balance) with DSCR between 0.5x and 1.0x, 3 assets (7.6% of total balance) with DSCR between 1.0x and 1.5x, 8 assets (23.0% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (10.8% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (15.0% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.6% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.8% of total balance) with DSCR between 4.0x and 4.5x. The most recent weighted average DSCR is 2.0x.

There are 4 assets (4.9% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (2.9% of total balance) that have maturity dates between 2026/1 and 2026/6, 1 assets (0.6% of total balance) that have maturity dates between 2026/7 and 2026/12, 1 assets (1.3% of total balance) that have maturity dates between 2027/1 and 2027/6, 2 assets (1.6% of total balance) that have maturity dates between 2029/1 and 2029/6 and 40 assets (88.7% of total balance) that have maturity dates between 2029/7 and 2029/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
