Transaction Summary

The transaction closed on Jun 08 2017 and matures in May 2032. The pool's current aggregate principal balance is \$623.0 million compared to \$639.1 million at close.

The largest loan of the pool (8.8%) is secured by Ohio Valley Plaza located in metropolitan area. Occupancy at the subject was 99%. The major tenants included Walmart (30.51%) and Lowe's Home Improvement (19.84%). The second largest loan of the pool (7.1%) is secured by Pershing Square Building located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 94%. The major tenants included Instride/Attainment Holdco (12.08%) and Pershing Hill LLC Perch (9.76%). The third largest loan of the pool (6.5%) is secured by Crossings at Hobart located in Gary, IN metropolitan area. Occupancy at the subject was 100%. The major tenants included Walmart (26.72%) and Burlington Coat Factory (13.31%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.01% and 43 months as of 10/15/2020, respectively. There are a total of 42 loans and 66 properties in the portfolio. The appraisal LTV was approximately 58.8% compared to the Original loan to value (LTV), which was approximately 60.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.79x. As of 10/15/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

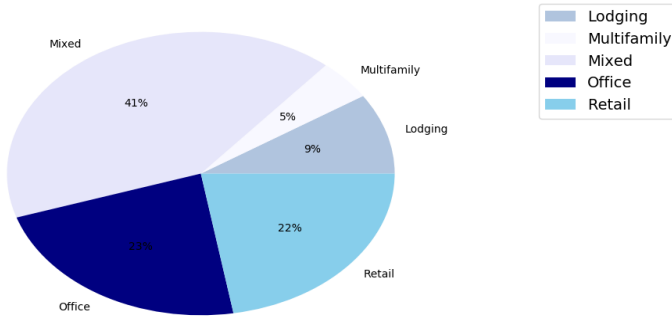

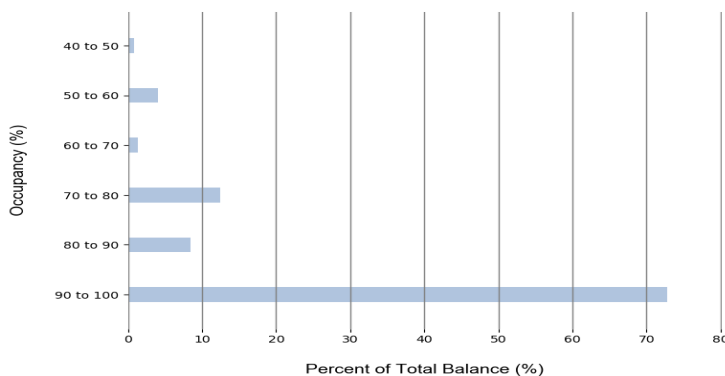

Occupancy Distribution (%)

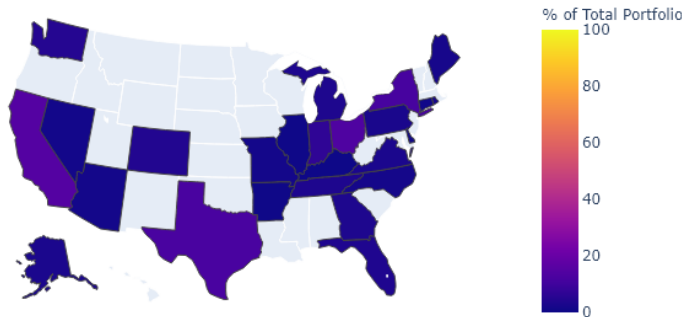

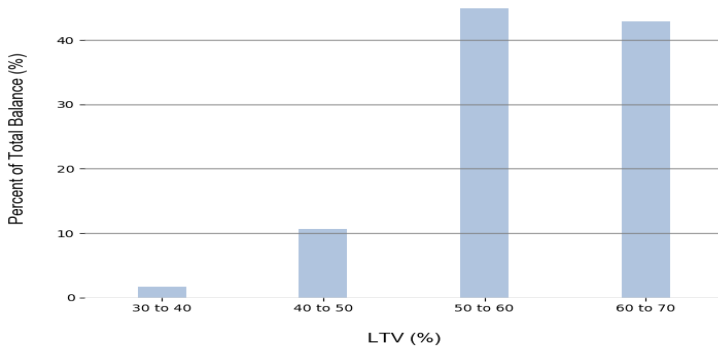
Local Distribution

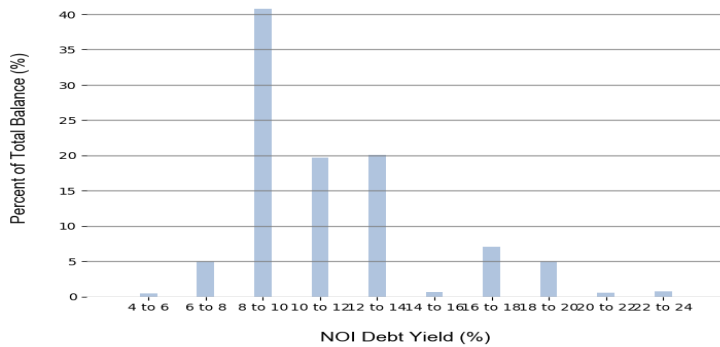

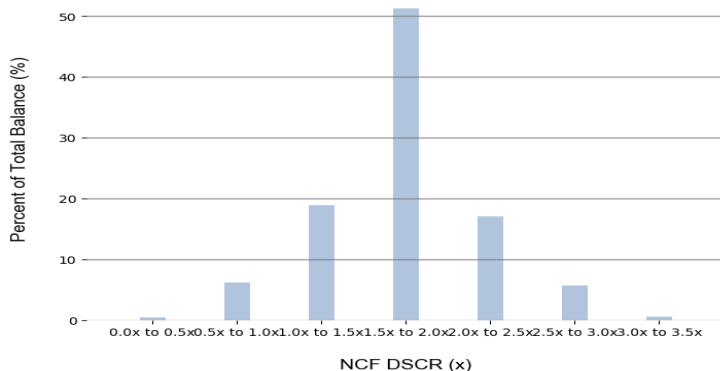
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 23% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 4% to 23%. Net Cash Flow DSCR (x)

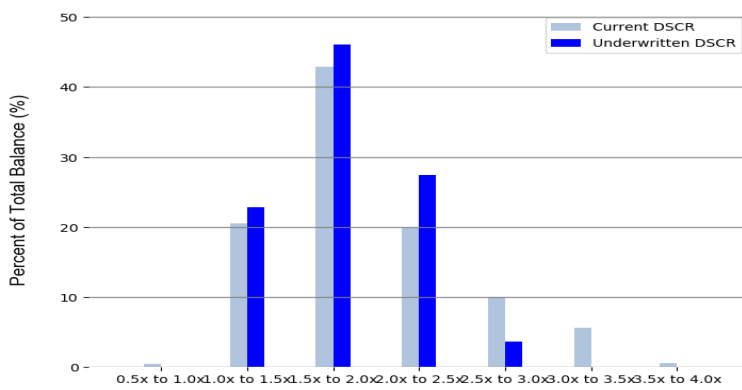

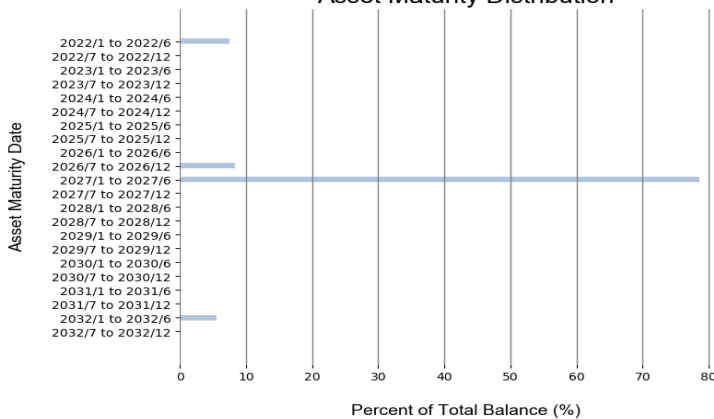
DSCR Distribution (x)



DSCRs ranged from 0.5x to 4.0x. There are 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (20.5% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (42.9% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (20.0% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (10.0% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (5.6% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.5% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.9x.

There are 3 assets (7.5% of total balance) that have maturity dates between 2022/1 and 2022/6, 4 assets (8.4% of total balance) that have maturity dates between 2026/7 and 2026/12, 34 assets (78.5% of total balance) that have maturity dates between 2027/1 and 2027/6 and 1 assets (5.6% of total balance) that have maturity dates between 2032/1 and 2032/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
