Transaction Summary

The transaction closed on Oct 04 2012 and matures in Oct 2022. The pool's current aggregate principal balance is \$221.5 million compared to \$259.0 million at close.

The largest loan of the pool (45.7%) is secured by The Oaks Mall located in Gainesville, FL. Occupancy at the subject was 96%. The major tenants included UF Health The Oaks (15.01%) and JC Penney (14.74%). The second largest loan of the pool (54.3%) is secured by Westroads Mall located in Omaha-Council Bluffs, NE-IA. Occupancy at the subject was 89%. The major tenants included Dick's Clothing and Sporting Goods (7.92%) and AMC Cinema (6.84%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.22% and 96 months as of 10/05/2020, respectively. There are a total of 2 loans and 2 properties in the portfolio. The appraisal LTV was approximately 47.4% compared to the Original loan to value (LTV), which was approximately 55.4%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.57x. As of 10/05/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.

The 2 properties are all retail buildings with a balance of \$221M, which amounted to 100% of total portfolio.

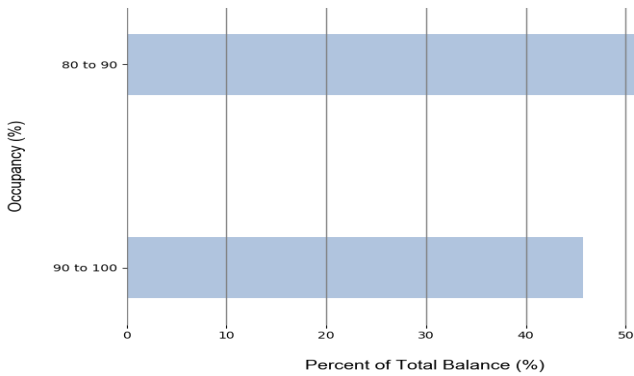

Occupancy Distribution (%)

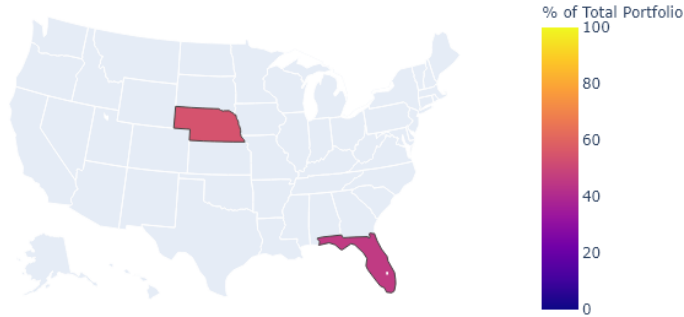

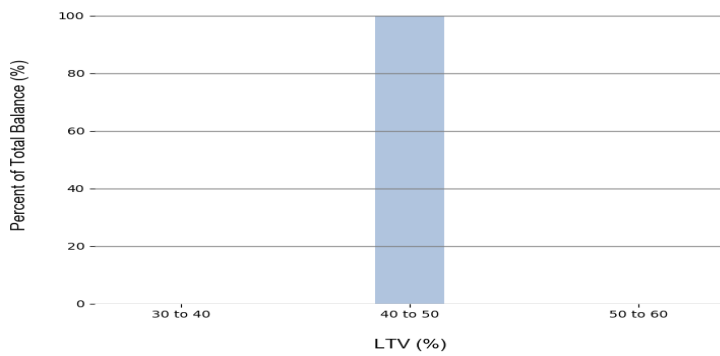
Local Distribution

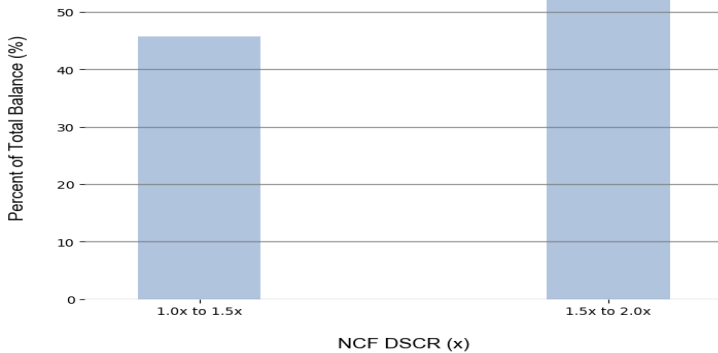
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

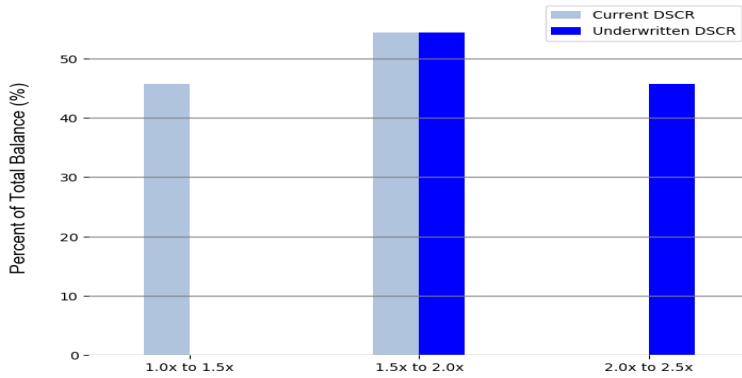


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 2.0x. There were 1 assets (45.7% of total balance) with NCF DSCR between 1.0x and 1.5x and 1 assets (54.3% of total balance) with NCF DSCR between 1.5x and 2.0x. The most recent weighted average NCF DSCR was 1.6x.

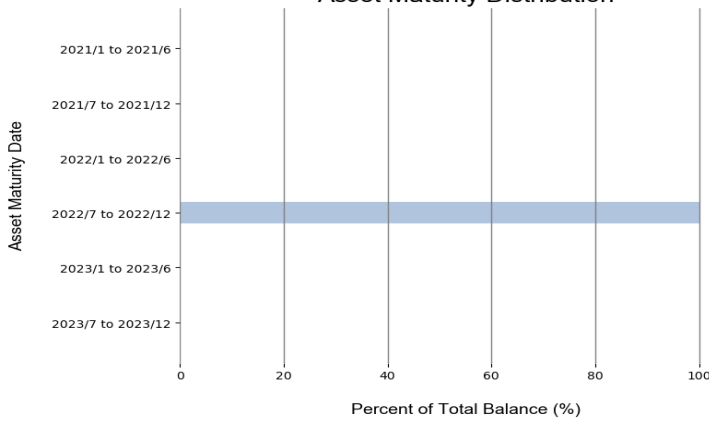
DSCR Distribution (x)

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1a and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v1.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:
