Transaction Summary

The transaction closed on Dec 19 2014 and matures in Dec 2024. The pool's current aggregate principal balance is \$642.4 million compared to \$692.8 million at close.

The largest loan of the pool (12.5%) is secured by One Memorial located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 99%. The major tenants included INTERSYSTEMS CORP (64.06%) and Microsoft (42.32%). The second largest loan of the pool (9.3%) is secured by Loews Miami Beach Hotel located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 91%. The third largest loan of the pool (7.5%) is secured by King's Shops located in metropolitan area. Occupancy at the subject was 78%. The major tenants included ROY'S WAIKOLOA BAR & GRILL (7.24%) and FOSTER'S KITCHEN (6.18%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.44% and 89 months as of 04/10/2022, respectively. There are a total of 51 loans and 66 properties in the portfolio. The appraisal LTV was approximately 69.0% compared to the Original loan to value (LTV), which was approximately 65.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.49x. As of 04/10/2022, 1.56% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.

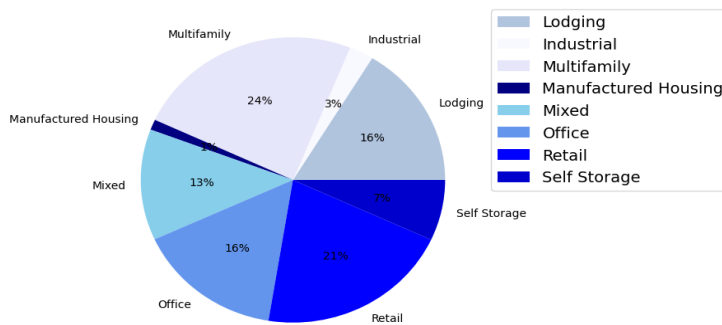

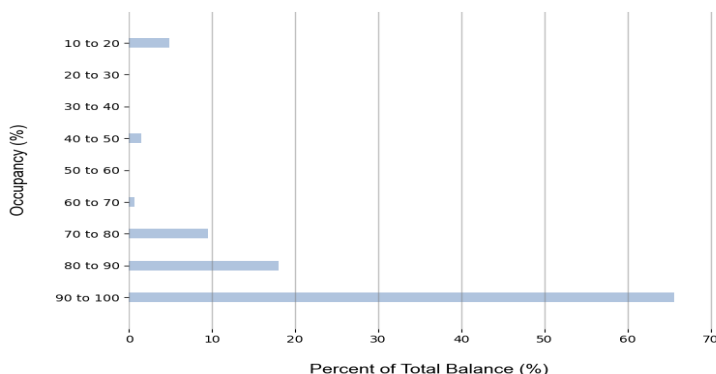

Occupancy Distribution (%)

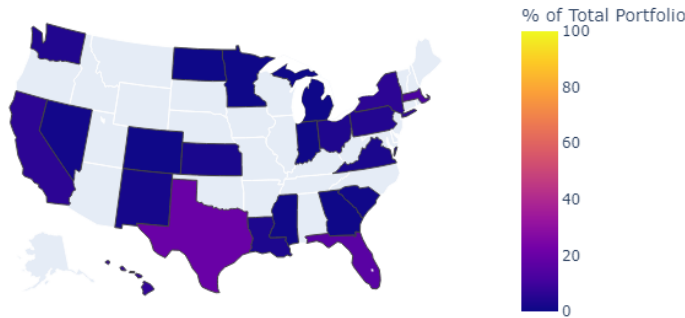

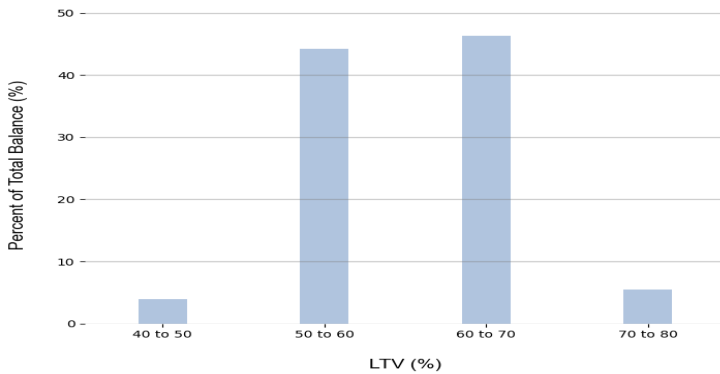
Local Distribution



Among assets in the portfolio, there are 14 properties (20% of total balance) located in Texas, 5 properties (16% of total balance) in Florida, 1 property (12% of total balance) in Massachusetts, 1 property (7% of total balance) in Hawaii, 2 properties (6% of total balance) in New York, 4 properties (6% of total balance) in California, 2 properties (4% of total balance) in Pennsylvania and 4 properties (4% of total balance) in Washington. 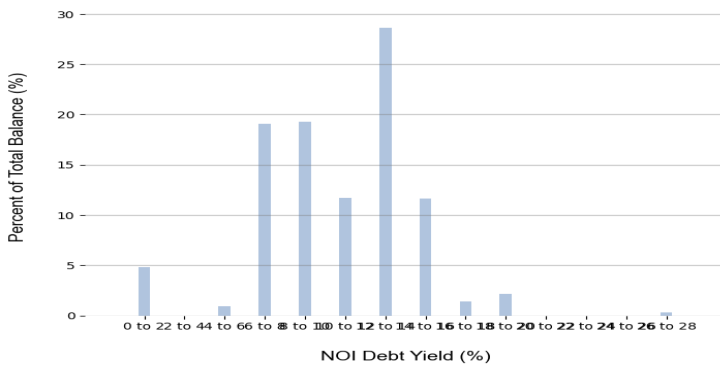

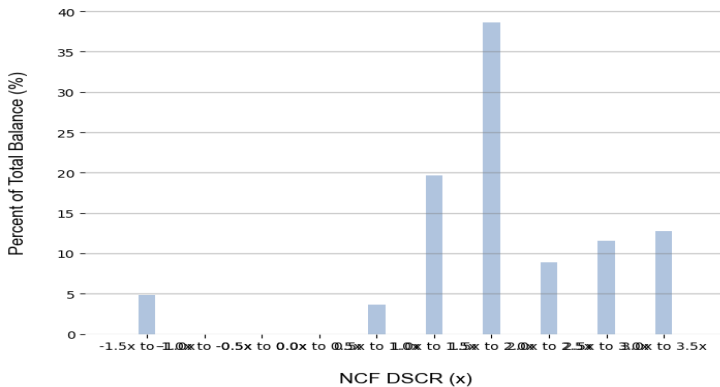
NOI Debt Yield (%)

Net Cash Flow DSCR (x)

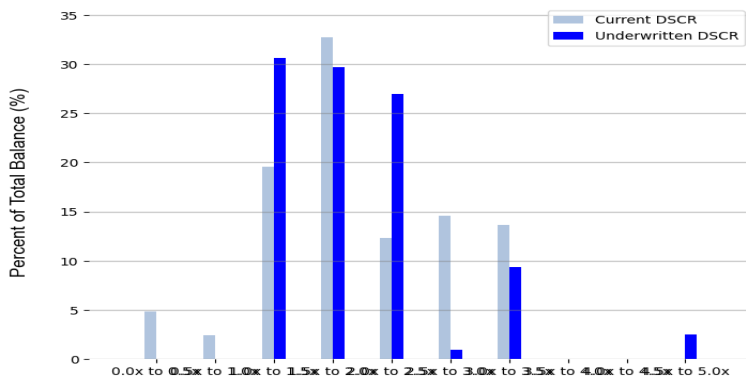

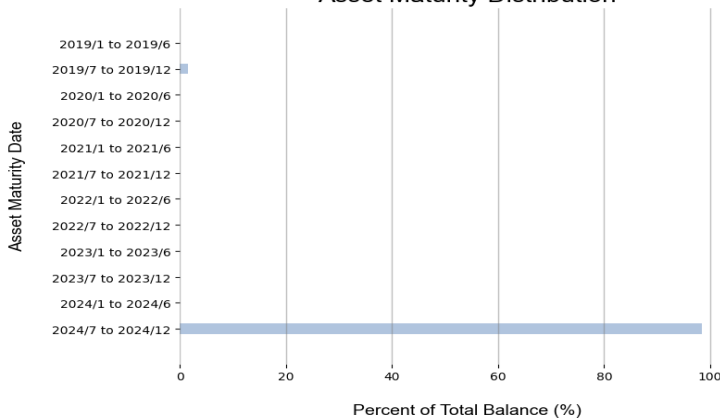
DSCR Distribution (x)



DSCRs ranged from 0.0x to 3.5x. There are 1 assets (4.8% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.4% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (19.5% of total balance) with DSCR between 1.0x and 1.5x, 19 assets (32.7% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (12.3% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (14.6% of total balance) with DSCR between 2.5x and 3.0x and 3 assets (13.6% of total balance) with DSCR between 3.0x and 3.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


