Transaction Summary

The transaction closed on Mar 25 2014 and matures in Mar 2039. The pool's current aggregate principal balance is \$620.5 million compared to \$706.8 million at close.

The largest loan of the pool (12.5%) is secured by One Kendall Square located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 95%. The major tenants included Bill & Melinda Gates Medical Research (9.09%) and Ipsen Bioscience Inc (7.94%). The second largest loan of the pool (10.6%) is secured by WRS Retail Portfolio located in metropolitan area. Occupancy at the subject was 84%. The major tenants included Dollar Tree Stores (17.26%) and CHOA (3.35%). The third largest loan of the pool (8.3%) is secured by Akers Mill Square located in metropolitan area. Occupancy at the subject was 88%. The major tenants included Hobby Lobby (15.28%) and LA Fitness (12.85%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.05% and 97 months as of 03/10/2022, respectively. There are a total of 38 loans and 186 properties in the portfolio. The appraisal LTV was approximately 60.7% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.49x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.



Type Concentration







EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
