## **Transaction Summary**

The transaction closed on Mar 25 2014 and matures in Mar 2039. The pool's current aggregate principal balance is \$619.3 million compared to \$706.8 million at close.

The largest loan of the pool (12.5%) is secured by One Kendall Square located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 95%. The major tenants included Bill & Melinda Gates Medical Research (9.09%) and Ipsen Bioscience Inc (7.94%). The second largest loan of the pool (10.6%) is secured by WRS Retail Portfolio located in metropolitan area. Occupancy at the subject was 88%. The major tenants included Dollar Tree Stores (17.26%) and CHOA (3.35%). The third largest loan of the pool (8.3%) is secured by Akers Mill Square located in metropolitan area. Occupancy at the subject was 88%. The major tenants included Hobby Lobby (15.28%) and LA Fitness (12.85%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.05% and 98 months as of 04/10/2022, respectively. There are a total of 38 loans and 186 properties in the portfolio. The appraisal LTV was approximately 60.4% compared to the Original loan to value (LTV), which was approximately 65.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.48x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 84%.





## Occupancy Distribution (%)















# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
