## Transaction Summary

The transaction closed on Sep 29 2014 and matures in Sep 2044. The pool's current aggregate principal balance is \$900.9 million compared to \$975.8 million at close.

The largest loan of the pool (13.3%) is secured by Loews Miami Beach Hotel located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 85%. The second largest loan of the pool (11.9%) is secured by Wilton Commercial Portfolio located in metropolitan area. Occupancy at the subject was 94%. The major tenants included Food Lion (5.42%) and Public Storage (3.54%). The third largest loan of the pool (5.4%) is secured by Myrtle Beach Marriott Resort & Spa located in metropolitan area. Occupancy at the subject was 69%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.57% and 75 months as of 12/10/2020, respectively. There are a total of 58 loans and 182 properties in the portfolio. The appraisal LTV was approximately 64.9% compared to the Original loan to value (LTV), which was approximately 65.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.94x. As of 12/10/2020, 2.09% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 83%.

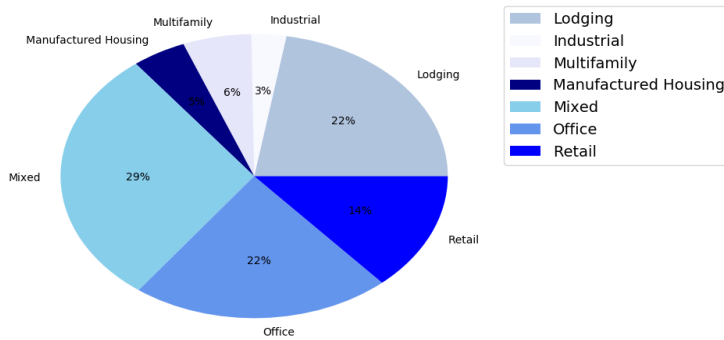

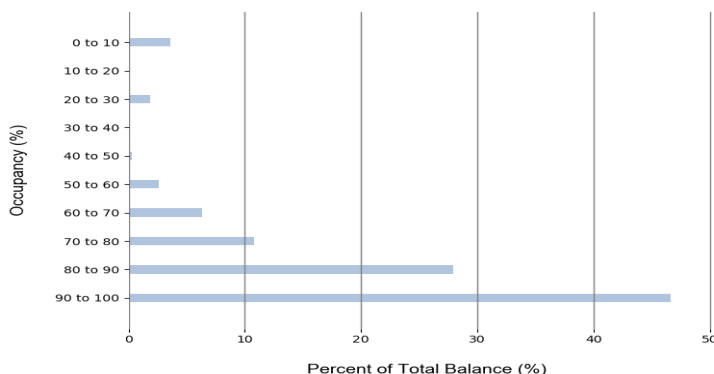

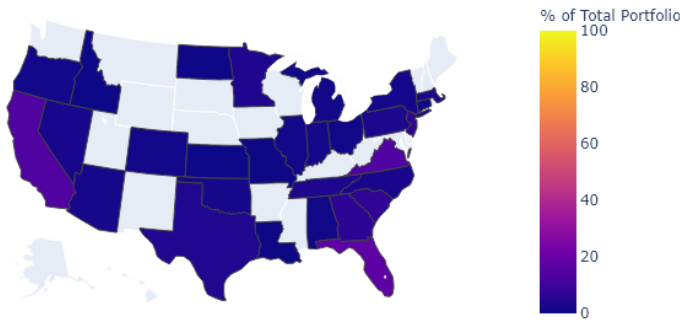

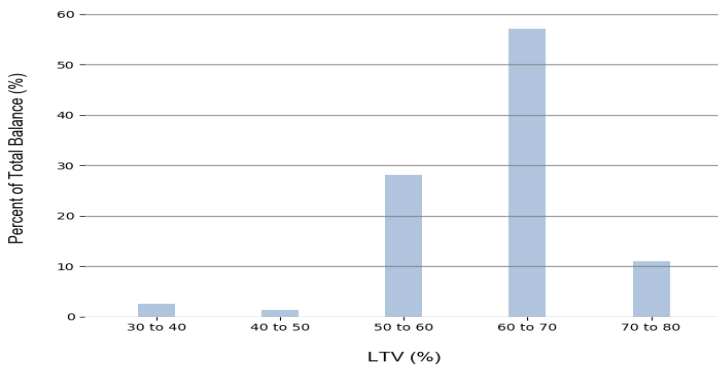
Local Distribution



Among assets in the portfolio, there are 9 properties (17% of total balance) located in Florida, 11 properties (14% of total balance) in California, 57 properties (13% of total balance) in Virginia, 3 properties (7% of total balance) in South Carolina, 3 properties (6% of total balance) in New Jersey, 12 properties (6% of total balance) in Georgia and 5 properties (4% of total balance) in Texas. Other properties are located in the state of Tennessee, Minnesota, Pennsylvania, Nevada, North Carolina, Oklahoma, Arizona, Indiana, New York, Colorado, Illinois, Oregon, Michigan, Ohio, NaN, Alabama, North Dakota, Connecticut, Louisiana, Missouri, Kansas and Idaho.

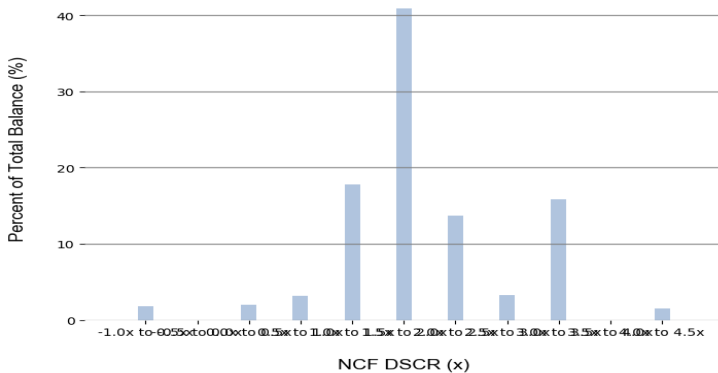
NOI Debt Yield (%)

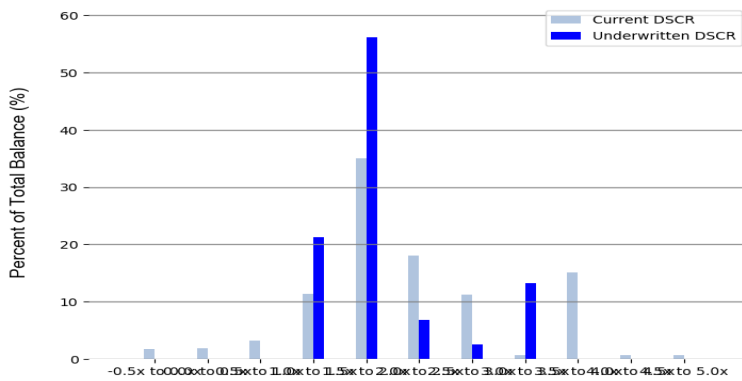
Net Cash Flow DSCR (x)

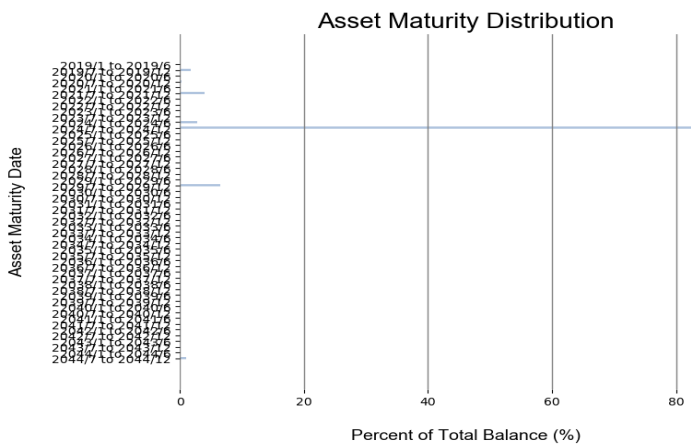

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
