Transaction Summary

The transaction closed on Mar 18 2014 and matures in Mar 2026. The pool's current aggregate principal balance is \$1012.3 million compared to \$1092.2 million at close.

The largest loan of the pool (11.4%) is secured by Google and Amazon Office Portfolio located in metropolitan area. Occupancy at the subject was 99%. The largest tenant was Google (64.76%). The second largest loan of the pool (11.3%) is secured by One Kendall Square located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 98%. The major tenants included BILL & MELINDA GATES MEDICAL R (9.09%) and IPSEN BIOSCIENCE INC (8.04%). The third largest loan of the pool (8.0%) is secured by Excelsior Crossings located in metropolitan area. Occupancy at the subject was 82%. The major tenants included USBank (37.22%) and CARGILL - 9350 EXCELSIOR (18.45%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.01% and 83 months as of 01/10/2021, respectively. There are a total of 51 loans and 60 properties in the portfolio. The appraisal LTV was approximately 63.3% compared to the Original loan to value (LTV), which was approximately 66.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.56x. As of 01/10/2021, 1.33% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.



Type Concentration















There are 3 assets (12.4% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (4.2% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (33.4% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (22.0% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (5.4% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (20.9% of total balance) with DSCR between 2.5x and 3.0x and 2 assets (1.6% of total balance) with DSCR between 3.0x and 3.5x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

Smoothing Calculation
