Transaction Summary

The transaction closed on Mar 18 2014 and matures in Mar 2026. The pool's current aggregate principal balance is \$880.6 million compared to \$988.3 million at close.

The largest loan of the pool (12.8%) is secured by Google and Amazon Office Portfolio located in metropolitan area. Occupancy at the subject was 99%. The largest tenant was Amazon.com Services LLC (33.79%). The second largest loan of the pool (12.7%) is secured by One Kendall Square located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 94%. The major tenants included BILL & MELINDA GATES MEDICAL R (9.10%) and IPSEN BIOSCIENCE INC (7.95%). The third largest loan of the pool (7.7%) is secured by Excelsior Crossings located in metropolitan area. Occupancy at the subject was 100%. The major tenants included USBank (37.22%) and ELEMENT FLEET CORPORATION (14.60%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 5.02% and 97 months as of 03/10/2022, respectively. There are a total of 49 loans and 53 properties in the portfolio. The appraisal LTV was approximately 63.5% compared to the Original loan to value (LTV), which was approximately 65.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.17x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 89%.

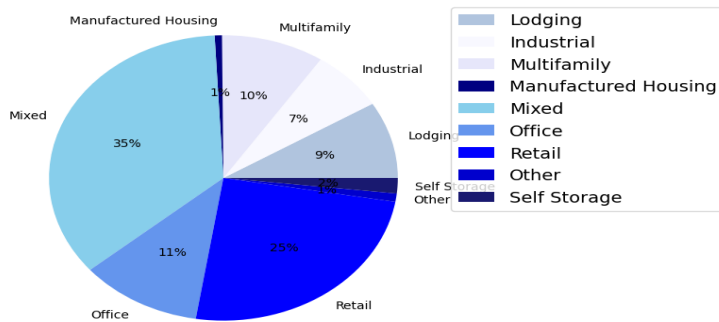

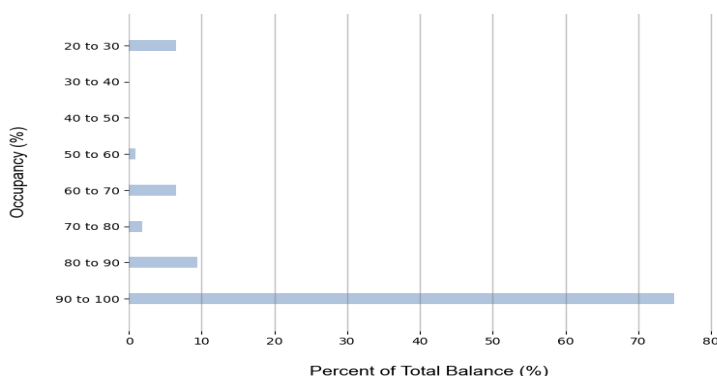

Occupancy Distribution (%)

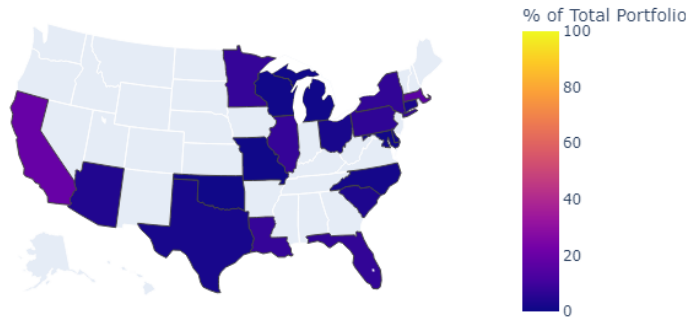

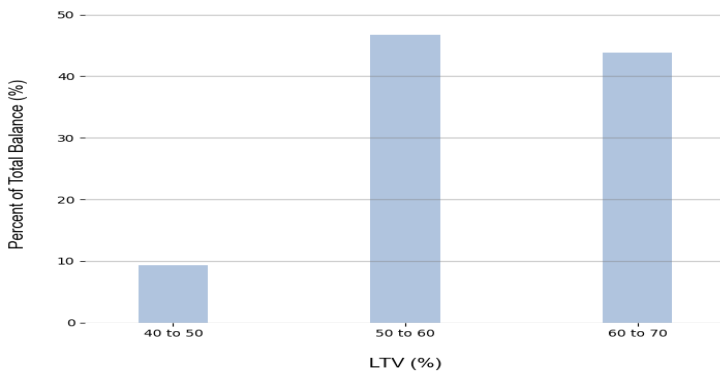
Local Distribution



Among assets in the portfolio, there are 7 properties (19% of total balance) located in California, 2 properties (16% of total balance) in Massachusetts, 5 properties (8% of total balance) in Illinois, 2 properties (8% of total balance) in Louisiana, 1 property (8% of total balance) in Minnesota, 9 properties (7% of total balance) in Florida, 4 properties (7% of total balance) in New York, 3 properties (7% of total balance) in Pennsylvania and 5 properties (4% of total balance) in Arizona. 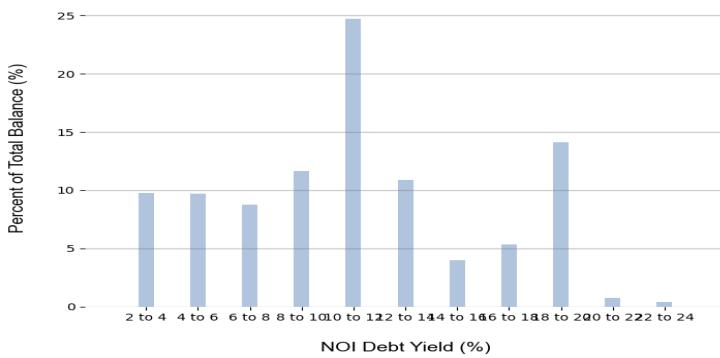

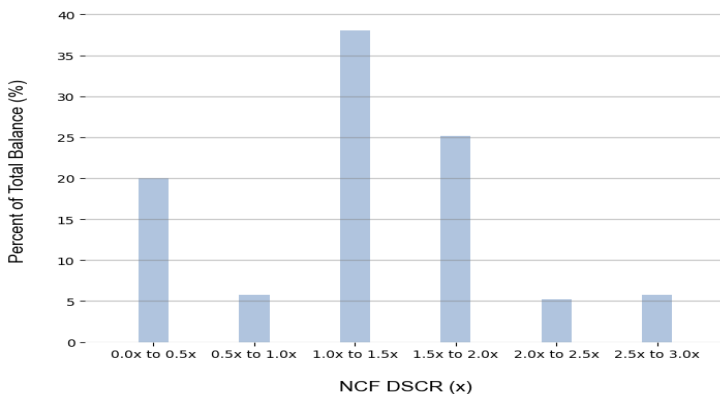
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 2% to 23% with a weighted average NOI debt yield of 10.8%. NOI debt yield ranged from 2% to 23%. Net Cash Flow DSCR (x)

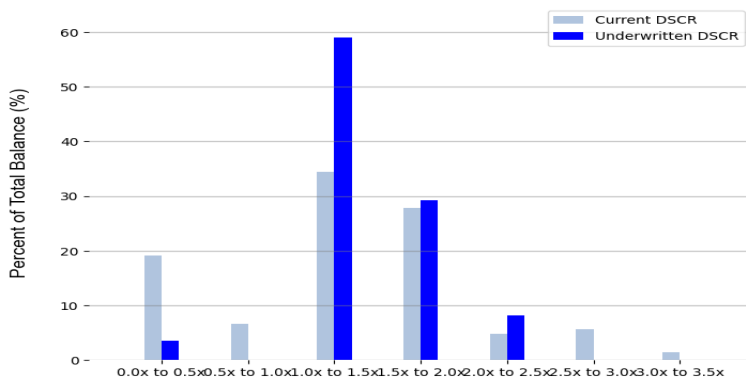


NCF DSCR ranged from 0.0x to 3.0x. There were 5 assets (20.0% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (5.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 16 assets (38.1% of total balance) with NCF DSCR between 1.0x and 1.5x, 15 assets (25.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (5.2% of total balance) with NCF DSCR between 2.0x and 2.5x and 4 assets (5.7% of total balance) with NCF DSCR between 2.5x and 3.0x. 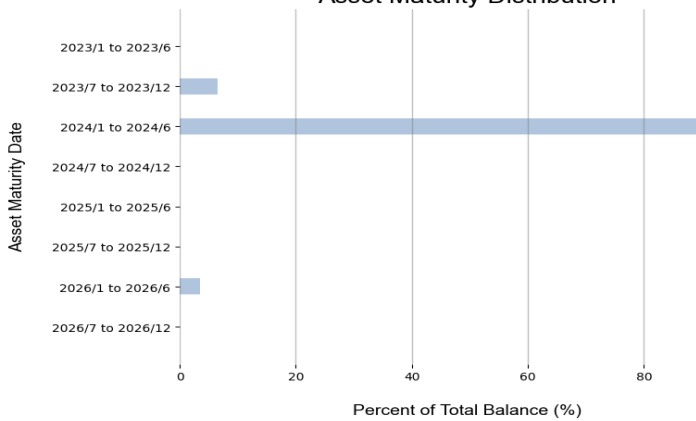
DSCR Distribution (x)



DSCRs ranged from 0.0x to 3.5x. There are 4 assets (19.1% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (6.7% of total balance) with DSCR between 0.5x and 1.0x, 12 assets (34.5% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (27.8% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (4.8% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (5.7% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (1.5% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 1.2x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.


