## Transaction Summary

The transaction closed on Jun 04 2014 and matures in Apr 2044. The pool's current aggregate principal balance is \$859.8 million compared to \$905.6 million at close.

The largest loan of the pool (12.2%) is secured by Bronx Terminal Market located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included Target (20.66%) and BJ's Wholesale Club (14.26%). The second largest loan of the pool (11.6%) is secured by State Farm Portfolio located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was State Farm Insurance Company (100.00%). The third largest loan of the pool (10.8%) is secured by Equitable Plaza located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 79%. The major tenants included COMMONWEALTH BUSINESS BANK (4.57%) and WILSHIRE BUSINESS CENTER (3.46%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.79% and 79 months as of 12/10/2020, respectively. There are a total of 41 loans and 70 properties in the portfolio. The appraisal LTV was approximately 66.3% compared to the Original loan to value (LTV), which was approximately 69.2%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.70x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.

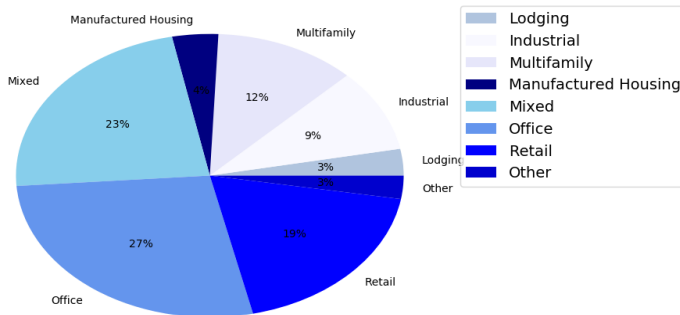

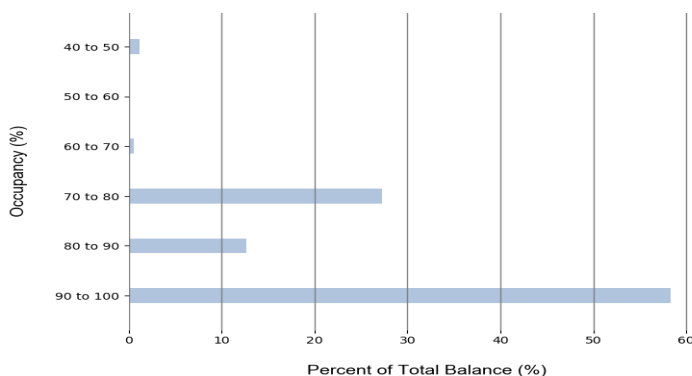

Occupancy Distribution (%)

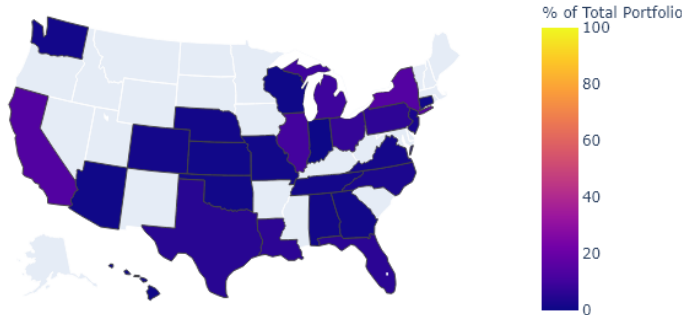

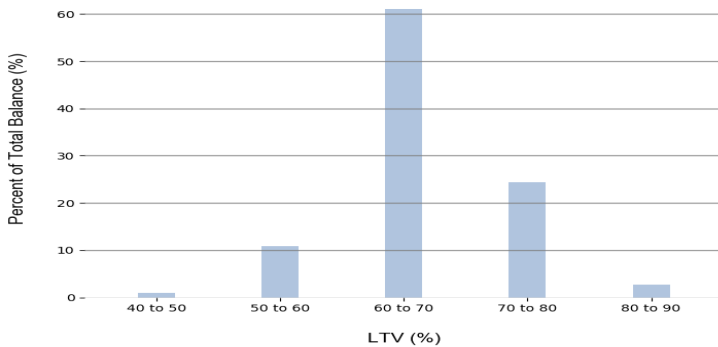
Local Distribution

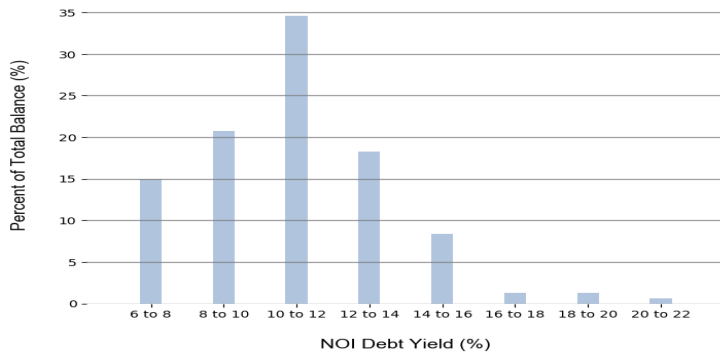

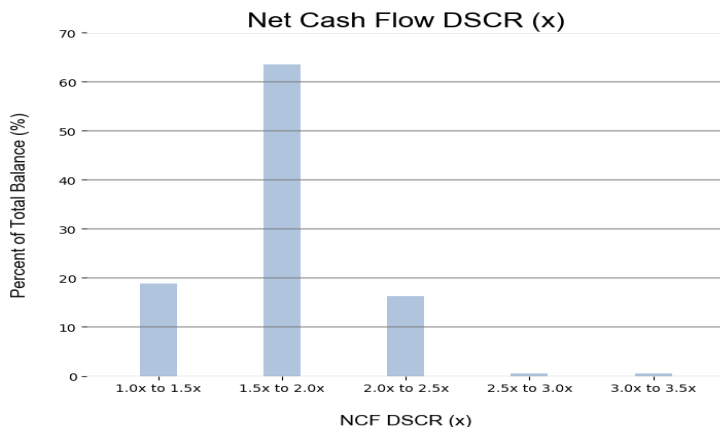

Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 11.0%. NOI debt yield ranged from 6% to 21%. There were 2 assets (15% of total balance) with NOI debt yield between 6% and 8%, 4 assets (21% of total balance) with NOI debt yield between 8% and 10%, 13 assets (35% of total balance) with NOI debt yield between 10% and 12%, 10 assets (18% of total balance) with NOI debt yield between 12% and 14%, 6 assets (8% of total balance) with NOI debt yield between 14% and 16%, 3 assets (1% of total balance) with NOI debt yield between 16% and 18%, 2 assets (1% of total balance) with NOI debt yield between 18% and 20% and 1 assets (1% of total balance) with NOI debt yield between 20% and 22%.

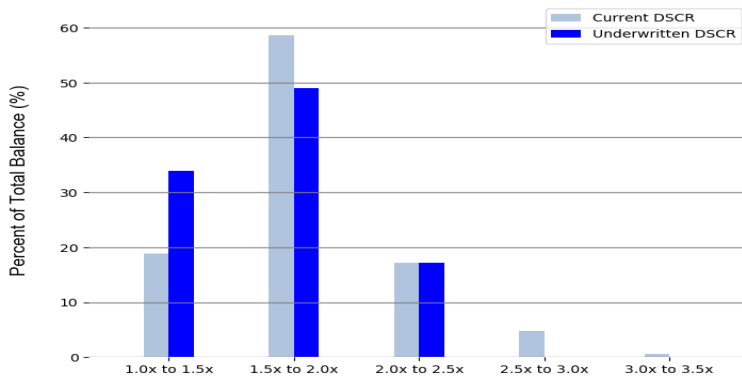


All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 3.0x. There were 10 assets (18.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 23 assets (63.6% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (16.3% of total balance) with NCF DSCR between 2.0x and 2.5x, 1 assets (0.6% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with NCF DSCR between 3.0x and 3.5x. The most recent weighted average NCF DSCR was 1.7x.

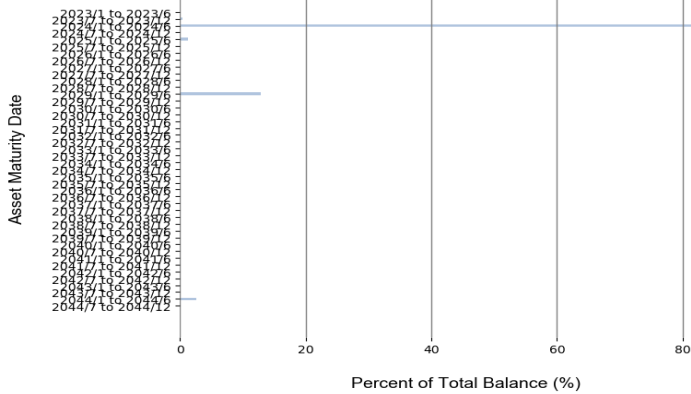
**DSCR Distribution (x)**



DSCRs ranged from 1.0x to 3.5x. There are 10 assets (18.9% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (58.6% of total balance) with DSCR between 1.5x and 2.0x, 9 assets (17.1% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (4.8% of total balance) with DSCR between 2.5x and 3.0x and 1 assets (0.6% of total balance) with DSCR between 3.0x and 3.5x. The most recent weighted average DSCR is 1.8x.

There are 1 assets (0.5% of total balance) that have maturity dates between 2023/7 and 2023/12, 35 assets (82.6% of total balance) that have maturity dates between 2024/1 and 2024/6, 1 assets (1.3% of total balance) that have maturity dates between 2025/1 and 2025/6, 3 assets (13.0% of total balance) that have maturity dates between 2029/1 and 2029/6 and 1 assets (2.6% of total balance) that have maturity dates between 2044/1 and 2044/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
