Transaction Summary

The transaction closed on Sep 23 2014 and matures in Jun 2031. The pool's current aggregate principal balance is \$1123.3 million compared to \$1190.5 million at close.

The largest loan of the pool (10.7%) is secured by Loews Miami Beach Hotel located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 85%. The second largest loan of the pool (6.5%) is secured by Canyon Ranch Portfolio located in metropolitan area. Occupancy at the subject was 54%. The third largest loan of the pool (4.9%) is secured by 30 Dunnigan located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Raymour & Flanigan Furniture (78.77%) and PAR PHARMACEUTICAL iNC (21.23%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.62% and 76 months as of 12/10/2020, respectively. There are a total of 60 loans and 81 properties in the portfolio. The appraisal LTV was approximately 75.2% compared to the Original loan to value (LTV), which was approximately 66.1%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.76x. As of 12/10/2020, 3.75% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 81%.





Occupancy Distribution (%)






Local Distribution









There are 1 assets (5.6% of total balance) with DSCR between -0.5x and 0.0x, 1 assets (2.1% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (2.7% of total balance) with DSCR between 0.5x and 1.0x, 10 assets (11.4% of total balance) with DSCR between 1.0x and 1.5x, 23 assets (36.5% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (17.9% of total balance) with DSCR between 2.0x and 2.5x, 8 assets (11.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.8% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (10.7% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
