Transaction Summary

The transaction closed on Sep 23 2014 and matures in Jun 2031. The pool's current aggregate principal balance is \$1067.6 million compared to \$1152.6 million at close.

The largest loan of the pool (11.2%) is secured by Loews Miami Beach Hotel located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 58%. The second largest loan of the pool (6.7%) is secured by Canyon Ranch Portfolio located in metropolitan area. Occupancy at the subject was 32%. The third largest loan of the pool (4.9%) is secured by 30 Dunnigan located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Raymour & Flanigan Furniture (78.77%) and PAR PHARMACEUTICAL iNC (21.23%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.63% and 91 months as of 03/10/2022, respectively. There are a total of 57 loans and 78 properties in the portfolio. The appraisal LTV was approximately 67.9% compared to the Original loan to value (LTV), which was approximately 66.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.23x. As of 03/10/2022, 1.07% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 75%.

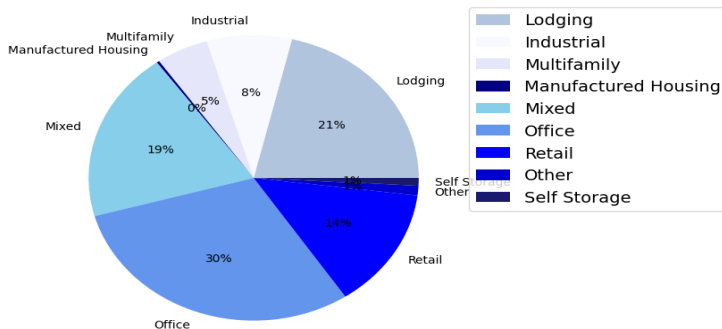

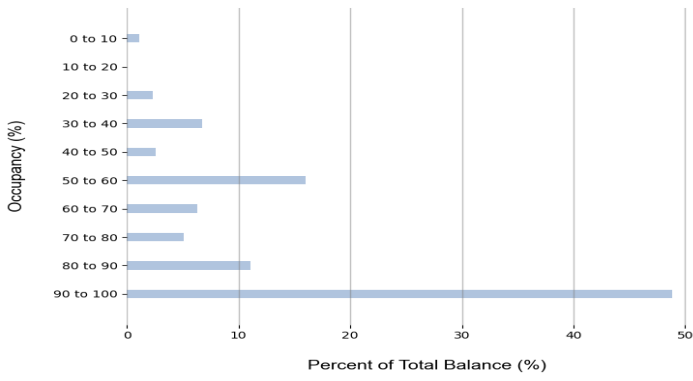

Occupancy Distribution (%)

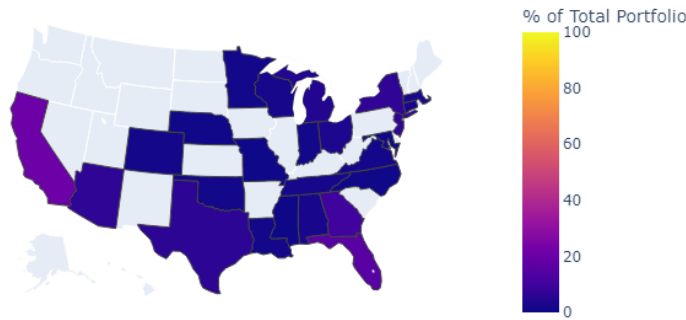

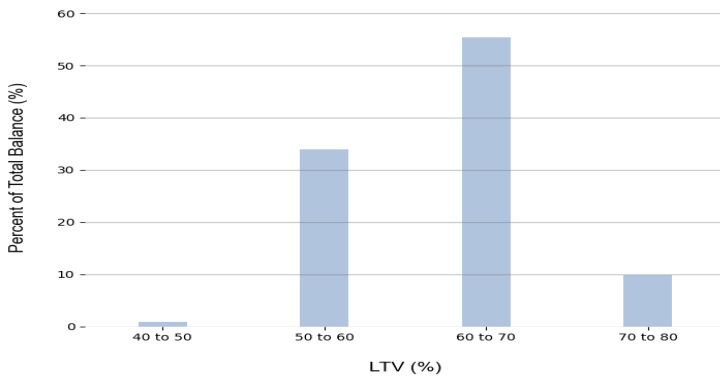
Local Distribution



Among assets in the portfolio, there are 8 properties (21% of total balance) located in California, 5 properties (16% of total balance) in Florida, 12 properties (10% of total balance) in Georgia, 3 properties (7% of total balance) in New York, 2 properties (7% of total balance) in New Jersey, 3 properties (6% of total balance) in Arizona, 9 properties (6% of total balance) in Texas, 3 properties (4% of total balance) in Michigan and 3 properties (3% of total balance) in Ohio. 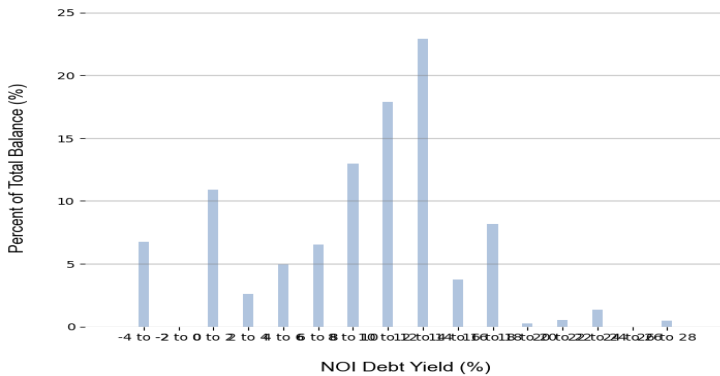

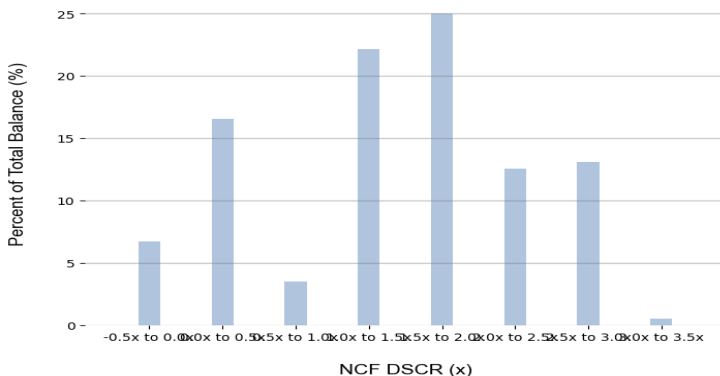
NOI Debt Yield (%)

Net Cash Flow DSCR (x)



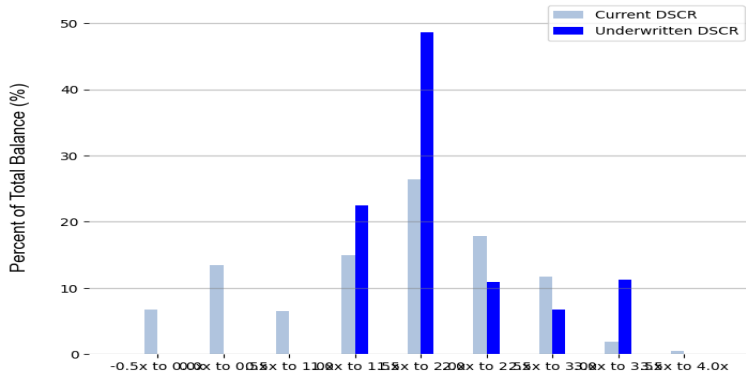

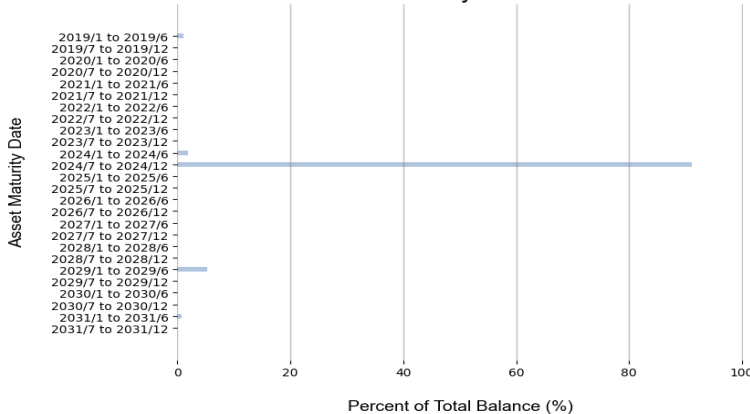
DSCR Distribution (x)



DSCRs ranged from -0.5x to 4.0x. There are 1 assets (6.7% of total balance) with DSCR between -0.5x and 0.0x, 4 assets (13.5% of total balance) with DSCR between 0.0x and 0.5x, 5 assets (6.5% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (15.0% of total balance) with DSCR between 1.0x and 1.5x, 20 assets (26.4% of total balance) with DSCR between 1.5x and 2.0x, 11 assets (17.9% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (11.7% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.9% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.5% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.4x.

There are 1 assets (11.4% of total balance) that have maturity dates between 2019/1 and 2019/6, 4 assets (19.6% of total balance) that have maturity dates between 2024/1 and 2024/6, 50 assets (972.7% of total balance) that have maturity dates between 2024/7 and 2024/12, 1 assets (55.5% of total balance) that have maturity dates between 2029/1 and 2029/6 and 1 assets (8.3% of total balance) that have maturity dates between 2031/1 and 2031/6.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:


