## **Transaction Summary**

The transaction closed on Dec 09 2014 and matures in Oct 2044. The pool's current aggregate principal balance is \$1095.0 million compared to \$1169.1 million at close.

The largest loan of the pool (9.5%) is secured by Tops & Kroger Portfolio located in metropolitan area. Occupancy at the subject was 87%. The major tenants included Tops Market (34.08%) and Kroger Supermarkets (8.37%). The second largest loan of the pool (5.1%) is secured by W Scottsdale located in metropolitan area. Occupancy at the subject was 70%. The third largest loan of the pool (4.7%) is secured by Churchill Portfolio located in Detroit-Dearborn-Livonia, MI-4.94% metropolitan area. Occupancy at the subject was 65%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.46% and 73 months as of 12/10/2020, respectively. There are a total of 79 loans and 254 properties in the portfolio. The appraisal LTV was approximately 66.9% compared to the Original loan to value (LTV), which was approximately 65.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.08x. As of 12/10/2020, 1.72% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.



Type Concentration






#### Occupancy Distribution (%)



Among assets in the portfolio, there are 14 properties (15% of total balance) located in California, 13 properties (14% of total balance) % of Total Portfolio in New York, 18 properties (8% of total balance) in Texas, 64 properties (8% of total balance) in Arizona, 49 properties (6% of total balance) in Florida, 8 properties (5% of total balance) in Alabama, 2 properties (4% of total balance) in Virginia, 3 properties (4% of total balance) in Ohio and 5 properties (4% of total balance) in Illinois. Other properties are located in the state of Illinois, Colorado, South Carolina, Michigan, Missouri, Louisiana, Nevada, Maryland,Tennessee, Georgia, North Carolina, Wisconsin, Kentucky, Oregon, Minnesota, South Dakota, Massachusetts, Maine, Utah, Nebraska, Wyoming, Mississippi, Kansas, Iowa, Connecticut, Pennsylvania and Indiana.

Among all the assets in the portfolio, 3 assets (5% of total balance) had LTVs between 30% and 40%, 7 assets (6% of total balance) with LTVs between 40% and 50%, 12 assets (9% of total balance) with LTVs between 50% and 60%, 46 assets (61% of total balance) with LTVs between 60% and 70% and 11 assets (18% of total balance) with LTVs between 70% and 80%.





Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 13.1%. NOI debt yield ranged from 4% to 25%. 



DSCRs ranged from 0.5x to 5.0x.There are 2 assets (1.2% of total balance) with DSCR between 0.5x and 1.0x, 15 assets (14.5% of total balance) with DSCR between 1.0x and 1.5x, 22 assets (27.2% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (18.2% of total balance) with DSCR between 2.0x and 2.5x, 16 assets (28.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (1.5% of total balance) with DSCR between 3.0x and 3.5x, 2 assets (1.4% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (4.2% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (3.5% of total balance) with DSCR between 4.5x and 5.0x. The most recent weighted average DSCR is 2.3x.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
