Transaction Summary

The transaction closed on Mar 25 2015 and matures in Jan 2045. The pool's current aggregate principal balance is \$1113.2 million compared to \$1170.4 million at close.

The largest loan of the pool (9.0%) is secured by 26 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included City Of New York (21.64%) and THE NYC SCHOOL CONSTR AUTH (12.68%). The second largest loan of the pool (1.9%) is secured by Wells Fargo Roanoke located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Wells Fargo Bank (100.00%). The third largest loan of the pool (1.7%) is secured by Wells Fargo Atlanta located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Wells Fargo Bank (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.13% and 68 months as of 10/10/2020, respectively. There are a total of 58 loans and 65 properties in the portfolio. The appraisal LTV was approximately 63.4% compared to the Original loan to value (LTV), which was approximately 67.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.76x. As of 10/10/2020, 5.39% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.



Type Concentration

















EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
