Transaction Summary

The transaction closed on Mar 25 2015 and matures in Jan 2045. The pool's current aggregate principal balance is \$1110.5 million compared to \$1170.4 million at close.

The largest loan of the pool (9.0%) is secured by 26 Broadway located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 92%. The major tenants included City Of New York (21.64%) and THE NYC SCHOOL CONSTR AUTH (12.68%). The second largest loan of the pool (1.9%) is secured by Wells Fargo Roanoke located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Wells Fargo Bank (100.00%). The third largest loan of the pool (1.6%) is secured by Wells Fargo Atlanta located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was Wells Fargo Bank (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.13% and 70 months as of 12/10/2020, respectively. There are a total of 58 loans and 65 properties in the portfolio. The appraisal LTV was approximately 63.2% compared to the Original loan to value (LTV), which was approximately 67.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.76x. As of 12/10/2020, 5.40% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.



Type Concentration






Occupancy Distribution (%)











EJR's Key Rating Features & Differences Compared With Other NRSROs
