Transaction Summary

The transaction closed on May 15 2015 and matures in Apr 2035. The pool's current aggregate principal balance is \$1176.4 million compared to \$1245.7 million at close.

The largest loan of the pool (10.2%) is secured by 9200 & 9220 Sunset located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 93%. The major tenants included S&F Management Company (8.34%) and SoHo House (6.81%). The second largest loan of the pool (7.8%) is secured by DFW / Raleigh Portfolio located in Fort Worth-Arlington, TX-100.00% metropolitan area. Occupancy at the subject was 91%. The third largest loan of the pool (7.7%) is secured by 3 Columbus Circle located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included Y&R (30.31%) and Emerge212 (10.91%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.31% and 69 months as of 12/10/2020, respectively. There are a total of 79 loans and 121 properties in the portfolio. The appraisal LTV was approximately 66.1% compared to the Original loan to value (LTV), which was approximately 66.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.79x. As of 12/10/2020, 3.37% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

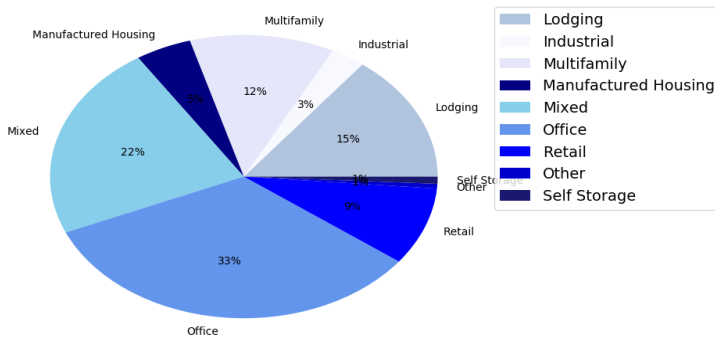

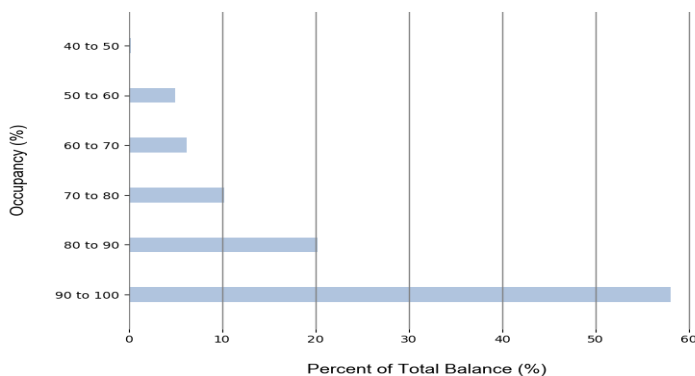

Occupancy Distribution (%)

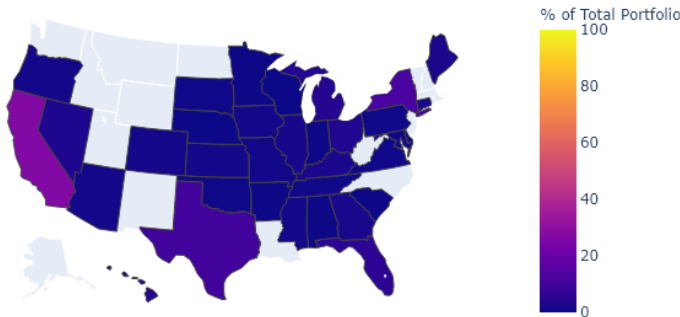

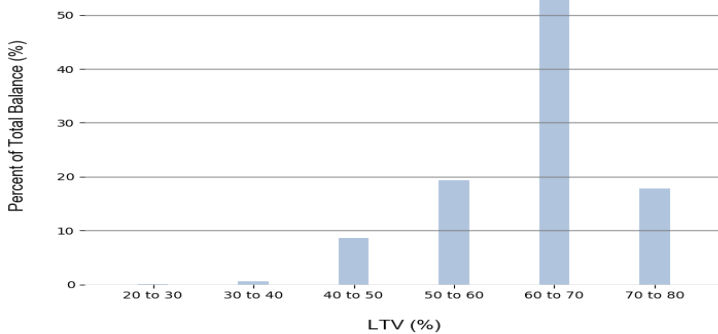
Local Distribution

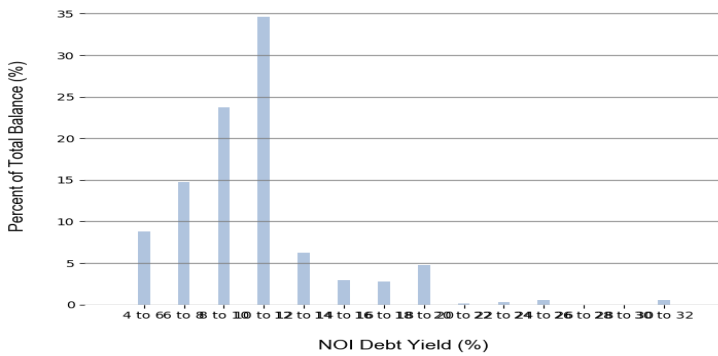

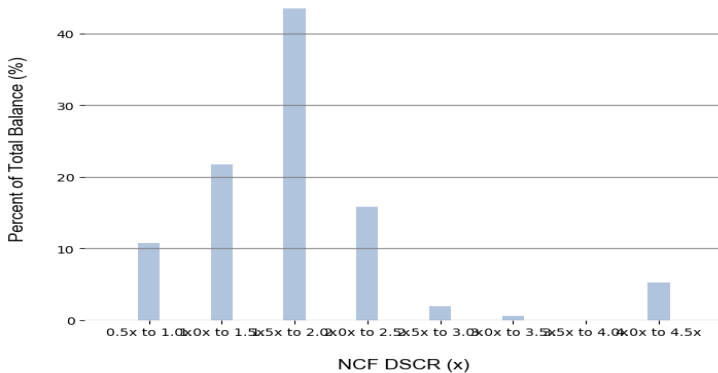
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 4% to 31% with a weighted average NOI debt yield of 10.3%. NOI debt yield ranged from 4% to 31%. Net Cash Flow DSCR (x)

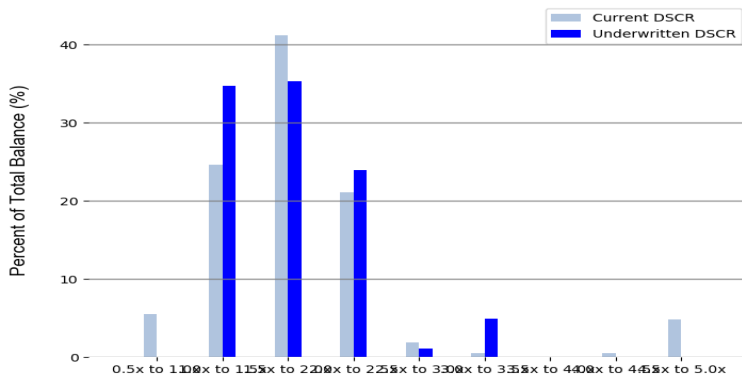


NCF DSCR ranged from 0.0x to 4.0x. There were 8 assets (10.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 17 assets (21.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 34 assets (43.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (15.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (1.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.5% of total balance) with NCF DSCR between 3.0x and 3.5x and 2 assets (5.3% of total balance) with NCF DSCR between 4.0x and 4.5x. 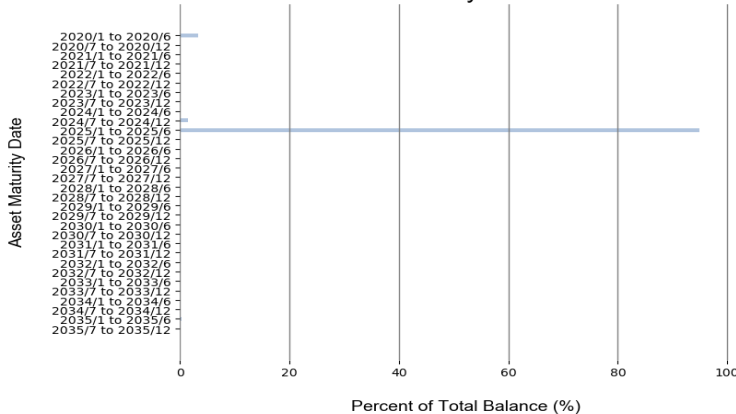
DSCR Distribution (x)



DSCRs ranged from 0.5x to 5.0x. There are 4 assets (5.5% of total balance) with DSCR between 0.5x and 1.0x, 19 assets (24.6% of total balance) with DSCR between 1.0x and 1.5x, 31 assets (41.1% of total balance) with DSCR between 1.5x and 2.0x, 18 assets (21.1% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (1.9% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.5% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (4.8% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
