# **Transaction Summary**

The transaction closed on May 15 2015 and matures in Apr 2035. The pool's current aggregate principal balance is \$1144.3 million compared to \$1235.1 million at close.

The largest loan of the pool (10.5%) is secured by 9200 & 9220 Sunset located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 89%. The major tenants included S&F Management Company (8.31%) and SoHo House (6.79%). The second largest loan of the pool (7.8%) is secured by DFW / Raleigh Portfolio located in Fort Worth-Arlington, TX-100.00% metropolitan area. Occupancy at the subject was 91%. The third largest loan of the pool (7.9%) is secured by 3 Columbus Circle located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 90%. The major tenants included Y&R (30.31%) and Emerge212 (10.91%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.31% and 84 months as of 03/10/2022, respectively. There are a total of 77 loans and 119 properties in the portfolio. The appraisal LTV was approximately 65.4% compared to the Original loan to value (LTV), which was approximately 66.8%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.30x. As of 03/10/2022, 3.10% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 79%.








#### Local Distribution









DSCRs ranged from -1.0x to 3.0x.There are 1 assets (1.5% of total balance) with DSCR between -1.0x and -0.5x, 8 assets (8.9% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (5.9% of total balance) with DSCR between 0.5x and 1.0x, 21 assets (20.3% of total balance) with DSCR between 1.0x and 1.5x, 24 assets (37.7% of total balance) with DSCR between 1.5x and 2.0x, 15 assets (22.7% of total balance) with DSCR between 2.0x and 2.5x and 5 assets (2.9% of total balance) with DSCR between 2.5x and 3.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
