Transaction Summary

The transaction closed on Aug 06 2015 and matures in Jul 2030. The pool's current aggregate principal balance is \$1274.7 million compared to \$1354.3 million at close.

The largest loan of the pool (7.6%) is secured by Lakewood Center - Pooled located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 99%. The major tenants included Macy's (17.49%) and Costco (8.04%). The second largest loan of the pool (7.5%) is secured by Eden Roc located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 73%. The third largest loan of the pool (7.5%) is secured by Heartland Industrial Portfolio located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Kirkland's (11.51%) and Amcor PET Packaging (9.86%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 65 months as of 12/10/2020, respectively. There are a total of 78 loans and 125 properties in the portfolio. The appraisal LTV was approximately 61.5% compared to the Original loan to value (LTV), which was approximately 61.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.88x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.






Local Distribution





Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 11.8%. NOI debt yield ranged from 4% to 25%. There were 1 assets (4% of total balance) with NOI debt yield between 4% and 6%, 3 assets (8% of total balance) with NOI debt yield between 6% and 8%, 22 assets (30% of total balance) with NOI debt yield between 8% and 10%, 18 assets (20% of total balance) with NOI debt yield between 10% and 12%, 12 assets (13% of total balance) with NOI debt yield between 12% and 14%, 9 assets (8% of total balance) with NOI debt yield between 14% and 16%, 5 assets (6% of total balance) with NOI debt yield between 16% and 18%, 4 assets (10% of total balance) with NOI debt yield between 18% and 20%, 2 assets (1% of total balance) with NOI debt yield between 20% and 22%, 1 assets (0% of total balance) with NOI debt yield between 22% and 24% and 1 assets (0% of total balance) with NOI debt yield between 24% and 26%.

There were 2 assets (4.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 14 assets (11.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 34 assets (54.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 18 assets (18.0% of total balance) with NCF DSCR between 2.0x and 2.5x, 7 assets (5.3% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (1.6% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (2.4% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (2.4% of total balance) with NCF DSCR between 4.0x and 5.0x. 



There are 2 assets (4.8% of total balance) with DSCR between 0.5x and 1.0x, 11 assets (7.8% of total balance) with DSCR between 1.0x and 1.5x, 32 assets (53.1% of total balance) with DSCR between 1.5x and 2.0x, 21 assets (22.2% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (4.0% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (2.0% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.6% of total balance) with DSCR between 3.5x and 4.0x, 1 assets (2.1% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (2.4% of total balance) with DSCR between 4.5x and 5.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
