## **Transaction Summary**

The transaction closed on Aug 25 2015 and matures in Aug 2025. The pool's current aggregate principal balance is \$1008.9 million compared to \$1061.8 million at close.

The largest loan of the pool (11.9%) is secured by Heartland Industrial Portfolio located in metropolitan area. Occupancy at the subject was 92%. The major tenants included Kirkland's (11.78%) and Amcor PET Packaging (10.09%). The second largest loan of the pool (4.7%) is secured by Courtyard Miami Downtown located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 84%. The third largest loan of the pool (4.8%) is secured by Pearlridge Center - Trust located in metropolitan area. Occupancy at the subject was 91%. The major tenants included Macy's (16.60%) and Bed Bath & Beyond (7.30%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.55% and 65 months as of 12/10/2020, respectively. There are a total of 80 loans and 139 properties in the portfolio. The appraisal LTV was approximately 68.3% compared to the Original loan to value (LTV), which was approximately 65.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.84x. As of 12/10/2020, 1.11% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 88%.



Type Concentration











Most recent net operating income debt yield ranged from 0% to 19% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 0% to 19%. There were 1 assets (3% of total balance) with NOI debt yield between 0% and 2%, 2 assets (2% of total balance) with NOI debt yield between 2% and 4%, 1 assets (1% of total balance) with NOI debt yield between 4% and 6%, 6 assets (7% of total balance) with NOI debt yield between 6% and 8%, 15 assets (27% of total balance) with NOI debt yield between 8% and 10%, 24 assets (24% of total balance) with NOI debt yield between 10% and 12%, 16 assets (17% of total balance) with NOI debt yield between 12% and 14%, 4 assets (3% of total balance) with NOI debt yield between 14% and 16%, 5 assets (6% of total balance) with NOI debt yield between 16% and 18% and 6 assets (10% of total balance) with NOI debt yield between 18% and 20%.

NCF DSCR ranged from -1.0x to 5.0x. There were 1 assets (3.1% of total balance) with NCF DSCR between -0.5x and 0.0x, 1 assets (2.3% of total balance) with NCF DSCR between 0.0x and 0.5x, 3 assets (1.5% of total balance) with NCF DSCR between 0.5x and 1.0x, 27 assets (22.8% of total balance) with NCF DSCR between 1.0x and 1.5x. 29 assets (46.1% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (12.4% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (4.0% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.4% of total balance) with NCF DSCR between 3.0x and 3.5x and 2 assets (7.5% of total balance) with NCF DSCR between 4.5x and 5.0x. The most recent weighted average NCF DSCR was 1.8x.





DSCRs ranged from 0.0x to 5.5x.There are 2 assets (5.4% of total balance) with DSCR between 0.0x and 0.5x, 3 assets (1.5% of total balance) with DSCR between 0.5x and 1.0x, 19 assets (17.5% of total balance) with DSCR between 1.0x and 1.5x, 34 assets (48.1% of total balance) with DSCR between 1.5x and 2.0x, 12 assets (9.4% of total balance) with DSCR between 2.0x and 2.5x, 7 assets (10.2% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.4% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (2.8% of total balance) with DSCR between 4.5x and 5.0x and 1 assets (4.8% of total balance) with DSCR between 5.0x and 5.5x. The most recent weighted average DSCR is 2.0x.

There are 1 assets (1.1% of total balance) that have maturity dates between 2020/7 and 2020/12, 11 assets (15.9% of total balance) that have maturity dates between 2025/1 and 2025/6 and 68 assets (83.0% of total balance) that have maturity dates between 2025/7 and 2025/12.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
