## **Transaction Summary**

The transaction closed on Aug 25 2015 and matures in Aug 2025. The pool's current aggregate principal balance is \$973.2 million compared to \$1045.3 million at close.

The largest loan of the pool (12.2%) is secured by Heartland Industrial Portfolio located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Kirkland's (11.78%) and Amcor PET Packaging (10.09%). The second largest loan of the pool (4.8%) is secured by Courtyard Miami Downtown located in Miami-Miami Beach-Kendall, FL metropolitan area. Occupancy at the subject was 73%. The third largest loan of the pool (4.9%) is secured by Pearlridge Center - Trust located in metropolitan area. Occupancy at the subject was 91%. The major tenants included Macy's (16.60%) and Bed Bath & Beyond (7.30%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.55% and 81 months as of 04/10/2022, respectively. There are a total of 78 loans and 137 properties in the portfolio. The appraisal LTV was approximately 65.8% compared to the Original loan to value (LTV), which was approximately 65.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.76x. As of 04/10/2022, 1.15% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.





#### Occupancy Distribution (%)




## Local Distribution





Most recent net operating income debt yield ranged from 0% to 25% with a weighted average NOI debt yield of 11.1%. NOI debt yield ranged from 0% to 25%. There were 3 assets (5% of total balance) with NOI debt yield between 0% and 2%, 3 assets (6% of total balance) with NOI debt yield between 4% and 6%, 7 assets (7% of total balance) with NOI debt yield between 6% and 8%, 10 assets (24% of total balance) with NOI debt yield between 8% and 10%, 18 assets (20% of total balance) with NOI debt yield between 10% and 12%, 16 assets (15% of total balance) with NOI debt yield between 12% and 14%, 12 assets (8% of total balance) with NOI debt yield between 14% and 16%, 5 assets (12% of total balance) with NOI debt yield between 16% and 18%, 3 assets (3% of total balance) with NOI debt yield between 20% and 22%, 1 assets (0% of total balance) with NOI debt yield between 24% and 26%

NCF DSCR ranged from 0.0x to 5.0x. There were 3 assets (4.9% of total balance) with NCF DSCR between 0.0x and 0.5x, 9 assets (12.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 20 assets (20.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 29 assets (42.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 9 assets (7.7% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (2.5% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (0.6% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (1.8% of total balance) with NCF DSCR between 3.5x and 4.0x, 1 assets (4.9% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (2.9% of total balance) with NCF DSCR between 4.5x and 5.0x. 



DSCRs ranged from 0.0x to 5.0x. There are 3 assets (4.9% of total balance) with DSCR between 0.0x and 0.5x, 6 assets (6.7% of total balance) with DSCR between 0.5x and 1.0x, 15 assets (17.3% of total balance) with DSCR between 1.0x and 1.5x, 29 assets (44.3% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (9.1% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (6.2% of total balance) with DSCR between 2.5x and 3.0x, 4 assets (1.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (1.8% of total balance) with DSCR between 4.0x and 4.5x and 2 assets (7.8% of total balance) with DSCR between 4.5x and 5.0x. ## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
