Transaction Summary

The transaction closed on Oct 08 2015 and matures in Sep 2025. The pool's current aggregate principal balance is \$1005.4 million compared to \$1048.3 million at close.

The largest loan of the pool (11.2%) is secured by Prudential Plaza located in metropolitan area. Occupancy at the subject was 89%. The major tenants included Tribune Publishing Company LLC (6.04%) and Wilson Sporting Goods Co. (4.04%). The second largest loan of the pool (7.0%) is secured by 11 Madison Avenue - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Credit Suisse (55.41%) and Sony (25.33%). The third largest loan of the pool (6.7%) is secured by Ashley Park located in metropolitan area. Occupancy at the subject was 93%. The major tenants included Dillard's (27.96%) and Regal Cinemas (9.12%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.50% and 64 months as of 12/10/2020, respectively. There are a total of 57 loans and 95 properties in the portfolio. The appraisal LTV was approximately 65.0% compared to the Original loan to value (LTV), which was approximately 66.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.92x. As of 12/10/2020, 0.77% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 91%.

Type Concentration





Occupancy Distribution (%)





Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 10.8%. NOI debt yield ranged from 6% to 21%. There were 2 assets (5% of total balance) with NOI debt yield between 6% and 8%, 19 assets (40% of total balance) with NOI debt yield between 8% and 10%, 14 assets (23% of total balance) with NOI debt yield between 10% and 12%, 13 assets (21% of total balance) with NOI debt yield between 12% and 14%, 5 assets (10% of total balance) with NOI debt yield between 14% and 16%, 2 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (0% of total balance) with NOI debt yield between 18% and 20% and 1 assets (0% of total balance) with NOI debt yield between 20% and 22%.





EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
