## **Transaction Summary**

The transaction closed on Oct 29 2015 and matures in Oct 2030. The pool's current aggregate principal balance is \$826.3 million compared to \$872.9 million at close.

The largest loan of the pool (8.5%) is secured by 11 Madison Avenue - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Credit Suisse (55.41%) and Sony (25.33%). The second largest loan of the pool (7.9%) is secured by NMS Los Angeles Multifamily Portfolio located in Los Angeles-Long Beach-Glendale, CA-100.00% metropolitan area. Occupancy at the subject was 88%. The third largest loan of the pool (6.9%) is secured by Sandalwood Portfolio located in Fort Worth-Arlington, TX-13.49% metropolitan area. Occupancy at the subject was 96%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.47% and 63 months as of 12/10/2020, respectively. There are a total of 63 loans and 87 properties in the portfolio. The appraisal LTV was approximately 63.7% compared to the Original loan to value (LTV), which was approximately 64.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.06x. As of 12/10/2020, 0.95% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 90%.





## Occupancy Distribution (%)






#### Local Distribution





Most recent net operating income debt yield ranged from 4% to 25% with a weighted average NOI debt yield of 11.3%. NOI debt yield ranged from 4% to 25%. There were 1 assets (1.2% of total balance) with NCF DSCR between 0.0x and 0.5x, 2 assets (1.4% of total balance) with NCF DSCR between 0.5x and 1.0x, 26 assets (33.8% of total balance) with NCF DSCR between 1.0x and 1.5x, 14 assets (24.2% of total balance) with NCF DSCR between 1.5x and 2.0x, 13 assets (23.9% of total balance) with NCF DSCR between 2.0x and 2.5x, 4 assets (3.9% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.8% of total balance) with NCF DSCR between 3.0x and 3.5x, 1 assets (8.5% of total balance) with NCF DSCR between 4.0x and 4.5x and 1 assets (2.3% of total balance) with NCF DSCR between 4.5x and 5.0x. 



There are 1 assets (1.2% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.3% of total balance) with DSCR between 0.5x and 1.0x, 18 assets (22.7% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (31.3% of total balance) with DSCR between 1.5x and 2.0x, 14 assets (23.3% of total balance) with DSCR between 2.0x and 2.5x, 6 assets (6.4% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (4.1% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (8.5% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (2.3% of total balance) with DSCR between 5.0x and 5.5x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
