Transaction Summary

The transaction closed on Oct 29 2015 and matures in Oct 2030. The pool's current aggregate principal balance is \$801.1 million compared to \$854.8 million at close.

The largest loan of the pool (8.7%) is secured by 11 Madison Avenue - Pooled located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included Credit Suisse (55.41%) and Sony (25.33%). The second largest loan of the pool (8.1%) is secured by NMS Los Angeles Multifamily Portfolio located in Los Angeles-Long Beach-Glendale, CA-100.00% metropolitan area. Occupancy at the subject was 88%. The third largest loan of the pool (6.9%) is secured by Sandalwood Portfolio located in Fort Worth-Arlington, TX-13.49% metropolitan area. Occupancy at the subject was 94%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.47% and 78 months as of 03/10/2022, respectively. There are a total of 61 loans and 79 properties in the portfolio. The appraisal LTV was approximately 62.8% compared to the Original loan to value (LTV), which was approximately 64.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.88x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 86%.

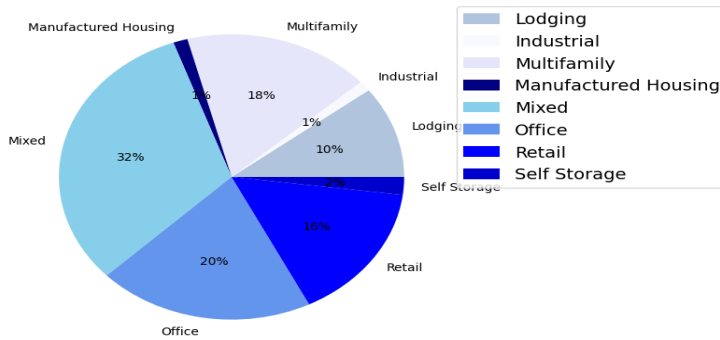

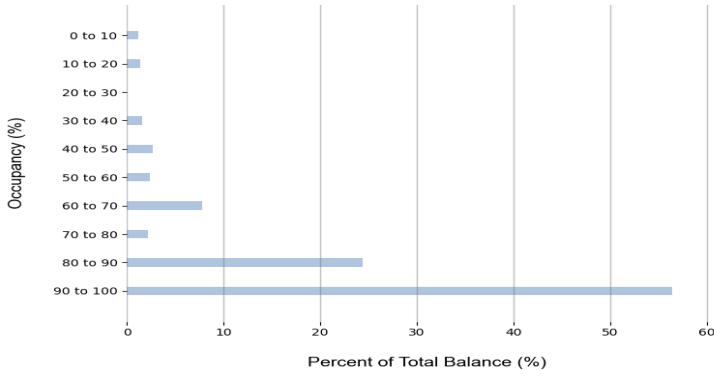

Occupancy Distribution (%)

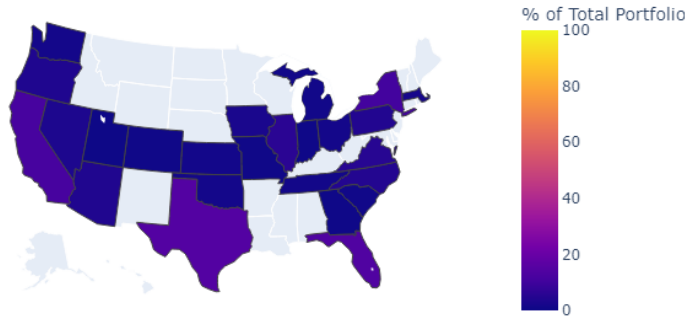

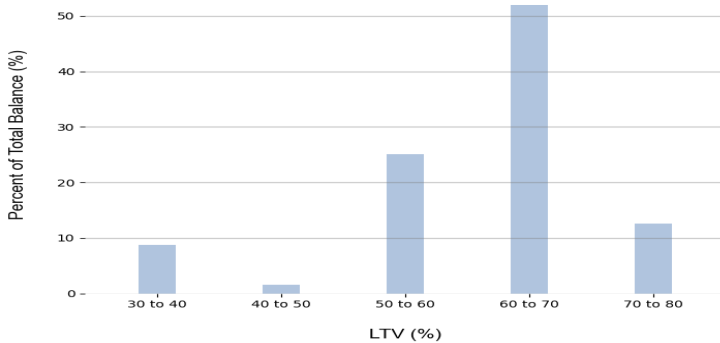
Local Distribution

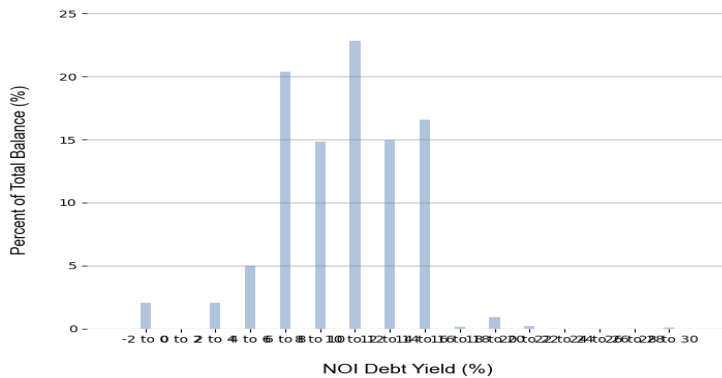

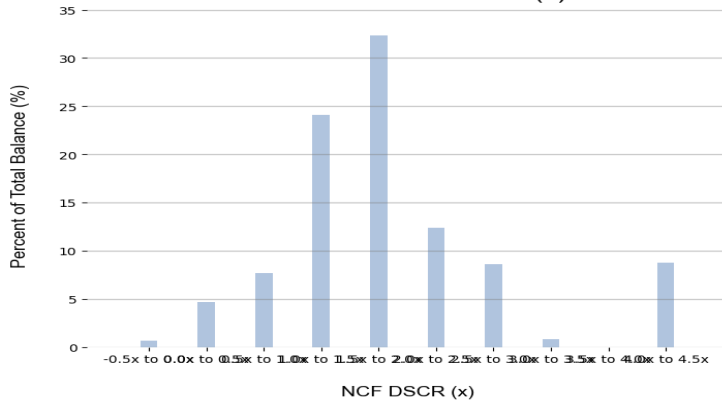
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from -2% to 29% with a weighted average NOI debt yield of 10.3%. NOI debt yield ranged from -2% to 29%. There were 2 assets (2% of total balance) with NOI debt yield between -2% and 0%, 1 assets (2% of total balance) with NOI debt yield between 2% and 4%, 3 assets (5% of total balance) with NOI debt yield between 4% and 6%, 10 assets (20% of total balance) with NOI debt yield between 6% and 8%, 9 assets (15% of total balance) with NOI debt yield between 8% and 10%, 14 assets (23% of total balance) with NOI debt yield between 10% and 12%, 9 assets (15% of total balance) with NOI debt yield between 12% and 14%, 9 assets (17% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (0% of total balance) with NOI debt yield between 20% and 22%, 1 assets (0% of total balance) with NOI debt yield between 28% and 30%. 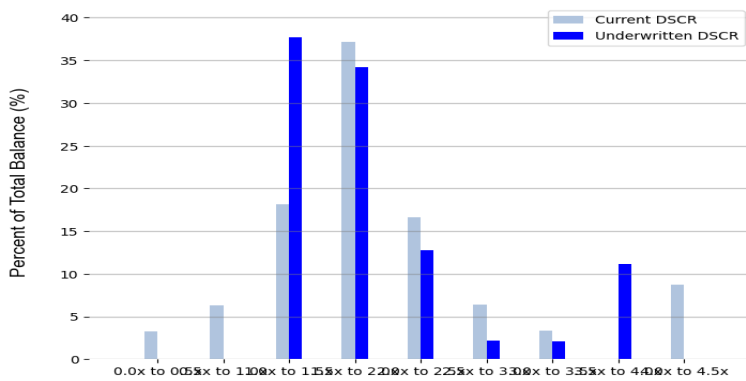
Net Cash Flow DSCR (x)

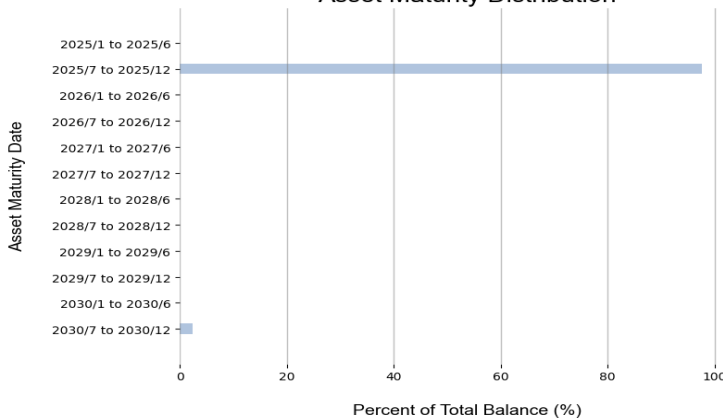
DSCR Distribution (x)



DSCRs ranged from 0.0x to 4.5x. There are 3 assets (3.3% of total balance) with DSCR between 0.0x and 0.5x, 4 assets (6.3% of total balance) with DSCR between 0.5x and 1.0x, 14 assets (18.1% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (37.2% of total balance) with DSCR between 1.5x and 2.0x, 13 assets (16.6% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (6.4% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (3.4% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (8.7% of total balance) with DSCR between 4.0x and 4.5x. There are 59 assets (781.8% of total balance) that have maturity dates between 2025/7 and 2025/12 and 2 assets (19.3% of total balance) that have maturity dates between 2030/7 and 2030/12.

Sensitivity Analysis

Summary

EJR used the capitalization rates ("cap rates") listed below for the different types of the properties and then calculated the value of the properties in the portfolio by considering the most recent NCF and the various cap rates.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

1. The symbol in the rating scale used to denote the credit rating categories and notches within categories and the identity of the obligor, security, or money market instrument as required by Paragraph (a)(1)(ii)(A) of Rule 17g-7:

There are three notches in each of EJR's rating categories (e.g., A-(sf), A(sf) and A+(sf) for category A(sf)) except for AAA(sf), CC(sf), C(sf) and D(sf).

2. The version of the procedure or methodology used to determine the credit rating as required by Paragraph (a)(1)(ii)(B) of Rule 17g-7:

We are using the Methodology for Rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) v1b and General Methodology for Rating Asset Backed and Structured Finance Obligations (Non-NRSRO) v2.

3. The main assumptions and principles used in constructing the procedures and methodologies used to determine the credit rating as required by Paragraph (a)(1)(ii)(C) of Rule 17g-7:

The credit rating assigned reflects EJR's judgement regarding the future credit quality of the issue. The major assumptions used to construct the methodologies include:

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.

4. The potential limitations of the credit rating as required by Paragraph (a)(1)(ii)(D) of Rule 17g-7:

EJR's rating pertains solely to EJR's view of current and prospective credit quality. EJR's rating does not address pricing, liquidity or other risks associated with holding investments in the issuer. EJR ratings:

- 1). Are not intended to address the value, price, price stability, liquidity, suitability, or merit of an investment.
- 2). Do not address whether a particular rated security is suitable for a particular investor or suitable for an investor's risk tolerance.
