# **Transaction Summary**

The transaction closed on Feb 04 2015 and matures in Dec 2044. The pool's current aggregate principal balance is \$1263.1 million compared to \$1346.2 million at close.

The largest loan of the pool (11.4%) is secured by One Memorial located in Cambridge-Newton-Framingham, MA metropolitan area. Occupancy at the subject was 99%. The major tenants included INTERSYSTEMS CORP (64.06%) and Microsoft (42.32%). The second largest loan of the pool (8.3%) is secured by Gateway Center Phase II located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included JC Penney (20.39%) and Big V Shoprite Supermarket (14.95%). The third largest loan of the pool (7.8%) is secured by 9911 Belward Campus Drive located in Silver Spring-Frederick-Rockville, MD metropolitan area. Occupancy at the subject was 100%. The largest tenant was Human Genome Sciences Inc. (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.24% and 88 months as of 04/10/2022, respectively. There are a total of 52 loans and 117 properties in the portfolio. The appraisal LTV was approximately 59.1% compared to the Original loan to value (LTV), which was approximately 62.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.82x. As of 04/10/2022, 0.63% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 81%.





# Occupancy Distribution (%)




## Local Distribution







# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
