Transaction Summary

The transaction closed on Jun 18 2015 and matures in Jun 2035. The pool's current aggregate principal balance is \$1080.6 million compared to \$1150.8 million at close.

The largest loan of the pool (6.2%) is secured by Courtyard by Marriott Pasadena located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 86%. The second largest loan of the pool (3.7%) is secured by Meridian at Brentwood located in metropolitan area. Occupancy at the subject was 95%. The major tenants included BJC Health System (70.68%) and TIAA FSB (8.11%). The third largest loan of the pool (3.8%) is secured by 155 Mercer Street located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was Dolce & Gabbana USA INC (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.35% and 67 months as of 12/10/2020, respectively. There are a total of 94 loans and 127 properties in the portfolio. The appraisal LTV was approximately 65.4% compared to the Original loan to value (LTV), which was approximately 68.5%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.59x. As of 12/10/2020, 1.06% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)













Most recent net operating income debt yield ranged from 4% to 23% with a weighted average NOI debt yield of 10.2%. NOI debt yield ranged from 4% to 23%. There were 3 assets (4% of total balance) with NOI debt yield between 4% and 6%, 15 assets (23% of total balance) with NOI debt yield between 6% and 8%, 21 assets (29% of total balance) with NOI debt yield between 8% and 10%, 26 assets (23% of total balance) with NOI debt yield between 10% and 12%, 14 assets (11% of total balance) with NOI debt yield between 12% and 14%, 6 assets (6% of total balance) with NOI debt yield between 14% and 16%, 1 assets (0% of total balance) with NOI debt yield between 16% and 18%, 5 assets (3% of total balance) with NOI debt yield between 18% and 20%, 2 assets (1% of total balance) with NOI debt yield between 20% and 22% and 1 assets (1% of total balance) with NOI debt yield between 22% and 24%.

NCF DSCR ranged from 0.0x to 3.0x. There were 6 assets (8.0% of total balance) with NCF DSCR between 0.5x and 1.0x, 38 assets (35.2% of total balance) with NCF DSCR between 1.0x and 1.5x, 35 assets (43.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 11 assets (9.7% of total balance) with NCF DSCR between 2.0x and 2.5x and 4 assets (3.4% of total balance) with NCF DSCR between 2.5x and 3.0x. The most recent weighted average NCF DSCR was 1.6x.




DSCR (Current / Underwritten)



EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
