Transaction Summary

The transaction closed on Oct 20 2016 and matures in Oct 2028. The pool's current aggregate principal balance is \$858.7 million compared to \$885.2 million at close.

The largest loan of the pool (9.5%) is secured by Glendale Fashion Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 92%. The major tenants included Ralph's Grocery Market (18.93%) and Nordstrom (14.06%). The second largest loan of the pool (9.3%) is secured by Champion Station located in metropolitan area. Occupancy at the subject was 100%. The major tenants included ForeScout Technologies (33.39%) and Itron Inc./Silver Spring Networks (33.39%). The third largest loan of the pool (7.0%) is secured by 286 Madison Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included CERTIFIED MOVING & STORAGE (6.06%) and BLUE HERON (4.42%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.40% and 51 months as of 10/10/2020, > respectively. There are a total of 41 loans and 58 properties in the portfolio. The appraisal LTV was approximately 58.6% compared to the Original loan to value (LTV), which was approximately 60.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.06x. As of 10/10/2020, 0.86% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.






Local Distribution









There are 6 assets (9.6% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 3 assets (7.1% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (41.4% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (17.3% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (7.6% of total balance) with DSCR between 2.5x and 3.0x, 3 assets (11.8% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (4.7% of total balance) with DSCR between 3.5x and 4.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
