Transaction Summary

The transaction closed on Oct 20 2016 and matures in Oct 2028. The pool's current aggregate principal balance is \$849.2 million compared to \$877.3 million at close.

The largest loan of the pool (9.7%) is secured by Glendale Fashion Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 92%. The major tenants included Ralph's Grocery Market (18.93%) and Nordstrom (14.06%). The second largest loan of the pool (9.4%) is secured by Champion Station located in metropolitan area. Occupancy at the subject was 100%. The major tenants included ForeScout Technologies (33.39%) and Itron Inc./Silver Spring Networks (33.39%). The third largest loan of the pool (7.1%) is secured by 286 Madison Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 96%. The major tenants included CERTIFIED MOVING & STORAGE (6.06%) and BLUE HERON (4.42%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.38% and 54 months as of 01/10/2021, respectively. There are a total of 40 loans and 57 properties in the portfolio. The appraisal LTV was approximately 58.5% compared to the Original loan to value (LTV), which was approximately 60.0%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.07x. As of 01/10/2021, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 93%.



Type Concentration










LTV Distribution (%)







DSCRs ranged from 0.0x to 4.0x. There are 6 assets (9.7% of total balance) with DSCR between 0.0x and 0.5x, 2 assets (2.7% of total balance) with DSCR between 0.5x and 1.0x, 2 assets (4.9% of total balance) with DSCR between 1.0x and 1.5x, 16 assets (41.7% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (17.5% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (6.8% of total balance) with DSCR between 2.0x and 3.5x and 3.0x, 3 assets (12.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (4.7% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 2.2x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
