## **Transaction Summary**

The transaction closed on Oct 20 2016 and matures in Oct 2028. The pool's current aggregate principal balance is \$784.8 million compared to \$824.3 million at close.

The largest loan of the pool (10.4%) is secured by Glendale Fashion Center located in Los Angeles-Long Beach-Glendale, CA metropolitan area. Occupancy at the subject was 93%. The major tenants included Ralph's Grocery Market (18.93%) and Nordstrom (14.06%). The second largest loan of the pool (10.2%) is secured by Champion Station located in metropolitan area. Occupancy at the subject was 100%. The major tenants included ForeScout Technologies (33.39%) and Itron Inc./Silver Spring Networks (33.39%). The third largest loan of the pool (7.6%) is secured by 286 Madison Avenue located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 82%. The major tenants included CERTIFIED MOVING & STORAGE (6.06%) and GLOBAL RELAY USA INC (4.46%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.35% and 69 months as of 04/10/2022, respectively. There are a total of 37 loans and 54 properties in the portfolio. The appraisal LTV was approximately 57.6% compared to the Original loan to value (LTV), which was approximately 61.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.55x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 82%.



Type Concentration















There are 1 assets (2.3% of total balance) with DSCR between -0.5x and 0.0x, 8 assets (20.9% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.5% of total balance) with DSCR between 0.5x and 1.0x, 5 assets (8.6% of total balance) with DSCR between 1.0x and 1.5x, 12 assets (38.1% of total balance) with DSCR between 1.5x and 2.0x, 5 assets (8.1% of total balance) with DSCR between 2.0x and 2.5x, 2 assets (5.3% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (11.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (5.1% of total balance) with DSCR between 3.5x and 4.0x. # EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
