Transaction Summary

The transaction closed on Mar 16 2016 and matures in Dec 2035. The pool's current aggregate principal balance is \$771.4 million compared to \$807.1 million at close.

The largest loan of the pool (9.7%) is secured by Sun MHC Portfolio located in Detroit-Dearborn-Livonia, MI-7.96% metropolitan area. Occupancy at the subject was 75%. The second largest loan of the pool (8.0%) is secured by North Point Center East located in metropolitan area. Occupancy at the subject was 100%. The major tenants included MedAssets Net Revenue Sys. LLC (19.97%) and SIS (8.51%). The third largest loan of the pool (6.5%) is secured by Williamsburg Premium Outlets located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Food Lion (6.06%) and Nike Factory Store (2.62%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.65% and 59 months as of 12/10/2020, respectively. There are a total of 64 loans and 88 properties in the portfolio. The appraisal LTV was approximately 64.9% compared to the Original loan to value (LTV), which was approximately 65.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.74x. As of 12/10/2020, 0.58% of loans had a remaining term of less than 6 months. Weighted average occupancy was approximately 87%.

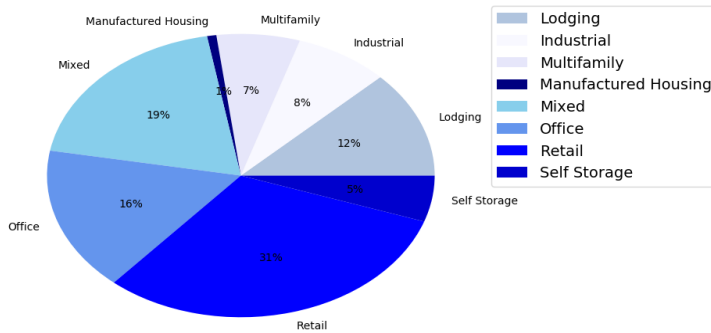

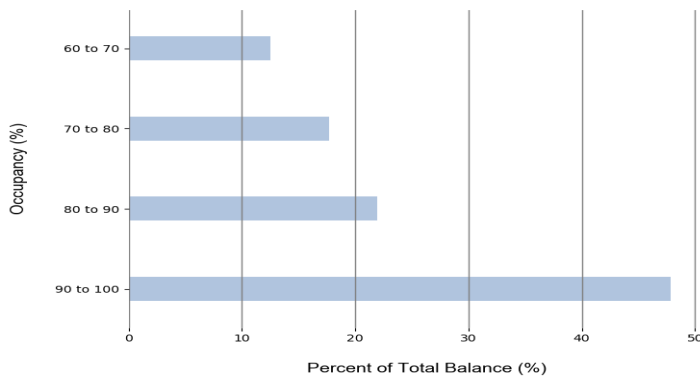

Occupancy Distribution (%)

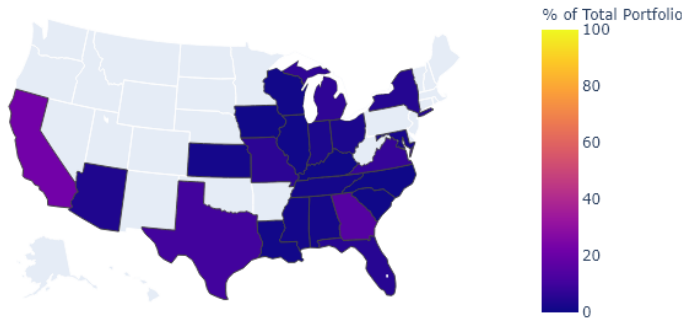

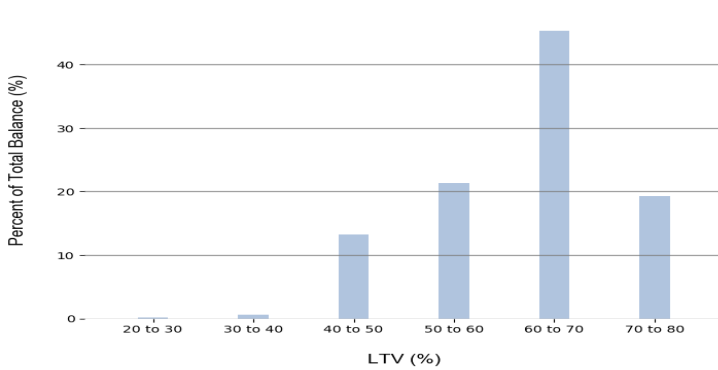
Local Distribution

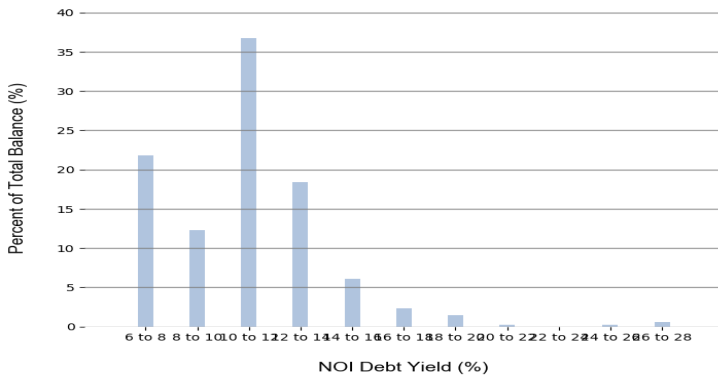

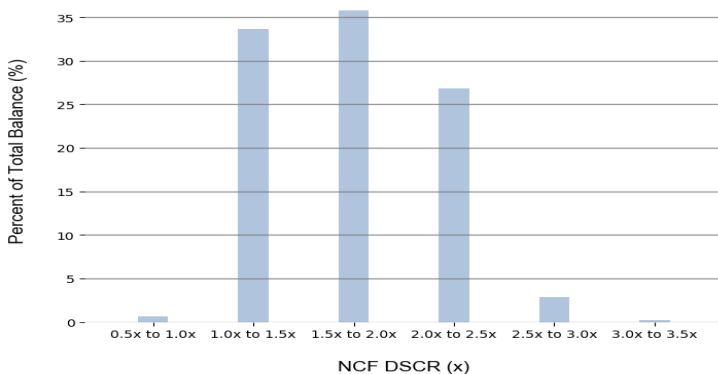
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 27% with a weighted average NOI debt yield of 11.0%. NOI debt yield ranged from 6% to 27%. Net Cash Flow DSCR (x)

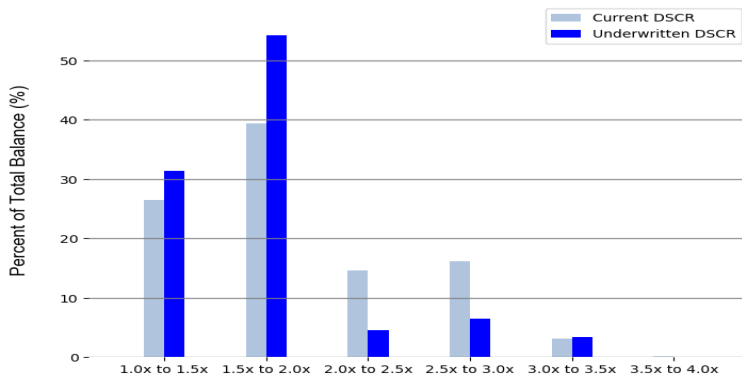


NCF DSCR ranged from 0.0x to 3.0x. There were 1 assets (0.7% of total balance) with NCF DSCR between 0.5x and 1.0x, 24 assets (33.7% of total balance) with NCF DSCR between 1.0x and 1.5x, 24 assets (35.8% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (26.8% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.8% of total balance) with NCF DSCR between 2.5x and 3.0x and 1 assets (0.2% of total balance) with NCF DSCR between 3.0x and 3.5x. 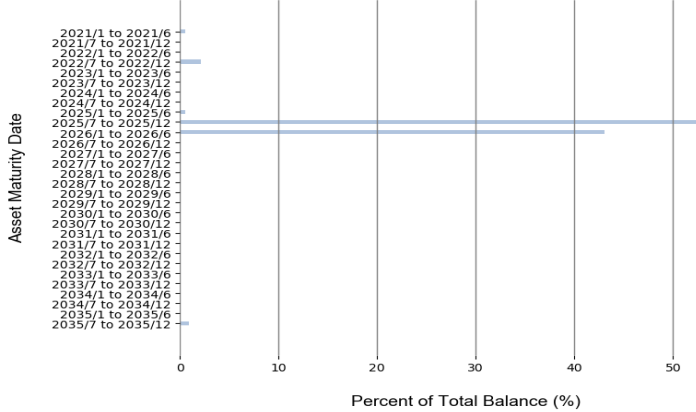
DSCR Distribution (x)



DSCRs ranged from 1.0x to 4.0x. There are 18 assets (26.5% of total balance) with DSCR between 1.0x and 1.5x, 28 assets (39.4% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (14.6% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (16.2% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (3.2% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with DSCR between 3.5x and 4.0x. The most recent weighted average DSCR is 1.9x.

There are 1 assets (0.6% of total balance) that have maturity dates between 2021/1 and 2021/6, 2 assets (2.1% of total balance) that have maturity dates between 2022/7 and 2022/12, 1 assets (0.6% of total balance) that have maturity dates between 2025/1 and 2025/6, 36 assets (52.7% of total balance) that have maturity dates between 2025/7 and 2025/12, 23 assets (43.1% of total balance) that have maturity dates between 2026/1 and 2026/6 and 1 assets (1.0% of total balance) that have maturity dates between 2035/7 and 2035/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.
