Transaction Summary

The transaction closed on Mar 16 2016 and matures in Dec 2035. The pool's current aggregate principal balance is \$664.6 million compared to \$712.3 million at close.

The largest loan of the pool (9.2%) is secured by North Point Center East located in metropolitan area. Occupancy at the subject was 100%. The major tenants included Services Solutions Group Holdco LLC (19.97%) and Cool Labs DM LLC (4.81%). The second largest loan of the pool (7.5%) is secured by Williamsburg Premium Outlets located in metropolitan area. Occupancy at the subject was 86%. The major tenants included Food Lion (6.06%) and Nike Factory Store (2.71%). The third largest loan of the pool (6.5%) is secured by Intercontinental Kansas City Hotel located in metropolitan area. Occupancy at the subject was 42%.

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.69% and 75 months as of 04/10/2022, respectively. There are a total of 60 loans and 73 properties in the portfolio. The appraisal LTV was approximately 63.6% compared to the Original loan to value (LTV), which was approximately 64.6%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.63x. As of 04/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 85%.

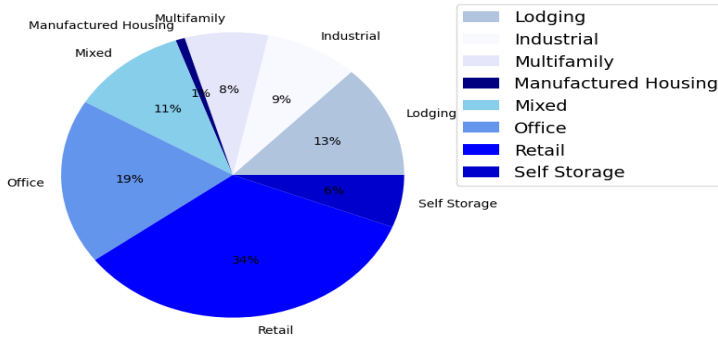

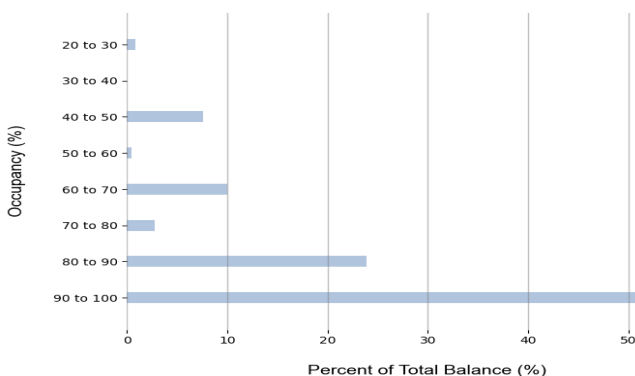

Occupancy Distribution (%)

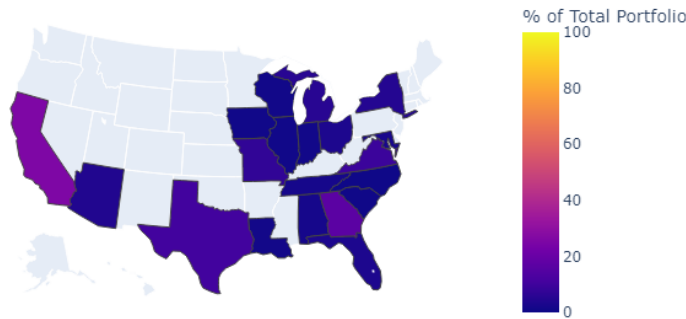

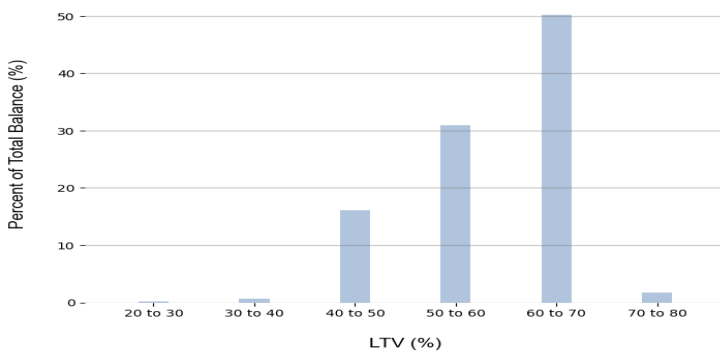
Local Distribution

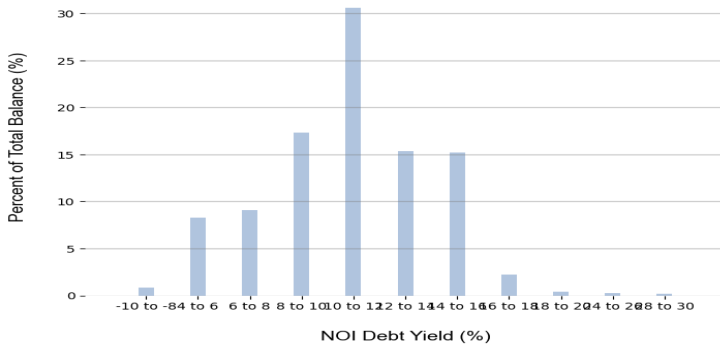

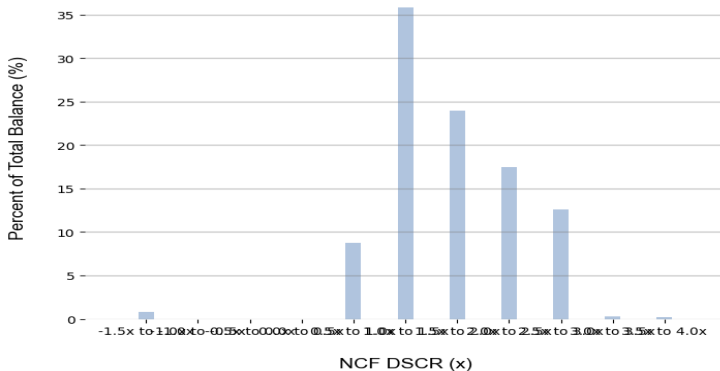
NOI Debt Yield (%)



Most recent net operating income debt yield ranged from -10% to 29% with a weighted average NOI debt yield of 10.7%. NOI debt yield ranged from -10% to 29%. Net Cash Flow DSCR (x)

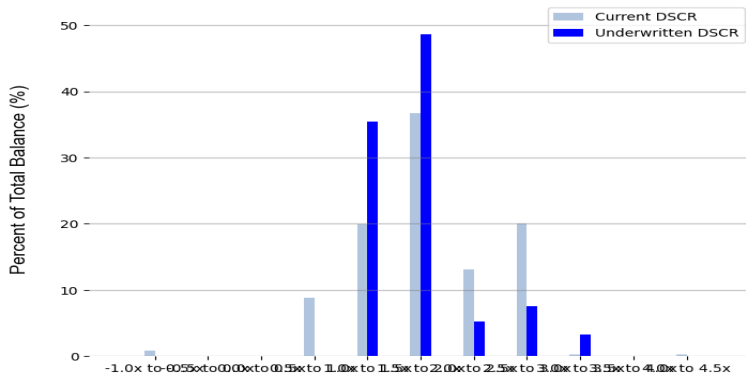

There were 1 assets (0.8% of total balance) with NCF DSCR between -1.5x and -1.0x, 4 assets (8.8% of total balance) with NCF DSCR between 0.5x and 1.0x, 22 assets (35.9% of total balance) with NCF DSCR between 1.0x and 1.5x, 22 assets (23.9% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (17.5% of total balance) with NCF DSCR between 2.0x and 2.5x, 3 assets (12.6% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (0.3% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with NCF DSCR between 3.5x and 4.0x. 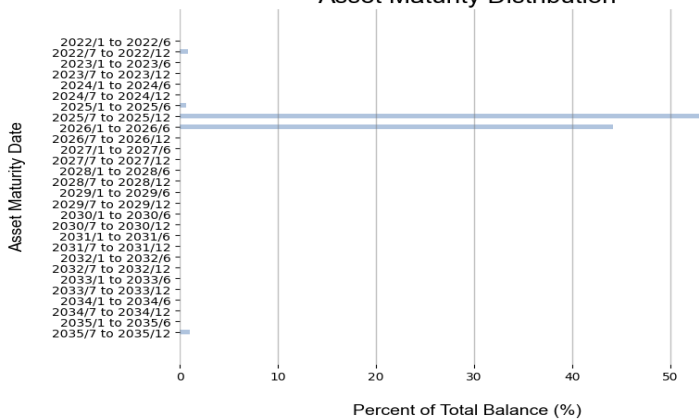
DSCR Distribution (x)



DSCRs ranged from -1.0x to 4.5x. There are 1 assets (0.8% of total balance) with DSCR between -1.0x and -0.5x, 4 assets (8.8% of total balance) with DSCR between 0.5x and 1.0x, 13 assets (19.9% of total balance) with DSCR between 1.0x and 1.5x, 28 assets (36.7% of total balance) with DSCR between 1.5x and 2.0x, 8 assets (13.2% of total balance) with DSCR between 2.0x and 2.5x, 4 assets (20.1% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (0.3% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (0.2% of total balance) with DSCR between 4.0x and 4.5x. There are 1 assets (5.8% of total balance) that have maturity dates between 2022/7 and 2022/12, 1 assets (4.4% of total balance) that have maturity dates between 2025/1 and 2025/6, 38 assets (353.6% of total balance) that have maturity dates between 2025/7 and 2025/12, 19 assets (293.7% of total balance) that have maturity dates between 2026/1 and 2026/6 and 1 assets (7.1% of total balance) that have maturity dates between 2035/7 and 2035/12.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJ's approach (see our Methodology for rating Commercial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
3. EJ's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
4. Subject to economic conditions, EJ may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

- 1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.
- 2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.
- 3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
