Transaction Summary

The transaction closed on Sep 28 2017 and matures in Sep 2027. The pool's current aggregate principal balance is \$906.0 million compared to \$917.1 million at close.

The largest loan of the pool (7.8%) is secured by 101 Ludlow located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Chelgram Holdings (99.50%) and Hakki Akdeniz (0.50%). The second largest loan of the pool (6.4%) is secured by AHIP Northeast Portfolio II located in Camden, NJ-28.27% metropolitan area. Occupancy at the subject was 85%. The third largest loan of the pool (6.0%) is secured by CHG Building located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was CHG Healthcare Services Inc. (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.58% and 41 months as of 10/10/2020, respectively. There are a total of 42 loans and 55 properties in the portfolio. The appraisal LTV was approximately 57.8% compared to the Original loan to value (LTV), which was approximately 58.3%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 2.03x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 92%.





Occupancy Distribution (%)




Local Distribution





Most recent net operating income debt yield ranged from 6% to 21% with a weighted average NOI debt yield of 10.5%. NOI debt yield ranged from 6% to 21%. There were 9 assets (19% of total balance) with NOI debt yield between 6% and 8%, 11 assets (33% of total balance) with NOI debt yield between 8% and 10%, 14 assets (29% of total balance) with NOI debt yield between 10% and 12%, 5 assets (13% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 16% and 18%, 1 assets (1% of total balance) with NOI debt yield between 18% and 20%, 1 assets (4% of total balance) with NOI debt yield between 20% and 22%

There were 2 assets (2.3% of total balance) with NCF DSCR between 0.5x and 1.0x, 9 assets (15.5% of total balance) with NCF DSCR between 1.0x and 1.5x, 14 assets (36.5% of total balance) with NCF DSCR between 1.5x and 2.0x, 12 assets (36.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (2.5% of total balance) with NCF DSCR between 2.5x and 3.0x, 2 assets (2.6% of total balance) with NCF DSCR between 3.0x and 3.5x and 1 assets (4.4% of total balance) with NCF DSCR between 5.5x and 6.0x. 



DSCRs ranged from 1.0x to 6.0x.There are 8 assets (14.8% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (39.5% of total balance) with DSCR between 1.5x and 2.0x, 10 assets (25.6% of total balance) with DSCR between 2.0x and 2.5x, 3 assets (11.2% of total balance) with DSCR between 2.5x and 3.0x, 2 assets (3.8% of total balance) with DSCR between 3.0x and 3.5x, 1 assets (0.7% of total balance) with DSCR between 4.0x and 4.5x and 1 assets (4.4% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.2x.

EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
