Transaction Summary

The transaction closed on Sep 28 2017 and matures in Sep 2027. The pool's current aggregate principal balance is \$858.5 million compared to \$879.1 million at close.

The largest loan of the pool (8.3%) is secured by 101 Ludlow located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The major tenants included Chelgram Holdings (99.50%) and Cloud 9 Convenience LLC (0.50%). The second largest loan of the pool (6.7%) is secured by AHIP Northeast Portfolio II located in Camden, NJ-28.27% metropolitan area. Occupancy at the subject was 68%. The third largest loan of the pool (6.1%) is secured by CHG Building located in metropolitan area. Occupancy at the subject was 100%. The largest tenant was CHG Healthcare Services Inc. (100.00%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.61% and 58 months as of 03/10/2022, respectively. There are a total of 41 loans and 52 properties in the portfolio. The appraisal LTV was approximately 58.7% compared to the Original loan to value (LTV), which was approximately 59.7%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.46x. As of 03/10/2022, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 79%.



Type Concentration











DSCRs ranged from -2.0x to 6.0x.There are 1 assets (0.8% of total balance) with DSCR between -2.0x and -1.5x, 2 assets (6.8% of total balance) with DSCR between -0.5x and 0.0x, 2 assets (7.0% of total balance) with DSCR between 0.0x and 0.5x, 1 assets (0.9% of total balance) with DSCR between 0.5x and 1.0x, 9 assets (19.8% of total balance) with DSCR between 1.0x and 1.5x, 17 assets (41.5% of total balance) with DSCR between 1.5x and 2.0x, 6 assets (15.8% of total balance) with DSCR between 2.0x and 2.5x, 1 assets (0.7% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (2.0% of total balance) with DSCR between 3.0x and 3.5x and 1 assets (4.7% of total balance) with DSCR between 5.5x and 6.0x. EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.

2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.

3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.

4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.

1). Past data reflects the performance and credit worthiness of the pooled assets and is useful for analysis.

2). Financial and credit information that EJR gets from the issuer or the third party is reliable and accurate.

3). The economy and regulation policies will remain stable in the foreseeable future.

Specific quantitative assumptions used in this credit analysis applied to the collateral assets, which include Loan-to-Value analysis and Cash flow analysis.

Asset diversification is not considered in this report.
