## **Transaction Summary**

The transaction closed on May 22 2018 and matures in Apr 2030. The pool's current aggregate principal balance is \$1001.7 million compared to \$1006.5 million at close.

The largest loan of the pool (10.0%) is secured by 930 Flushing located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was New York City Emergency Management (100.00%). The second largest loan of the pool (7.8%) is secured by Hyatt @ Olive 8 located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 85%. The third largest loan of the pool (6.5%) is secured by Kingswood Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included Visiting Nurse Service of NY (45.25%) and TJ Companies Inc (20.65%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.58% and 33 months as of 10/10/2020, respectively. There are a total of 41 loans and 44 properties in the portfolio. The appraisal LTV was approximately 56.6% compared to the Original loan to value (LTV), which was approximately 56.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.89x. As of 10/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.





#### Occupancy Distribution (%)




#### Local Distribution




#### NOI Debt Yield (%)



Most recent net operating income debt yield ranged from 6% to 27% with a weighted average NOI debt yield of 9.5%. NOI debt yield ranged from 6% to 27%. There were 11 assets (32% of total balance) with NOI debt yield between 6% and 8%, 12 assets (19% of total balance) with NOI debt yield between 8% and 10%, 10 assets (32% of total balance) with NOI debt yield between 10% and 12%, 7 assets (17% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 26% and 28%

All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 5.0x. There were 13 assets (29.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 18 assets (40.3% of total balance) with NCF DSCR between 1.5x and 2.0x, 6 assets (18.2% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (5.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (6.4% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (1.0% of total balance) with NCF DSCR between 4.5x and 5.0x. The most recent weighted average NCF DSCR was 1.9x.







DSCRs ranged from 1.0x to 6.0x.There are 9 assets (24.8% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (31.7% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (27.9% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (8.2% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.0% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.0x.

There are 2 assets (12.8% of total balance) that have maturity dates between 2027/1 and 2027/6, 9 assets (18.9% of total balance) that have maturity dates between 2027/7 and 2027/12, 29 assets (61.8% of total balance) that have maturity dates between 2028/1 and 2028/6 and 1 assets (6.4% of total balance) that have maturity dates between 2030/1 and 2030/6.

## EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
