# **Transaction Summary**

The transaction closed on May 22 2018 and matures in Apr 2030. The pool's current aggregate principal balance is \$1001.3 million compared to \$1006.5 million at close.

The largest loan of the pool (10.0%) is secured by 930 Flushing located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 100%. The largest tenant was New York City Emergency Management (100.00%). The second largest loan of the pool (7.8%) is secured by Hyatt @ Olive 8 located in Seattle-Bellevue-Everett, WA metropolitan area. Occupancy at the subject was 85%. The third largest loan of the pool (6.5%) is secured by Kingswood Center located in New York-Jersey City-White Plains, NY-NJ metropolitan area. Occupancy at the subject was 99%. The major tenants included Visiting Nurse Service of NY (45.25%) and TJ Companies Inc (20.65%).

The weighted average coupon (WAC) and the weighted average age (WALA) were 4.58% and 35 months as of 12/10/2020, respectively. There are a total of 41 loans and 44 properties in the portfolio. The appraisal LTV was approximately 56.5% compared to the Original loan to value (LTV), which was approximately 56.9%. The most recent weighted average Debt Service Coverage Ratio (DSCR) was 1.89x. As of 12/10/2020, no loan had a remaining term of less than 6 months. Weighted average occupancy was approximately 94%.





## Occupancy Distribution (%)




#### Local Distribution





Most recent net operating income debt yield ranged from 6% to 27% with a weighted average NOI debt yield of 9.5%. NOI debt yield ranged from 6% to 27%. There were 11 assets (32% of total balance) with NOI debt yield between 6% and 8%, 12 assets (19% of total balance) with NOI debt yield between 8% and 10%, 9 assets (31% of total balance) with NOI debt yield between 12%, 8 assets (17% of total balance) with NOI debt yield between 12% and 14%, 1 assets (1% of total balance) with NOI debt yield between 26% and 28%

## NCF DSCR



All assets in the portfolio had net cash flow debt service coverage ratios (NCF DSCR) higher than 1x. NCF DSCR ranged from 1.0x to 5.0x. There were 13 assets (29.0% of total balance) with NCF DSCR between 1.0x and 1.5x, 17 assets (39.4% of total balance) with NCF DSCR between 1.5x and 2.0x, 7 assets (19.1% of total balance) with NCF DSCR between 2.0x and 2.5x, 2 assets (5.1% of total balance) with NCF DSCR between 2.5x and 3.0x, 1 assets (6.4% of total balance) with NCF DSCR between 3.5x and 4.0x and 1 assets (1.0% of total balance) with NCF DSCR between 4.5x and 5.0x. The most recent weighted average NCF DSCR was 1.9x.







DSCRs ranged from 1.0x to 6.0x.There are 9 assets (24.8% of total balance) with DSCR between 1.0x and 1.5x, 18 assets (31.7% of total balance) with DSCR between 1.5x and 2.0x, 7 assets (27.9% of total balance) with DSCR between 2.0x and 2.5x, 5 assets (8.2% of total balance) with DSCR between 2.5x and 3.0x, 1 assets (6.4% of total balance) with DSCR between 3.5x and 4.0x and 1 assets (1.0% of total balance) with DSCR between 5.5x and 6.0x. The most recent weighted average DSCR is 2.0x.

There are 2 assets (12.8% of total balance) that have maturity dates between 2027/1 and 2027/6, 9 assets (18.9% of total balance) that have maturity dates between 2027/7 and 2027/12, 29 assets (61.9% of total balance) that have maturity dates between 2028/1 and 2028/6 and 1 assets (6.4% of total balance) that have maturity dates between 2030/1 and 2030/6.

# EJR's Key Rating Features & Differences Compared With Other NRSROs

Below is a summary of EJR's approach (see our Methodology for rating Commerial Mortgage Backed Securities (CMBS) (Non-NRSRO) for more complete description):

- 1. Our ratings are derived from Loan to Value estimates (LTVs) and calculated Estimated Losses (ELs). The ELs are then compared to our EL matrices to derive the implied ratings.
- 2. To reflect the current bearish credit conditions, we have discounted reported pool assets' Net Cashflow (NCF) by 20% for the Base Case.
- 3. EJR's analysis is conducted using information and cash flow engines supplied by a recognized industry service provider.
- 4. Subject to economic conditions, EJR may cap its highest rating at "AA" and apply an additional downgrade of up to two notches for each tranche.
